On May 4, 2022, the Mason Consolidated Schools Board of Education held a regular meeting in the Mason Senior High School Library. President Stieben called the meeting to order at 6:06 p.m.

The next regularly scheduled Mason Consolidated Schools Board of Education Meeting will be held, Wednesday, June 1, 2022, at 6:00 p.m. in the Mason Senior High School Library.

Recommendation to approve Mason Senior High School Course- "Freshman Focus" -Principal Bates shared the request to approve a new Tier II level of support course for identified incoming freshmen. The course will provide academic, social/emotional and behavioral supports for 15-20 identified students. These students will work directly with 2-3 staff members during this one period course over the year.

Recommendation to approve 6-year subscription of Algebra, Geometry, and Algebra 2 materials

-Superintendent Tuller and Principal Bates shared the work the high school math department completed to identify mission, vision, and beliefs for mathematics at MSHS. The team developed their "portrait of a math student" and determined necessary resources for mathematics. Kathy Berry, MCSID Math Consultant, shared the process the

team went through, and the outcomes expected. The resources recommended for approval align to the these expectations.

-Jackie Cousino, resident, asked the Board when the community can expect a timeline for all of the items mentioned in the Strategic Plan and where the money would come from for the items listed in the plan. Superintendent Tuller shared that a copy of the approved Strategic Plan of Mission, Vision, Beliefs and Goals, along with first year strategies will be posted once the final corrections have been completed. She indicated that Administration and the Board of Education will determine funding sources when it is necessary to fund projects outlined in the Strategic Plan.

Student Discipline Resolution
