2020 Capital Project Update

-Mr. Shaw reported that all materials have been sent to the county and met the requirements for the March 10, 2020 election. SSOE is excited to get started with us. They would like to create a high scale of where we are at and they would like to meet with the Board, students, staff and the community to talk about what we want to see inside and outside and get a good feel for what they need to put together for the presentations. On Thursday, met with Atwell, who is doing the investigation on the wastewater treatment plant. It was a very informative meeting and Dave Hileman was a great resource to have there. We will be able to look at reducing the plant. We should have options to look at in late January to early February to be able to create a plan for this. We can look into grants and other options to not penalize the taxpayers if we should run city sewer up to here. Another community meeting was held on Thursday to discuss the plan. There have been approximately 75-80 people total who have attended the meetings so far. Working with our technology director on funding from eRate and Consumers to help with technology wiring and connectivity for the project. There is also a solar panel field project going in south of here that may create some opportunities as well.
