Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2024-25 educational progress for Mason Central Elementary School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2025-26 school year, schools were identified based on previous years' performance using definitions and labels as required in The Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2024-25. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-2022. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67%, failed to exit CSI status in 2024-25, or failed to exit ATS status in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

### **Mason Central Elementary HAS NOT BEEN GIVEN ANY OF THESE LABELS.**

Mason Central Elementary School continues to perform higher than state average in all tested subjects. Our staff is engaged in the PLC (Professional Learning Communities) process. This involves utilizing common assessments and adjusting instruction to ensure success for all students. We offer additional instructional support to students both during school and the 4 week summer school program.

State law requires that we also report additional information.

**1. *Process for assigning pupils to the school:*** Students are assigned to Mason Central Elementary School based on academic promotion as an eligible student at Mason Consolidated Schools.

**2. *The status of the 3-5 year school improvement plan:*** Mason Central Elementary School is a school-wide Title I school. The School Improvement Plan continues to be

modified to meet the curricular demands for our district. Based on our student achievement data, the need to align our curriculum district wide has become the biggest priority. Through the district strategic planning committee, we have identified a series of needs to support our student achievement goals. Over the next year, these needs will be supported with the appropriate professional development to ensure our staff create an effective and transparent curriculum for the four core academic areas K-12 grades.
