Superintendent's Report

Celebrations –A shout out to our kiddos and staff as we wrapped up the first part of our school year. The hard work, new programs, and new activities were the highlights of our first semester, and we are excited about semester two. It is hard to believe we are already halfway finished with our year.

Update: The HS Media Club will not be attending the Journalism Conference in April due to the unrest in Minneapolis at this time.

Operations: Trane Technologies is nearly finished with the review of areas that the District will consider for updates using a non-voted guaranteed energy performance bond. The greatest focus will be on heating, controls, and lighting. TRANE shared that they plan to release information to us mid-March, an RFP to be posted in April and an anticipated approval in May.

Academics and Programs: The CHOICE program was developed due to the DARE program not being available to the district this year. Our district knew how important it was to our students and staff to have a program for our fifth grade students. At the beginning of the year, Officer Rollins consulted with the principal, staff, and counselors of the elementary school to design a program for our district. Together they came up with topics they thought were important to instruct our young students. This was how CHOICE was born. CHOICE is an

acronym which stands for Creating Habits Of Integrity, Character, and Excellence.
