New Business

Recommendation of Executive Search by MASB

-Mr. Shaw presented Mason Consolidated Schools used MASB for their last Executive Search and it is recommended to use them again at a cost of \$5,600. MASB has a new grant program where if the grant is approved, they will cover \$1,500 of the cost. We will apply for the grant.

Recommendation of Technology Purchase

-Per the plan for the start of Mason's 1-to-1 initiative as presented during Mason's 4/20/20 Board Meeting and in a conjunctional response to the recent required blended, dynamic learning environment presented to our education system it is recommended to purchase 325 Dell 3100 Chromebooks along with licenses, warranty, insurance and extra AC adaptor at cost of \$104,000 from Presidio. The two other bids were \$133,562 from Zones and \$131,433.25 from CDWG. The 325 Dell 3100 Chromebooks will be paid from the Technology Fund.

Presentation of 2020 High School Graduation

-Mr. Bates and Mr. Shaw presented two options for graduation. One would be a car parade in the school parking lot and another on the football filed while practicing social distancing. The senior class will be surveyed on what they would like. Graduation can only happen after the stay home order is lifted. The football field option is designed to practice social distancing. Both options will be live streamed.

2020 – 2021 Budget Numbers Update

-Mr. Shaw presented to the Board options to reduce expenditures. Two of the items require the administration to negotiate with the employees. Other options focused on reducing expenses by line item and also possibly reducing the liaison officers time.
