Recommendation to approve overnight conference for Kelly Trainor, MIAAA Athletic Administrators Annual Conference, March 14-18, 2019, Traverse City, MI

-Mrs. McGarry presented Ms. Trainor is requesting to attend the MIAAA Athletic Administrators Annual Conference in Traverse City, MI. The approximate cost is \$1,164.48 paid by general fund.

#### Voluntary Severance Plan

-Mr. Shaw presented details of a plan to offer to teachers to reduce staff as a cost savings for the district to avoid tapping into the district's fund balance. This calls for a minimum of five teachers and a maximum of ten with at least fifteen years of service or more to accept this plan. We are budgeting a 40 student loss for next year. Three teachers will be replaced. We need to reduce costs between \$300,00 to \$400,00.

Recommendation of Sports Complex Electrical Work by Laibe Electric

-Mr. Shaw presented Laibe Electric completed the work when we had our power outage in the fall. They investigated the problem and found a short in the line near the baseball fence that goes to the main power supply for the athletic complex. The work consists of trenching and conduit work at a cost not to exceed \$5,735.60. Add primary cable and Sectionalizer junction box at a cost not to exceed \$7,205.40. Final step of adding new transformer Fusing and Energization at a cost not to exceed \$5,819.00. Total cost of the project not to exceed \$18,760 to be paid from sinking fund. Mr. Shaw will gather two more quotes for this work and bring back to the Board in February.

-Mr. Shaw shared with the Board of Education the results from the surveys. There was very good feedback provided and he will be using consistent points as growth areas for him.

Pictures were shown of the heat pipes that had problems at the elementary school. They had years of accumulated gunk and mud that had to be cleaned out. There are also leaks. Air gaps were preventing the heat from going through and caused the pipes to freeze up. This is something that will have to be looked at for the future for how to clean this out. Twelve steam leaks have been fixed at the high school and the maintenance team will continue to work through checking the pipes.

The pool controller is supposed to be in on Friday and can be installed. The pool is cloudy because the chlorine is low. Otherwise it is in good shape.

The School Improvement meeting has been moved to May so it will not conflict with final exams.
