Recommendation of overnight conference for Beth Sherman and Lynn Ferguson, MPAAA (Michigan Pupil Accounting and Attendance Association) Boot Camp, July 22nd – July 24th, 2019 Lansing, MI

-Mr. Shaw recommended that Beth Sherman and Lynn Ferguson attend the MPAAA Boot Camp from July 22nd to July 24th in Lansing at an approximate cost of \$955.54 paid from general fund. This Boot Camp replaces the Annual MPAAA conference that was approved last month.

2019 MCISD Board of Education Election Resolution

The Board of Education is to adopt the resolution for Mrs. Larrow to vote for these two candidates at the June 3, 2019 ISD Board Election meeting.

Recommendation of Schools of Choice 105 Opt-Out Resolution

-Mr. Shaw presented Monroe County has a school of choice program for the county and because of this program we opt-out of Section 105 and participate in the Monroe County School of Choice Program.

Recommendation of Schools of Choice Selection 105c Opt-In Resolution

-Mr. Shaw presented Mason Consolidated Schools will opt-in to receive school of choice students per section 105c. This will allow Mason Consolidated to accept students from contiguous ISD's to Monroe County.

Recommendation of paying hourly staff for three days due to the State of Emergency -Mr. Shaw presented it is recommended to pay the hourly staff for the three days that Mason Consolidated Schools was closed due to the State of Emergency. The groups impacted are the bus drivers, food service employees and Para pros. All other hourly employees (secretaries and finance office) were already paid because they were directed to not report to work due to the weather and when that happens, they are paid. These monies were budgeted and the cost of paying out these three days is \$11,474.
