Reconfirmation Meeting for February 3, 2021

Reconfirm instructional delivery method:

Presently, all K-12 students attend 5 days per week for a reduced in-person day, while finishing the instructional day remotely at home 5 days per week. Families continue to have the opportunity to select a fully remote option for their child.

Reconfirm how instruction will be delivered for each grade level:

Elementary (Grades K - 5): See above

Middle School (Grades 6 - 8): See above

High School (Grades 9 - 12): See above

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

Mason Consolidated School continues to provide the highest levels of instruction for all learners including ELL, special education, and at-risk populations through identified programming and services from within students IEPs, 504s, intervention plans, or student intervention team meetings. Staff is using benchmark assessments and progress monitoring to develop instructional supports to address learning gaps and assisting students on an individual basis.
