- Substance Use Screening and Intervention: annual substance abuse screening for all patients, including medical. If needed, medical providers will refer to behavioral health providers for full assessment. Determination is made for level of care, and Family Medical Center provides services for mild to moderate cases and refers out for more intensive services.
- Behavioral health services include individual therapy, group therapy, screening and diagnostic services for depression, anxiety, PTSD, Bipolar Disorder, ADHD, etc.
- Many insurances are accepted, including sliding scale fee for the uninsured. It is recommended to call the location from which you will be seeking services to determine whether they accept your insurance.

- There are 4 homes in Monroe with 42 beds.
- Transitional housing for homeless men who are struggling with a substance abuse disorder. This housing provides accountability, structure, outpatient programming, and job opportunities.
- The first 60 days are funded by Community Mental Health Partnership of Southeast Michigan. In this 60 days, men are assigned to a peer recovery coach to work towards self-sustainment. Clients receive assistance in applying for insurance and obtaining food and clothing. The expectation is \$420 per month in self-pay after the first 60 days.

- Faith-based, works with court system and probation officers, testing such as physical, TB, HIV, Hepatitis B & C, STD, and pregnancy.
- \$700 one-time fee, and Monroe County residents have the opportunity to apply for this fee through *Ryan's Hope Foundation*.
