## WCPS TUITION PAYMENT SCHEDULE 2025-26 New Families

• \*If your child is entering the Pre-K 4s program an additional \$100 has been added to your tuition, to cover field trips.

• \*If your child is entering the Pre-K 5s program an additional \$125 has been added to your tuition, to cover field trips.

In addition to the tuition installment payments described above, parents must agree to follow all school policies listed in the Parent Handbook. These policies include\_- all students must be vaccinated according to the State of TN Health Department guidelines. WCPS does not accept delayed vaccination schedules, vaccination exemptions, or Religious Exemptions.

## The Deposit payment is non-refundable and non-transferrable. WCPS will not refund any part of the Deposit payment under any circumstances.

All families are required to set up an automated payment account through Tuition Express. Please return the enclosed Tuition Express form with your signed contract. Email reminders will be sent 1 week prior to Tuition Express withdrawal. If changes need to be made to the current payment method, please contact Sheila Mathias at smathias@woodmont.org.

If a child must leave WCPS during the school year, the Director of WCPS must be notified in writing as soon as possible. The withdrawing child's family will not be liable for further tuition installments so long as:

(1) notification of the child's withdrawal is received at least 30 days prior to the next tuition installment payment due date<u>and</u>
(2) WCPS is able to fill the child's vacancy within 2 weeks of receipt of notification of the child's withdrawal from WCPS. This tuition policy is applicable in all circumstances. In the event a child's vacancy is not filled within 2 weeks of receipt of notification of the child's withdrawal from WCPS, the child's family will be responsible for the payment of all remaining tuition installments.

Children enrolled after the beginning of the school year will be charged tuition & fees based on the number of weeks remaining in the school year.

All payment refunds will be less a \$100 administration fee.

Tuition assistance is available (you <u>MUST</u> check off the box for tuition assistance on the Registration Form). All assistance is confidential.
