- Hot pour-able beverages. *ie. drip coffee, powdered hot chocolate – NO milks or creamers; steaming or blending*
- Dry shelf stable foods, portioned on-site. *ie dry pasta, beans, spices, coffee, tea - NOT combined ingredients like soup mixes*
- COTTAGE Food items or Eggs. **Food training certificate, list if items, sample of labels with all requirements, disclaimer.**
- Young Entrepreneur: Child run low-risk food sales *ie. Packaged at home baked goods. Food handler training & labeling advised*
- Offering samples for tasting. Must protect from vendor & customer hand contamination. *Solids <=1oz, liquids <=2 oz*
- *Ranch meats: processed/packaged in USDA facility, held in a *powered* cold holding unit. **Require Limited Temp License \$**
- *Kettle corn, fried potatoes, funnel cakes, donuts, waffles, etc made on-site. **Require Limited Temp License \$**
- *Commercial ice cream/frozen novelties, prepackaged, scooped or soft-serve. **Require Limited Temp License \$**
- *Food preparation &/or service of any unpackaged food not described above. **Require Full-service Temp License \$**

***The above 4* selections MUST apply for a temporary food license. Apply with Teller County Public Health**
