- Manufactured food packaged & labeled for resale. (Submit copy of label with license &/or packing information)
- Young Entrepreneur: Child run low-risk food sales (ie. baked goods) (Menu, child's age, recommend food training & labels)
- *Ranch meats: processed/packaged in USDA facility, held in a *powered* cold holding unit. (Require Limited Temp License \$)
- *Kettle corn, fried potatoes, funnel cakes, donuts, waffles, etc made on-site. (Require Limited Temp License \$)
- *Commercial ice cream/frozen novelties, prepackaged, scooped or soft-serve (Require Limited Temp License \$)
- *Food preparation &/or service of any unpackaged food not described above. (Require Full Service Temp License \$)
- The above 4* selections MUST apply for a temporary food license. Apply with TCPHE (Subject to license fees & approval.)
