

Jacqueline Avant, the wife of music executive Clarence Avant, was shot and killed at their residence during an apparent home invasion early Wednesday morning.

At approximately 2:23 a.m., the Beverly Hills Police Department (BHPD) re-

Police units arrived and discovered the victim, Jacqueline, with a gunshot wound. The suspects were no longer on the scene.

medics transported Jacqueline to a local hospital but she did not survive.

According to TMZ, Clarence Avant was home at the time of the incident but was not injured.

A BHPD press conference was held on Wednesday after the Weekly's deadline.

Clarence Avant is known as the "Godfather of Black music" and was recently admitted to the Hall of Fame. He was the chairman of Motown Records and is also the president of his music publishing companies, Avant Garde and Interior Music Publishing.

Their daughter, Nicole Avant, was Ambassador to the Bahamas in the Obama administration.

## **BHPD Make Several Arrests Following Recent Robberies**

On Nov. 22 at approximately 10:50 p.m., the Beverly Hills Police Department (BHPD) received two reports of armed street robberies in the area of Elm Drive and Charleville Blvd, and Rexford Drive and Charleville Blvd.

The suspects fled the scene inside a black SUV prior to officers arriving. The on scene investigation produced a license plate, description of the suspect vehicle and description of two suspects involved. The victims of these two crimes were not physically harmed.

BHPD detectives located the suspect's vehicle near West 54th Street and Figueroa in the City of Los Angeles and at approximately 1:35 a.m, BHPD detectives working in conjunction with LAPD patrol units, stopped the suspect's vehicle.

The investigation led to the arrest of the two occupants, Chynelle Tyla-Lee Rhyne, a 22-year-old female and Justice Rash-edmalike Gill, a 25-year-old male. They were both booked at the BHPD. A replica firearm was also recovered from inside the vehicle.

On Nov. 23, at approximately 4:19 PM, Beverly Hills Police units responded to a report of an armed street robbery on Beverly Blvd west of Doheny Drive. The suspects fled on foot prior to officers arriving on the scene, however; a containment was set up and the suspects were eventually located.

Three suspects were arrested and booked at the BHPD after further investigation. Two loaded handguns were also recovered from two of the three suspects that were arrested.

Lakeylia Lambert, a 27 year old female from Seaside, Calif. was charged with robbery and conspiracy; Isaiah Hudson, a 19 year old male from Marina, Calif. was charged with robbery, conspiracy, and carrying a concealed weapon; and a 16 year old juvenile male was also arrested.

The victims in this case were not physically harmed.

The BHPD does not believe these robberies are connected to any other criminal activity in Beverly Hills and the investigation into the Nov. 22 robberies is still ongoing.

## **Barricaded Motorist Found Deceased**

A motorist who was found unresponsive after a standoff with Beverly Hills Police Department (BHPD) police on Saturday was later pronounced deceased at the scene.

According to authorities, at approximately 6:08 pm, the BHPD received multiple calls of a van causing a traffic hazard in the area of Wilshire Blvd and Linden Drive. Upon arrival, police units located a van blocking the eastbound lanes of Wilshire at Linden.

BHPD officers attempted to communicate with the driver of the van at which time he drove off eastbound on Wilshire Blvd with police units following closely behind.

The man ran a red light at Wilshire and Rodeo and came to an abrupt stop within the intersection. The driver then exited the vehicle momentarily but quickly re-entered after seeing police units were behind him.

The driver then made clear attempts to secure himself inside the van by placing aluminum foil and other items on the windows. Officers made many attempts to communicate with the driver without success.

Beverly Hills SWAT arrived on scene and also made several failed attempts to communicate with the driver. After a long unsuccessful period to communicate with the driver, SWAT officers entered the vehicle and located an unresponsive male.

The male was treated by Beverly Hills Fire Department paramedics and was later declared deceased at the scene.

The Los Angeles County Coroner's office was notified and BHPD Detectives are conducting an investigation.

The cause of death and identity of the man was unknown as of press time.

## **Anti-Semitic Flyers Found on Front Yards**

The Beverly Hills Police Department (BHPD) is investigating a hate incident that likely occurred during the overnight hours on Nov. 27.

Around 6:00 a.m. on Nov. 28 the BHPD received a call from a resident who reported receiving a flyer containing hate speech on their front yard. Police surveyed the area and discovered that the flyers, enclosed in plastic bags containing rice for weight, were distributed to homes in several blocks in the northeast area of Beverly Hills.

The flyer, a single sheet of paper, contained propaganda style hate speech related to Jewish people and the pandemic.

Public Works personnel and police canvassed the area and collected the flyers. Police are continuing to investigate and attempt to identify the persons responsible for this incident.

## **Board Halts Approval for Modernization of Beverly High South Site**

At the Nov. 23 Board of Education meeting, the Board postponed the approval of an agreement with DLR Group for designing of the athletic facilities. The motion was put forward by Board President Rachelle Marcus and seconded by Board member Gabriel Halimi.

Board Vice President Mary Wells suggested postponing the approval of this item since the last update the board received regarding the construction program was focused on the shortfall in funding and they have yet to determine what is the best way to move forward with the construction program.

"I wouldn't want to impede the progress of the projects we already have in place that we know will be moving forward," Wells said.

Construction Manager Don Blake was not in attendance at the meeting to answer any questions from the Board.

"Seeing the shortness of funds that we are going to have, I have very serious doubts that we should start to think about moving on and I think we need to take a break and see what's going to happen. I would like to make sure we are finishing up what we started. El Rodeo, B3, B4, those must be completed, but I personally cannot vote for this," said Marcus.

Beverly High does not currently have a CIF regulation sized softball field, baseball field, a swimming pool, and track. Originally, the Measure BH funds were to include CIF regulation facilities.

## **Board Members Voice Transparency Issue**

At the Nov. 23 Board of Education meeting Board President Rachelle Marcus voiced her concerns over the lack of transparency regarding the private Construction Committee meetings.

Marcus said when she first became board president she asked if she could attend the Construction Committee meetings that were held privately but was rejected at that time to join that committee.

Subsequently, Marcus formed the Facilities and Construction Committee with agendas, minutes, and public access.

Marcus said that a couple of months ago she received an invitation to attend one of the private Construction Committee meetings that she was not able to attend previously.

Marcus attended that meeting but said she felt like a "hypocrite" because she was not originally allowed to attend and felt very uncomfortable being there.

She said she went to the next private meeting on Oct. 26 and was updated on the master plan. However, that same information was given to the board later in the day.

Marcus also went to the most recent meeting.

"As uncomfortable as I felt, I felt that I should report to the board what was discussed at that meeting," said Marcus.

Marcus said one of the things discussed during the meeting was about the lega-

cy wells, which according to the report would cost about \$30 million to vacate.

Other things discussed at the meeting included special ed relocation; a contract to work on the restoration of the medical site; a report on the completion of the water bottle stations in the locker rooms; and a request at Beverly Vista to transform the orchestra room into the counselor's office.

"I bring all this to you because all of these decisions will eventually come before the board, which it should. But I wanted you to be aware of what took place in that meeting," said Marcus.

Board Member Gabriel Halimi also weighed in on the lack of transparency.

"Just hearing the way you described not having transparency into such a major fundamental ongoing expenditure and process for the school district with hundreds of millions of dollars of community funds being spent, as the president of the board to not feel like you have that level of transparency, we got a problem. And I look forward to working with my board members and the administration to solve that. That needs to end, that should not be happening in our community," said Halimi.

## **Traffic and Parking Commission to Discuss Proposed Minimum Grid Bikeway Network**

At their Thursday meeting the Traffic and Parking Commission is expected to discuss a proposed minimum grid bikeway network, which if approved by City Council, would be installed as an interim first step to implementation of the long-term bikeways network identified in the Complete Streets Plan.

To assist with expediting installation of the bikeway network, in Sept. the commission developed a Bicycle Infrastructure Ad Hoc Committee.

At their monthly meetings, the Ad Hoc previews upcoming bikeway proposals scheduled for commission meetings and brainstorms ideas for outreach and engagement strategies, bikeway designs, and innovative installation methods.

One of the ideas generated from the Ad Hoc is accelerated implementation of a Class III Bike Boulevard network as a first step to installation of the long-term bikeways network. This implementation would provide a series of connected bicycle travel-ways in the short-term throughout the city that improve bicycle access to key destinations, while allowing the more time-intensive City Council approved outreach and implementation process for bike lanes to continue at the same time.

Class III Bike Boulevards are shared streets between bikers and drivers that highlight bicycle travel via "sharrow" pavement markings and signage. They function exactly the same way as other streets, but the pavement markings and signage help bicyclists navigate the Class III bikeway network, avoid streets that can be more challenging to ride on, and determine proper lane positioning outside of the "door zone".

Since there is no dedicated space for bi-

cyclists on Class III bikeways and to help minimize conflicts with drivers, they are most appropriate for lower streets with slower speeds and lower volume, according to the staff report.

City staff has identified a “minimum grid” network that could be completed within months, if approved. The term “minimum grid” refers to the concept of quickly implementing a basic bikeway network, while also continuing to pursue longer-range efforts to upgrade and expand cycling infrastructure.

The proposed minimum grid for the city includes streets that provide access to parks, schools, existing bikeways, future Metro stations, and key commercial corridors.

According to the staff report, the advantages of implementing Class III for the proposed minimum grid include: there are no impacts to vehicle travel lanes, turn lanes, or on-street parking; they can be installed at a low cost and quickly; markings and signage identifying the network provide guidance for cyclists to key destinations; and markings raise motorist awareness that bicyclists are allowed to ride on public streets and serve as a reminder to share the road.

Feedback received from the commission will be incorporated into the proposed network and brought to council for consideration.

Following City Council approval, public notices would be mailed to properties along the identified streets prior to installation by the Public Works Street Maintenance crews early next year.

Installation of the proposed quick build minimum grid network is estimated to cost approximately \$10,000-15,000.

## Traffic And Parking Commission To Discuss Proposed Bikeways On Charleville Boulevard And Gregory Way

At their Thursday meeting the Traffic and Parking Commission is expected to discuss proposed bikeways on Charleville Boulevard and Gregory Way.

Charleville Boulevard and Gregory Way are identified as proposed bikeways in the Complete Streets Plan and are included as high priority projects in the Complete Streets Action Plan.

Charleville Boulevard and Gregory Way are both residential streets with one travel lane in each direction and on-street parking on both sides of the street. Both streets are identified as potential Class IV Protected Bike Lanes on the Holistic Bikeways Network Map. This map is intended to serve as a long-range vision for bicycling.

The city hosted a virtual community meeting on Nov. 9 at 6:00 p.m. via Zoom as a first step to determining the type of bikeway to pursue for Charleville Boulevard and Gregory Way. The meeting was intended to be a “community conversation” about a range of possible design options.

Notices advising of the meeting were mailed to properties within 500 feet of

Charleville Boulevard and Gregory Way and over 50 residents attended the meeting.

Participants were offered several opportunities to provide their feedback, ideas, and concerns, including through two Zoom “polls”, through the “chat” function, and by raising their hands to provide verbal comments.

The first Zoom poll asked residents about their priorities for Charleville Boulevard and Gregory Way. Of the approximately 30 residents, 60% of attendees that participated in the poll, indicated that traffic calming and safety was their top priority for the two streets.

The second Zoom poll asked residents about their favorite and least favorite type of bikeway for Charleville Boulevard and Gregory Way.

Key takeaways from the Zoom polls and comments received include: desire for traffic calming, but lack of support for bikeways of any type; importance of maintaining parking availability; concern over potential traffic congestion issues; bike boulevards were voted as both the most and least favorite draft bikeway option; and confusion or distrust over the current status of the proposal.

There are four different types of bikeways identified in the zoom poll.

Bike Boulevards (Class III) offer separation between bicyclists and drivers and are typically only attractive to highly experienced and confident bicyclists. This also has no impact on vehicle travel lanes or parking.

One-way Buffered Bike Lane (Class II) + Bike Boulevard (Class III) are on-street bike lanes with a painted buffer between travel lane and bike lane. These are typically attractive to mid to highly experienced bicyclists and parking is removed on one side of each street.

One-way Protected Bike Lane (Class IV) + Bike Boulevard (Class III) are on-street bike lanes with a physical, vertical buffer between travel lane and bike lane. These are typically attractive to bicyclists of all ages and abilities and parking is removed on one side of each street.

Two-way Sidewalk-level Bike Lanes (Class I) are off-street bike paths that separate bicyclists and drivers through vertical elevation. These are typically attractive to bicyclists of all ages and abilities and parking is removed on one side of one street with no impact to the other street.

City staff does not believe that there is adequate community support for installing any bikeway design that would impact parking or travel lanes, based on the feedback received.

Staff will be proposing that Charleville Boulevard and Gregory Way be included as Class III bikeways in the proposed quick build “minimum grid” network.

If approved by the City Council, this would provide basic bikeways on these two streets while the community could consider upgraded bicycle infrastructure on these streets in the future.

Review Commission is expected to discuss a request for an R-1 Design Review Permit to allow the construction of a new two-story single-family residence located in the Central Area of the city, located at 713 North Beverly Drive.

The applicant has requested a review and approval for the new construction of a two-story single family residence with a habitable basement.

According to the staff report, the architectural style is identified by the applicant as “Modern Farmhouse” and was determined by city staff to require review by the commission.

The applicant has obtained approval from the Planning Division for the removal of one deceased Magnolia Tree in the front yard, and the relocation of three Canary Island Palm trees from the existing front yard, to the new front yard in between the proposed new main residence and the front property line.

The project proposal is seeking approval to demolish the existing two-story residence at the site and replace the structure with a new “Modernist-revival” style building.

“The design of the new residence harkens back to a post mid-century design aesthetic with framed two-story fully glazed gabled modules that form the general asymmetrical massing of the new building. Three cantilevered shading elements or awning features work to unite the building forms on the main, street-facing elevation, and intermittently form second-floor balcony areas,” according to the staff report.

The roofing is metal standing seam, and the face of the building is accented with cement-plaster, cementitious cladding with teak accents, and the recessed entry door is also fabricated in teak wood.

A contemporary fence in a black finish with vehicle and pedestrian gates in a vertical picket design will run along the front setback that will span across the proposed new driveway. The landscape plan incorporates a mix of drought tolerant plants

with certain existing trees that will be relocated.

The Commission is expected to provide feedback to the applicant on the final aesthetics of the residence and review any potential impacts to privacy for neighboring structures.

## Planning Commission Approves Hillside R-1 Permit on Lexington

At their Nov. 18 meeting the Planning Commission approved a Hillside R-1 Permit to allow more than 3,000 cubic yards of earth material to be exported; a Hillside R-1 Permit to exceed the maximum amount of combined landform alteration on a site; and a Hillside R-1 Permit to allow the construction of a new residence in excess of 14’ in height that would not substantially disrupt the view of the Los Angeles Area Basin at the property located at 1508 Lexington Road.

On Sept. 23 the commission held a public hearing to consider three Hillside R-1 Permits and a Tree Removal Permit associated with the development of a new single-family residence and site improvements at the property site.

The project involves construction of a new two-story single-family residence with an above-grade floor area of 7,788 square feet and a 6,989 square feet basement. The cumulative floor area of the new residence would be 12,877 square feet, which includes exemptions for up to 1,600 square feet of basement garage and up to 300 square feet for basement mechanical areas.

At the hearing, the commission reviewed the proposal and received public testimony regarding concerns expressed by neighboring property owners. Specifically, concerns were raised regarding potential impacts to disrupt the view of the Los Angeles Area Basin to neighboring properties.

City staff also expressed concerns regarding the removal of the existing cedar tree in the front yard and lack of a land-

scape buffer between the proposed base-ment driveway and the neighboring prop-erty to the east of the project site, at 1506 Lexington Road.

The project applicant revised the project to keep the existing cedar tree within the front yard area, and worked directly with the neighboring property owner to resolve potential view impacts by reducing the height of the structure.

### Rent Stabilization Commission to Discuss Habitability Standards

At their Wednesday meeting the Rent Stabilization Commission is expected to discuss possible amendments to the Rent Stabilization Ordinance (RSO) for both Chapter 5 and Chapter 6 of the Beverly Hills Municipal Code (BHMC) regarding habitability standards.

At their Nov. meeting the commission discussed a report on possible amend-ments to the RSO regarding proactive inspections; a mediation board to address habitability violations and associated rent reductions; and to restrict rent increases for properties with habitability violations.

The commission discussed the habit-ability-related issues presented and re-quested additional information to be pre-sented at their next meeting.

The Commission requested copies of the California Civil Code and Health and Safety Code that contain state habitability standards. These standards currently are enforced by the City's Code Enforcement Department and the City Prosecutor's Of-fice.

The commission requested information regarding Habitability cases. The com-mission will discuss a report that reflects fiscal year annual data for all complaints received by the RSO by category includ-ing habitability standards.

For the most recent fiscal year, from July 1, 2020 through June 2021, the RSO staff received 280 calls and processed 30 complaints regarding habitability.

According to the staff report, for Fiscal year 20-21 there were 30 habitability cas-es. Approximately 23% of the cases were closed with no violations and about 63% of the cases were resolved.

The commission requested cost re-quirements that may be associated with a proactive inspection program. On Dec. 18, 2018, the City Council was presented with an agenda report that included a fee study that would increase the annual Rent Stabilization Program fee from \$56.00 to \$197 per year per rental unit. The current Rent Stabilization Program fee per unit is \$59.00 per year.

Lastly, the commission discussed an ad-ministrative hearing process to hear habit-ability appeal cases and make determina-tions on habitability issues and associated rent reductions to compensate the tenant for a loss of housing services.

The commission is expected to discuss any modification to the RSO in regards to habitability standards and whether to establish Beverly Hills habitability stan-dards that go beyond the state standards, such as requiring units to be painted peri-odically; whether to establish a proactive inspection process in addition to the exist-

ing complaint-based process; whether to have the commission act as an administra-tive hearing board to determine habitabil-ity violations; and whether to restrict the annual rent increase for properties with ongoing or unaddressed habitability viola-tions during the time when there is a fail-ure to comply with habitability standards.

### Rent Stabilization Commission to Discuss Relocation Fees

At their Wednesday meeting the Rent Stabilization Commission is expected to discuss possible amendments to the Rent Stabilization Ordinance (RSO) for both Chapter 5 and Chapter 6 of the Beverly Hills Municipal Code (BHMC) regarding relocation fees to include a mom and pop reduction for owner occupancy.

The Beverly Hills RSO provides that an owner may evict a tenant for use and occupancy by the landlord or landlord's spouse, children, or parents provided that the landlord pays the tenant a relocation fee, among other things.

The following are the Beverly Hills 2021 relocation fees: for a studio the fee is \$6,988.87 and \$8,988.87 for a senior, disabled person or minor; for a one bed-room the fee is \$10,323.61 and \$12,323.61 for a senior, disabled person or minor; and for two and three bedrooms the fee is \$13,986.75 and \$15,986.75 for a senior, disabled person or minor.

According to the staff report, both the City of Los Angeles and Culver City's rent stabilization ordinances provide a reduc-tion in relocation fees for owner occupan-cy for mom and pop owners. Culver City established a 50% reduction making it the greatest reduction for relocation fees.

Culver City defines a "mom and pop" owner as someone who has no direct or indirect economic interest in more than 3 rental units located within or outside of Culver City. They also cannot include a real estate investment trust, a corporation, a limited liability company or partnership in which at least one member is, or is controlled by, a corporation.

The commission is expected to consid-er whether to modify the relocation fee for owner occupancy to add a "Mom and Pop" reduction; and if a "Mom and Pop" reduction is recommended, the commis-sion must define what constitutes a "Mom and Pop" landlord and the amount of re-duction.

### Artwork Protected During Burton Way Median Green Street and Water Efficient Landscape Project Construction

The Burton Way Median Green Street and Water Efficient Landscape Project construction on Burton Way between Rex-ford and Oakhurst Drive began in Sept. This project will develop the median into a stormwater retention site, and improve the landscape, transforming the median into a drought-tolerant garden. liam Kentridge, *Sisyphus* by Alexander Liberman and *Love Anatomy* by Alex-andra Nechita, and the sculpture across

from the median in Rexford Park, *Spiral of Life* by Baile Oakes, were fenced off and wrapped to protect the artwork when construction began.

Recently, these pieces have been un-wrapped although construction is not complete. While the fencing continues to protect these pieces, the city's art conser-vators will periodically wrap and unwrap these pieces during construction to pre-vent excessive condensation that might possibly harm the artwork.

While The Burton Way Median Green Street and Water Efficient Landscape Project will temporarily prevent the pub-lic from the full view of the sculptures, improvement to this site is intended to give the public an art sculpture garden in hopes of providing environmental sustain-ability for years to come.

### Next BH Discusses Time Capsule

At their Nov. 23 meeting the Next Bev-erly Hills Committee discussed a pro-posed 2020-2021 time capsule that would be filled with small memorabilia to re-

member the current time.

Each committee member will fill out a form where they will write about the cur-rent state of affairs as well as future pre-dictions, among other things.

Some ideas discussed to fill the time capsule include: a Next BH mask; resta-urant menus; some major newspaper head-lines; stock market information; a COVID rapid test; predictions where the commit-tee members will be in 20 years; and gen-eral predictions about the future, among other things.

The committee has not yet picked a date for the opening but discussed having it take place in about 15-20 years.

## VIOLINS OF HOPE

### Chair Susanne Reyto Helps Educate Audiences About The Holocaust Through Violins of Hope

After an 18-month delay, *Violins of Hope*, Los Angeles County presented their Opening Gala, featuring Delirium Musicum last night at Theatre Raymond Kabbaz. *Violins of Hope's* mission is to educate in a unique way. Their goal is to leave a lasting impact by informing the public about the Holocaust through culture and music.

Susanne Reyto is the Chair of *Violins of Hope*, Los Angeles County. She was born six days before the Nazi occupation of Hungary in March 1944. She is married, has one daughter and two grandchildren.

As a result of her personal experiences and speaking to many people after the publication of her first book, *Pursuit of Freedom*, she realized many people don't know much about the Holocaust, and made it her mission to educate and inform. When the *Violins of Hope* project was presented to her she realized this was the perfect solution.

"Teaching history through the stories of the violins and giving musical enrichment at the same time is a unique opportunity. I immediately connected with Avshi Weinstein, son of the founder, and the rest is history," Reyto said.

It started about four years ago and after the lockdowns in 2020, she continued with virtual programs to keep the excitement of *Violins of Hope* within the community.

"As a grateful survivor and a US citizen this project is my giving back to the community that I love. My goal is to em-

power young and old with tools to fight the bullies in the hopes of reducing hatred, bigotry and anti-Semitism," Reyto said.

#### Tell us about Violins of Hope.

Violins of Hope is a collection of mostly violins, but [also] violas and cellos instruments that were played during the Holocaust, both in ghettos and concentration camps. They have been collected and now restored to top-quality playing level by Amnon and Avshi Weinstein, the father and son luthiers in Tel Aviv.

After Amnon founded the project, *Violins of Hope*, it has traveled mostly throughout the United States and it is used as teaching opportunities and classical music concerts.

#### Tell us how the instruments were found.

Some of them were played by the survivors themselves. Some gave them, donated them, or some of them were even sold to the Weinstains in Tel Aviv. Many of the European musicians went to [what was] at that time Palestine, which then became Israel and many didn't want to play a German instrument. They wanted to get rid of them and they gave and sold and did all kinds of things to the Weinstains. After a while, he had so many [instruments], but people still wanted to give it to them.

Until the 1990's he wasn't emotionally and mentally able to handle them because he himself lost about 400 members of his family from Poland. So, in

the 1990's he gained enough emotional strength and they began to restore them, and some of them [took] a year to restore and rebuild. Now they have over 60 restored instruments that travel.

#### Tell us about some of the concerts Violins of Hope produces.

We take them to schools and we speak

to the youngsters and not only tell them the story about the Holocaust itself but the people who held them and played them. Some of them were in the major concentration camps. It either prolonged their life or saved their life because the Nazis loved music and these wonderful musicians played to entertain. And also, tragically when the transports arrived in Auschwitz many of the people who were not bound to live too long, were marched to the gas chambers right away and music accompanied them to make the evil seem deceitful. That's really what the aim was. That this really

wasn't a terrible place and half an hour later they were gone.

#### You escaped Communist Hungary in the late 1950s, tell us about that.

I am what you call a child survivor. I was born during the Holocaust, actually six days before the Nazi invasion of Hungary. My mother and I were hiding under terrible conditions, living in the cellar most of the time, we survived and my father did as well. When the Nazis left, for a few years there were good years, then followed that by communism.

In 1948 the communist came in and we were really persecuted. I was in prison as a five-year-old to punish us for my parent's desire to leave Hungary. When we got out of prison and my parents served for a year [we had] a few months of a fairly decent life, then we were taken to what you call a communist intern-

ment camp. It is like a concentration camp but less drastic for 29 months. I survived Nazism and really survived communism as well.

On the *Violins of Hope* website your bio says "Being a grateful child survivor, bringing *Violins of Hope* to the Los Angeles community is her way of giving back" can you elaborate on that?

I have always been a grateful survivor and a grateful American citizen. My parents always told me, whatever we can do for others that may be even worse off than we are, I learned philanthropy and how to help others [at a] very early age from

my mother. Even when we were in the communist internment camp my mother and I went to help those that were even less fortunate because we were together with some of the former royalty of Hungary and those people didn't even know how to boil water. So we often went and helped them. My mother showed me how it is to be helpful to others who are even less fortunate or less able to do for whatever reason.
