1. Information We Collect

- Personal Identification Information: Full name, age, rank, style, and other competition-related

details.

- Mailing Address: Your physical address so that we can distribute awards, medals, or certificates if

you place in the competition.

- Video Submissions: Videos you submit for competition judging, including your name card at the

start.

- Contact Information: Email address and other information you provide when registering or

communicating with us.

- Technical Data: IP address, device type, and usage data to ensure secure and proper functioning

of our platform.

2. How We Use Your Information

We use your information for the following purposes:

- To manage and administer the virtual competition.

- To verify your identity and eligibility.

- To evaluate your video submissions.

- To communicate with you regarding competition updates or issues.

- To distribute awards, certificates, or prizes to your provided mailing address.

- To maintain backup copies of videos for tie-breaking or verification.

- For marketing and promotional purposes, such as showcasing performances, highlights, or

promotional materials. No full names will be used in public-facing content; we may use your first name, rank, country, or division only in a way that does not fully identify you.

3. Confidentiality

- All submitted videos and personal information are treated as confidential and will be viewed only by authorized judges, event staff, or for official competition purposes.
- Videos may be featured in promotional or advertising content, highlight reels, or event recaps. When used for marketing, full names will not be displayed only partial identifiers such as first name, age group, country, or division may be used.
- We will never sell or lease your personal data, including your address, to third parties.

4. Data Sharing and Transfers

- We may share limited information with trusted service providers who help us operate our competitions (such as video hosting or judging platforms). These providers are contractually obligated to protect your data.
- Because this is a global event, your information may be transferred to and processed in countries outside of your country of residence, including the United States. We will take steps to ensure your data remains secure and protected.

5. EU Data Privacy Rights (GDPR)

If you are located in the European Union or European Economic Area, you have specific rights under the General Data Protection Regulation (GDPR):

- The right to access, correct, or delete your personal data.
- The right to object to processing or request restrictions.
- The right to data portability.
- The right to lodge a complaint with a data protection authority.
- The right to withdraw consent at any time (this may affect your ability to participate in the event).

We use industry-standard security measures to protect your information. However, no online transmission is completely secure. We cannot guarantee absolute security but will act swiftly in case of any data breach.

8. Children's Privacy

Participants under the age of 18 must have consent from a parent or legal guardian to participate and submit any personal data or videos.
