PROCEDURE: FSA03

TITLE: FSA All State Team Selection Criteria

EFFECTIVE DATE: September 12, 2015

REVISION DATE: April 22, 2015

PURPOSE:

To outline the procedures for annual selection of the Florida All State Team.

SELECTION PROCESS:

The secretary shall obtain member averages from NSSA and ascertain that they were compiled in bonafide competition (defined below). The President will appoint a committee to annually choose in February each year an Honorary All State Team composed of shooters who were residents of the state of Florida at the beginning of the shooting year.

SELECTION FORMAT:

The following team categories and selectee counts will be used to establish annual All State Teams:

Open Team	8 Minimum	12 Maximum
Ladies	4 Minimum	8 Maximum
Sub Junior	4 Minimum	8 Maximum
Junior	4 Minimum	8 Maximum
Collegiate	4 Minimum	8 Maximum
Triple Sub	4 Minimum	8 Maximum
Sub-Senior	4 Minimum	8 Maximum
Sub-Senior	4 Minimum	8 Maximum
Senior	4 Minimum	8 Maximum
Veterans	3 Minimum	6 Maximum
Senior Veteran	3 Minimum	6 Maximum
Super Veteran	3 Minimum	6 Maximum
Military	2 Minimum	4 Maximum
Retired Military	4 Minimum	6 Maximum
Military Veteran	4 Minimum	6 Maximum

SELECTION CRITERIA:

The selection criteria for All State Teams are as follows:

- 1. Minimum registered targets required for consideration
 - A. 12 Gauge 800 (Junior, Sub-Junior, Senior Veteran & Super Veteran 500)
 - B. 20 Gauge 600 (Junior, Sub-Junior, Senior Veteran & Super Veteran 400)
 - C. 28 Gauge 600 (Junior, Sub-Junior, Senior Veteran & Super Veteran 400)

- D. 410 Bore 600 (Junior & Sub-Junior, Senior Veteran & Super Veteran 400)
- 2. A registered bonafide competition will meet all the following criteria:
 - A. The shoot will be for a specific scheduled date.
 - B. The shoot must be "open" to members of FSA.
 - C. One (1) Closed Club "Members Only" Shoot per club will be allowed per skeet year.
 - D. The shoot must be advertised, i.e. Skeet Review, mailer, etc.
 - E. The shoot must have prior approval of the Executive Board of the Florida Skeet Association and all Clubs within that Zone.
 - F. A Financial Report must be filed with NSSA and FSA.
- 3. All members will have participated in the Florida State Championships held in April of each year, or if for some reason a shooter cannot attend the Florida State Championships, they can shoot the annual Hall of Fame shoot, but one half of the reuired state minimums have to be shot within the state of Florida..
- 4. Selection will be based on an individual's four gun High Overall Average consisting of only qualifying targets as defined below.
- 5. Members may only be selected for one team.
- 6. The selection order of teams will be as follows:
- Open, Ladies, Sub-Junior, Junior, Triple Sub, Sub Sub Senior, Sub Senior, Senior, Veteran, Senior Veteran, Super Veteran, Military, Retired Military, Military Veteran

QUALIFYING TARGETS:

Only targets shot in a registered bonafide completion will be included in an individual's minimum target count.

RECOGNITION:

Suitable mementos will be purchased by the Treasurer from the Association funds.
