Harber is clear choice

The official Democratic ballot for the primary election of June 30 lists three candidates for the one position as regent of the University of Colorado District 2.

Except for Aaron Harber, the two other candidates are both employees of the University of Colorado system. Both of these candidates have outright conflicts of interest too numerous to name and which must be avoided.

You cannot be both the employer as a regent of the University of Colorado and at the same time be the employee of the University as a professor in one of its colleges. The conflicts are clear and absolute.

In the half century that I have known Aaron, I have always found him to be a clear, analytical, rational and logical thinker, who quickly gets to the problem and its solution.
