# Brendan Rich - Working with Mineral pigments to make both Oil and Watercolor Paints

Brendan Rich will hold two 60 minute classes on Thursday June 20th & 27th from 10 to 11 am. The cost is \$60 per person for the two classes or one may choose to attend one class for \$30. There will be space for 6 people (8 if there is interest). Materials are included in the class price and some brushes will be provided. This is a materials exploration workshop discussing the techniques of making paint. We will work with Earths to make both oil and watercolor paints. We may explore additional binding mediums and, as time permits, we may explore Secco or Fresco painting. While materials are provided for these classes, please bring a smock or other covering, and a few brushes suitable for oil painting.

## Lesa Cook - "Low Relief Sculpture" Workshop

Two-day workshop with sculptor and painter, Lesa Cook, winner of many awards, instructor at the Delaplaine Art Center, Certified copyist at the National Gallery: students will create a low (bas) relief sculpture in waterbased clay using their own photographic sources from animal, human subject matter, a shallow relief that can be wall-mounted after firing. The workshop will be held on Thursday - Friday, June 6 - 7, 2024, from 10:30 am – 4:30 pm each day. Included in the workshop fee is the use of sculpture stands and tools loaned by the instructor. Lunch is also included. Cost is \$150 for VAA and Museum members, and \$165 for nonmembers. The clay will be provided by the instructor for a \$20 supply fee. Firing arrangements may be made with her during the workshop. Minimum is 6. The lunch break will be 30 minutes. The work will be supplemented with demonstration videos and other presentations by Lesa Cook.
