# Members in the NEWS continued

At the Board Meeting on Monday, January 6th, it was brought up that some of the sale items in the gallery are not adequately labeled.

The problem is not with the artists who sell paintings as their artwork has titles.

Members who sell anything except paintings should tag their items with a number or some type of description that matches the item identifier on their consignment sheet. For example, Donna Mason might tag & list her items as DM1, DM2, etc. One board member said she tagged her cards with a code corresponding to the date she put her cards on the shelf for sale.

Also, apparently not all members are listing their items on a consignment sheet. All items should be listed. I've revised the sheets - one sheet for paintings (hung on the wall) and one for everything else. The one for cards, etc. has a column for the i.d. I plan to put the sheets in the inventory binder to replace the current ones Copies are attached. If you see something that should be changed, please let me know. Thanks, Denise

# WASHINGTON COUNTY MUSEUM OF FINE ARTS PLANS 2026 CUMBERLAND VALLEY EXHIBITIONS AS PART OF AMERICA250 CELEBRATION

HAGERSTOWN, MD (January 3, 2025) – In honor of the semiquincentennial, or 250th anniversary of the U.S., the Washington County Museum of Fine Arts is planning its 2026 Cumberland Valley exhibitions around national themes. "A big part of our involvement in the national celebration will be our annual Cumberland Valley Artist show," WCFMA executive director Sarah J. Hall announced, "and we'd like artists to think about their subject matter now. Instead of our usual show, where artists submit any work of their choosing," she explained, "this exhibition will require submissions to be in line with four specific themes of national significance, some of which have been established by the American Association for State and Local History: Unfinished Revolutions, The Power of Place, Tell Everyone's Story, and American Experiment." Hall pointed out that while the formal call for submissions won't be until spring and summer of this year, "We want to make sure artists have enough time to think about, plan and execute works that illuminate or are made in response to the themes selected because of the power of their meaning to our country.

The Cumberland Valley Artist 250th U.S. anniversary exhibition will run from November 8, 2025 to March 1, 2026. The specific time period for submissions will be released at a later date, between May 1 and June 30, 2025. The Washington County Museum of Fine Arts, located on Hagerstown's historic City Park lakeside, was established in 1931 by William H. Singer, Jr. and Anna Brugh Singer and has an extensive, world-class permanent collection of paintings, drawings, prints, and sculptures from the 18th century to the present, featuring celebrated and diverse artists. The Museum offers tours, classes, educational programs and community events and is open 10 a.m. to 5 p.m. Tuesday through Sunday. Closed Mondays and major holidays. Admission is free and free parking is available. For more information: wcmfa.org.
