9. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).

11. To review, discuss and take action regarding District Insurance matters.
12. To review, discuss and take action regarding insurance matters related to HB471.
