

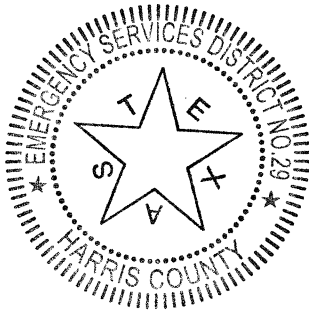
MEETING NOTICE

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To receive a report from Brad Dill of BD Realty and take action with respect to District real estate and station development matters.
4. To review, discuss and take action regarding matters related to the Station 12 property and Harris County Municipal Utility District No. 191.
5. To review, discuss and take action on reports and construction matters from District architect Ricardo Martinez of Martinez Architects for the Station 12 construction project.
6. To review, discuss and take action regarding proposals received to install access control, intercom systems and video surveillance equipment.
7. To review, discuss and take action regarding the proposal received from Affordable Drill Towers, LLC.
8. To review and take action of any pay applications submitted by JE Dunn and approved by Martinez Architects.
9. To approve the Minutes of prior meeting(s).
10. To receive a report from the District Bookkeeper, to review and take action on the Treasurer's Report.
11. To review, discuss and take action regarding the payment of monthly recurring invoices as well as matters related to timely payment issues.
12. To pay, authorize or ratify District bills and authorize fund transfers required for operations and capital expenses.
13. To receive, discuss and take action on the Fire Operations Report.

19. To discuss any new items that need to be on the agenda for the subsequent District meetings and to set the date for the next regularly scheduled meeting for September.

To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
21. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
22. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
23. Reconvene in Open Session.
24. To take action on matters discussed in closed session.
