

Notice of Public Hearing on Tax Increase

A tax rate of \$0.10 per \$100 valuation has been proposed by the governing body of **Harris County Emergency Services District No. 29**.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for **Harris County Emergency Services District No. 29** from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that **Harris County Emergency Services District No. 29** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Harris County Emergency Services District No. 29** exceeds the voter-approval rate for **Harris County Emergency Services District No. 29**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Harris County Emergency Services District No. 29**, the rate that will raise \$500,000, and the current debt rate for **Harris County Emergency Services District No. 29**.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Harris County Emergency Services District No. 29** is proposing to increase property taxes for the 2023 tax year.

The proposed tax rate is also greater than the voter-approval tax rate and the de minimis rate. If **Harris County Emergency Services District No. 29** adopts the proposed tax rate, **Harris County Emergency Services District No. 29** is required to hold an election so that the voters may accept or reject the proposed rate. If a majority of the voters reject the proposed tax rate, the tax rate of the **Harris County Emergency Services District No. 29** will be the voter-approval rate of the **Harris County Emergency Services District No. 29**.

A **PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2023 at 10:00 a.m.**, at Fire Station 11, 12730 Champion Forest Drive, Houston, TX 77066.

Harris County Emergency Services District No. 29 may take action on the proposed tax rate on August 22, 2023 at 10:00 a.m., following the hearing to be held.

The election will be on November 7, 2023. You may contact the Harris County Clerk's Office – Election Department for information about voting locations. The hours of voting on election day are 7:00 a.m. to 7:00 p.m.

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by **Harris County Emergency Services District No. 29** last year to the taxes proposed to be imposed on the average residence homestead by **Harris County Emergency Services District No. 29** this year.

| Total tax levy on all properties | \$3,716,733 | \$4,312,237 | Increase of \$595,504, or 16.02% |
