COUNT 1-MURDER IN THE FIRST DEGREE (F1)

On or about January 27, 2020, Letecia Stauch unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than herself, caused the death of Gannon Stauch; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 2-MURDER IN THE FIRST DEGREE (F1)

On or about January 27, 2020, Letecia Stauch unlawfully, feloniously, and knowingly caused the death of Gannon Stauch, a child who had not yet attained twelve years of age, and the defendant was in a position of trust with respect to the victim; in violation of section 18-3-102(1)(f), C.R.S.

COUNT 3-CHILD ABUSE RESULTING IN DEATH (F2)
