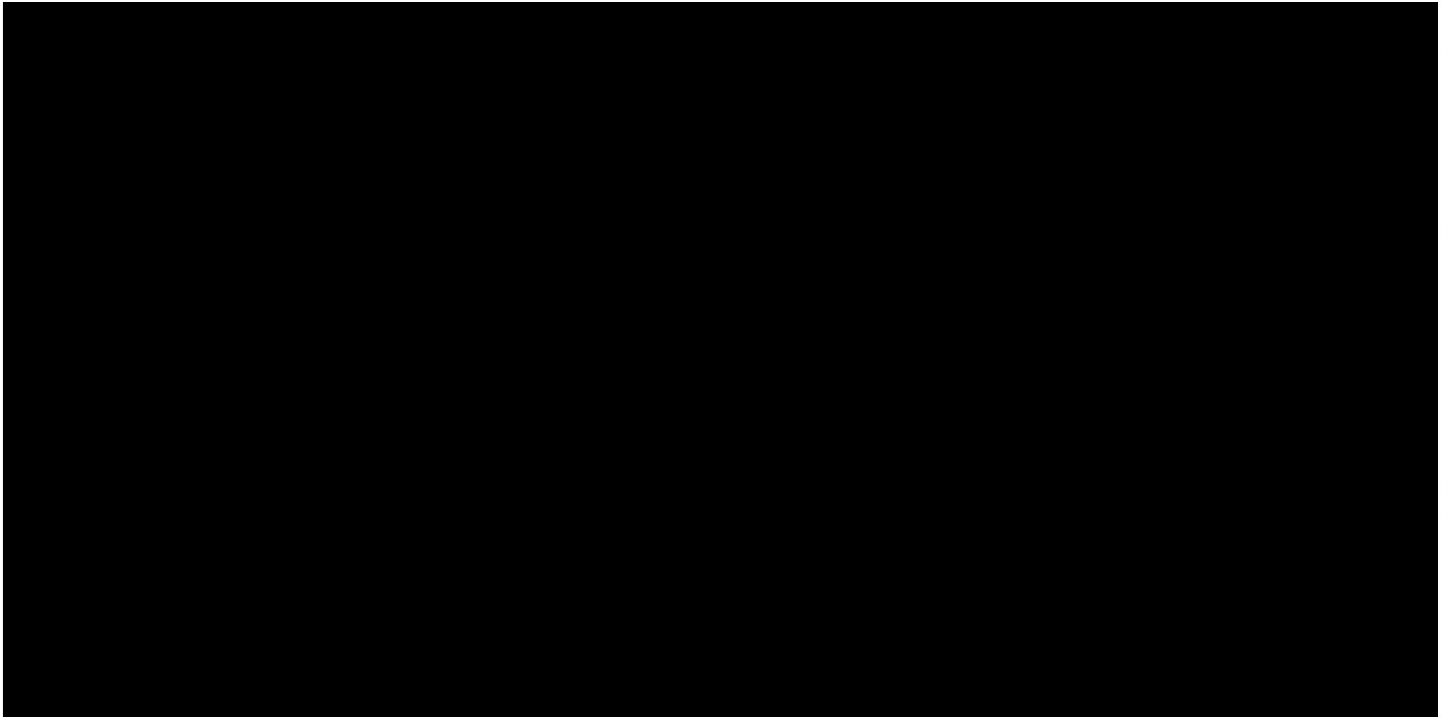

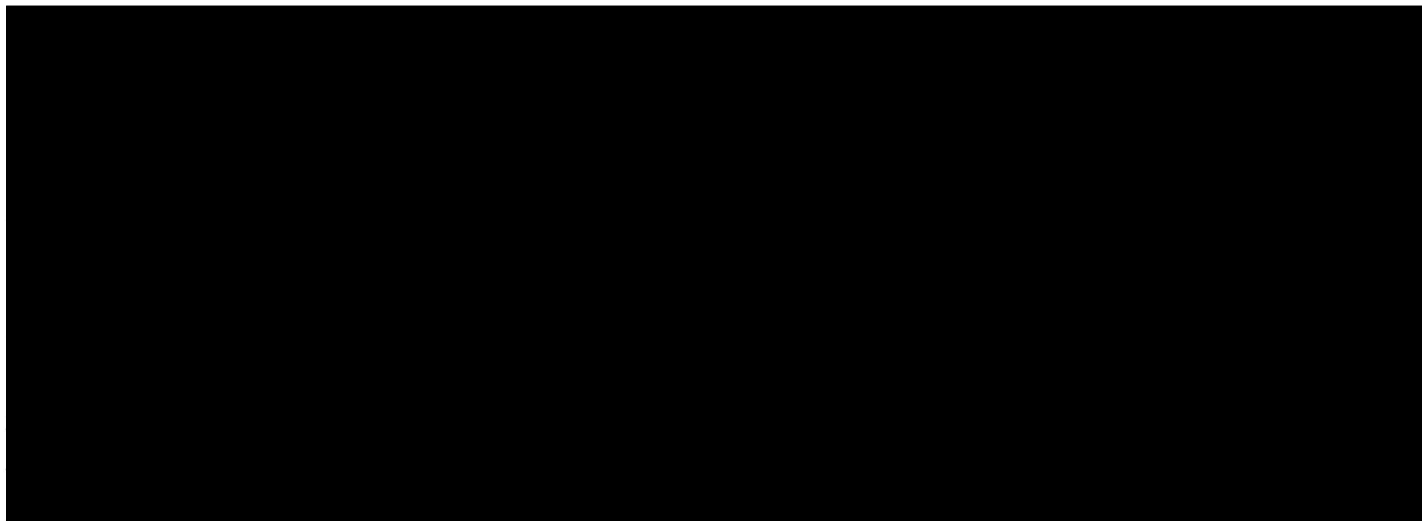

On June 15, 2023 at 1616 the Clermont County Communications Center dispatched several Sheriff's Office units to 1965 Laurel Lindale Rd for a report of an active shooter in progress. While on the way to the scene, we were getting updates that the shooter was on the front porch of the house shooting people. While still enroute, units on scene broadcasted via radio that they were able to take the suspect into custody without incident. I arrived on scene around 1630 hours with Deputy Deimling.

The scene was already very active with police and ems units. I observed Deputy Sparks standing by a young child (victim 1), by the front of the house, who was being treated by Monroe EMS. There was also a hysterical female kneeling by the child who identified as [REDACTED], the child's mother. I was later informed that [REDACTED] also suffered a gunshot wound to her hand. Deputy Sparks confirmed with me that the shooter, Chad Doerman, was in custody and was secured in Deputy Rudd's vehicle and that Deputy Rudd was with him. I asked where the other victims were and they pointed towards the front of the yard near the driveway and street. I saw one EMS member performing chest compressions on a small boy (victim 2) who appeared to be around three or four years old. I went over to help with medical care and the EMS member stopped CPR and said the child was deceased. After a closer look it was obvious he was deceased from a gunshot wound to the left side of his head. I covered the child with a sheet provided by EMS.

I was informed that a third child (victim 3) was in the back of the ambulance being treated for a gunshot wound. I was notified shortly after this that he died also.

The scene was taped off, roads were shut down by responding agencies and Deputy Deimling started a personnel log.

On 06/16/2023 around 1619 hours, I heard over the radio of a possible active shooter situation at 1965 Laurel Lindale Road in Monroe Township, Clermont County. Dispatch advised the Fire Department stated a male was actively shooting at the firehouse. While responding updates were provided of a male shooter who had shot 3 children which were laying in the yard. Further updates were provided that the male was still at the residence.

Upon my arrival at 1630 hours, the shooter had already been taken into custody. I grabbed a medical kit and ran up to the scene. I was advised by Sergeant Feilhauer that the juveniles in the yard are deceased. I was then requested to move up to Clermontville Laurel west of Laurel Lindale to block the road. I then began setting up crime scene tape to establish a perimeter for the scene. I was then requested to begin a canvass on Clermontville Laurel to locate any witnesses or video footage.



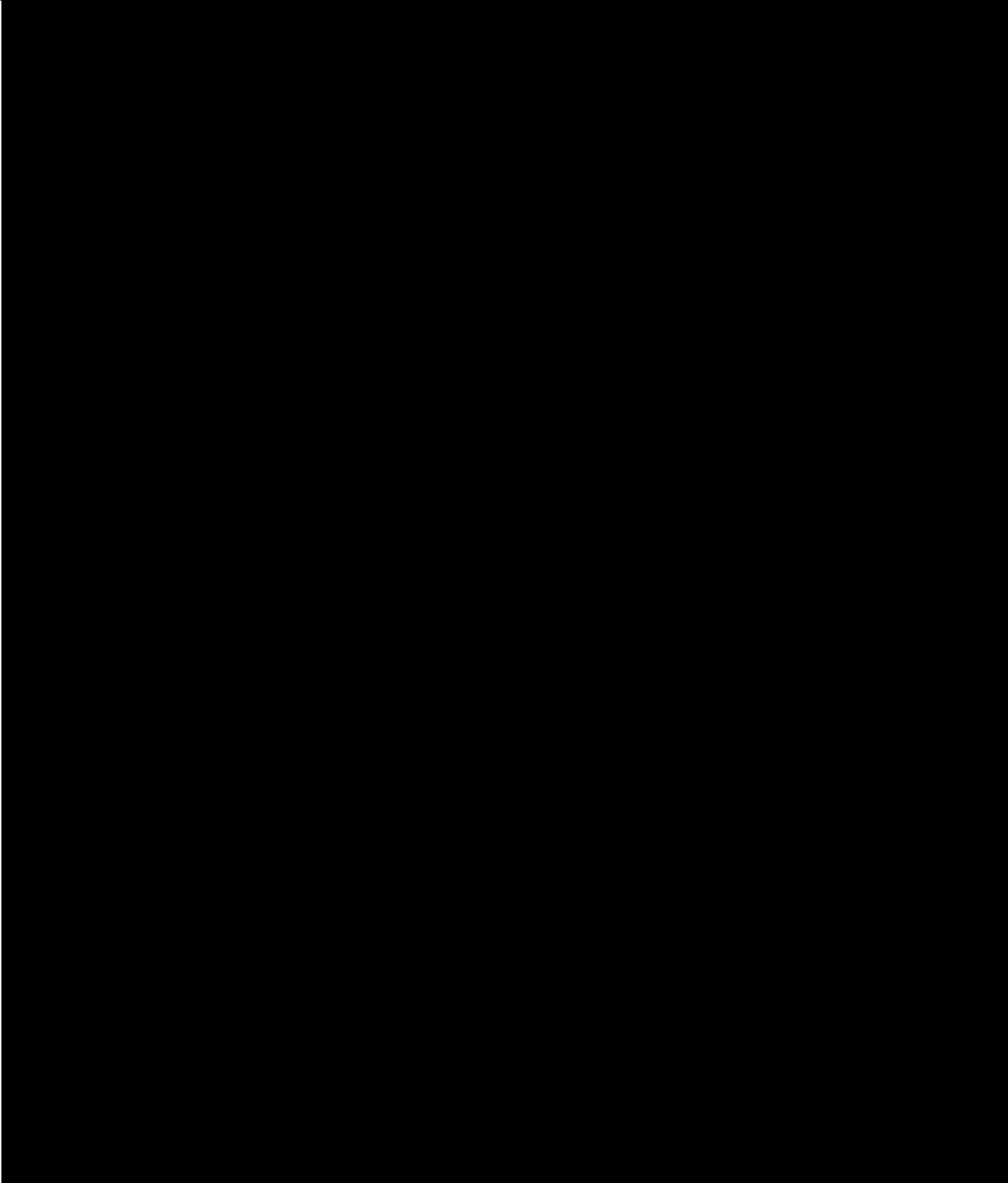

On 06-15-23 at 1627hrs. I arrived on scene at 1965 Laurel Lindale Road for an active shooter call. When I arrived I ran up to the driveway and observed Deputy Sparks performing CPR on a small child. I looked to my right and observed Deputy Popham had a male secured in handcuffs. I went to Deputy Popham and he advised me to take the suspect who was identified as one Chad Doerman and secure him in my cruiser. I escorted Mr. Doerman to my cruiser and as I was escorting him I noticed that Mr. Doerman had a large blood stain on his back right shoulder. I also noticed that Mr. Doerman had small blood stain on the back left shoulder. Also as I was escorting him to my cruiser he started to talk I advised Mr. Doerman to keep quiet and he was secured in the rear of my cruiser.

On 15 June 2023 at 1616 hrs. Deputies were dispatched to 1965 Laurel Lindale Rd. for reports of an active shooter. Calls to 911 were advising that a subject was shooting his family and that there were dead children in the yard. I responded from SR 276 and Mathis Rd. in Williamsburg Twp.

At 1639 hrs. I arrived on scene. There were already units on scene and two juvenile victims were in the yard deceased. The third victim was in an ambulance at the scene and the wife/mother, [REDACTED] was being treated for a gunshot wound in another squad and her oldest child was in there with her. I briefly spoke to Sgt. Feilhauer and we cleared the residence looking for additional victims. No one else was located and according to reports from the mother of the victims we were certain that her children had been accounted for and there was not anyone else needing medical care.

The scene was secured and we began blocking the roadway with vehicles and caution tape. We began a canvass of the area for witnesses and security cameras. Several witnesses were located and statements obtained. I just continued to manage the scene and relay information to the command staff.

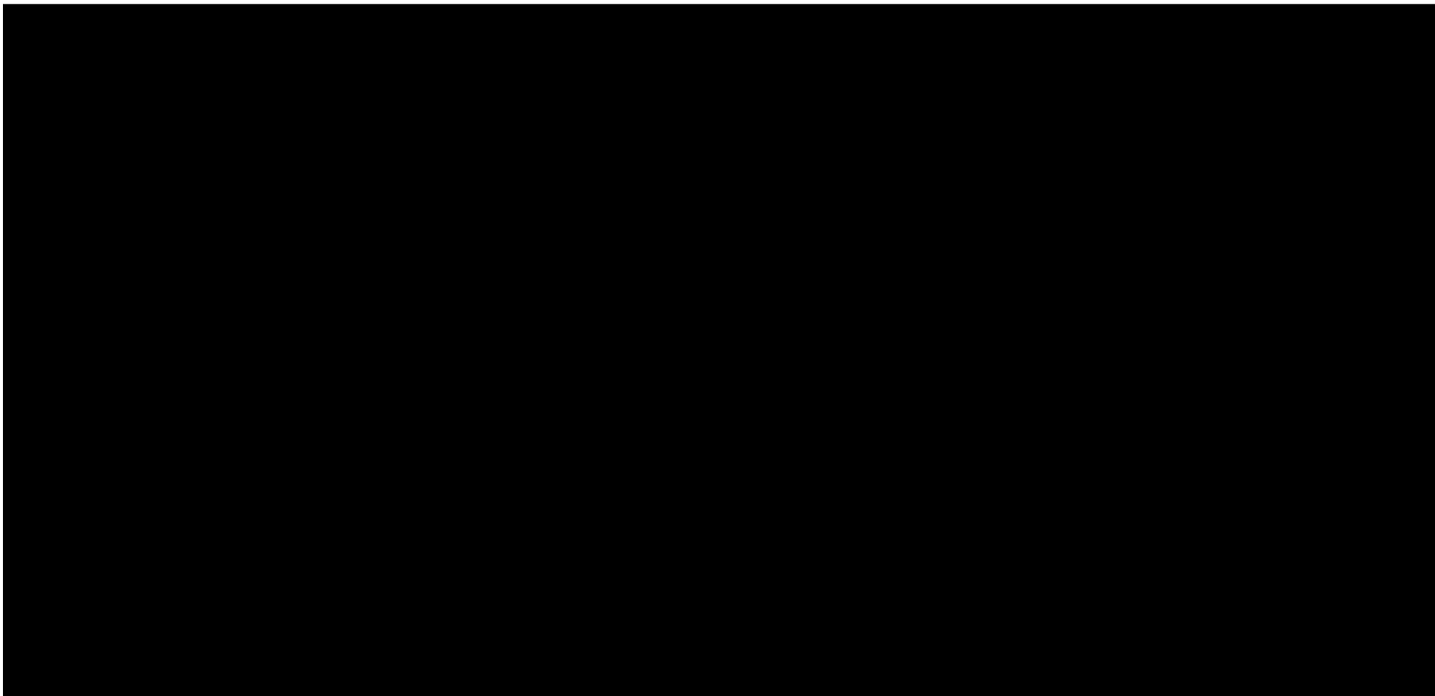

June 15 @ 4:49 PM - Arrived at 1965 Laurel Lindale. Contact made with patrol supervisor, Cpl. Scott. Briefed as to 3 confirmed deceased juveniles; (1) lying in the side yard near the porch stoop, (1) lying in the side yard near the driveway entrance and the last in Monroe Township Fire/EMS life squad. Patrol had established a secured scene, having the outer perimeter marked with crime scene tape with deputies posted and the primary perimeter with same.

Contact made with Investigation Supervisor, Sgt. Crouch. Informs me the mother of the 3 deceased juveniles has suffered an apparent GSW to the left hand and is in an additional life squad, awaiting ground transport to UC Hospital. Sgt. 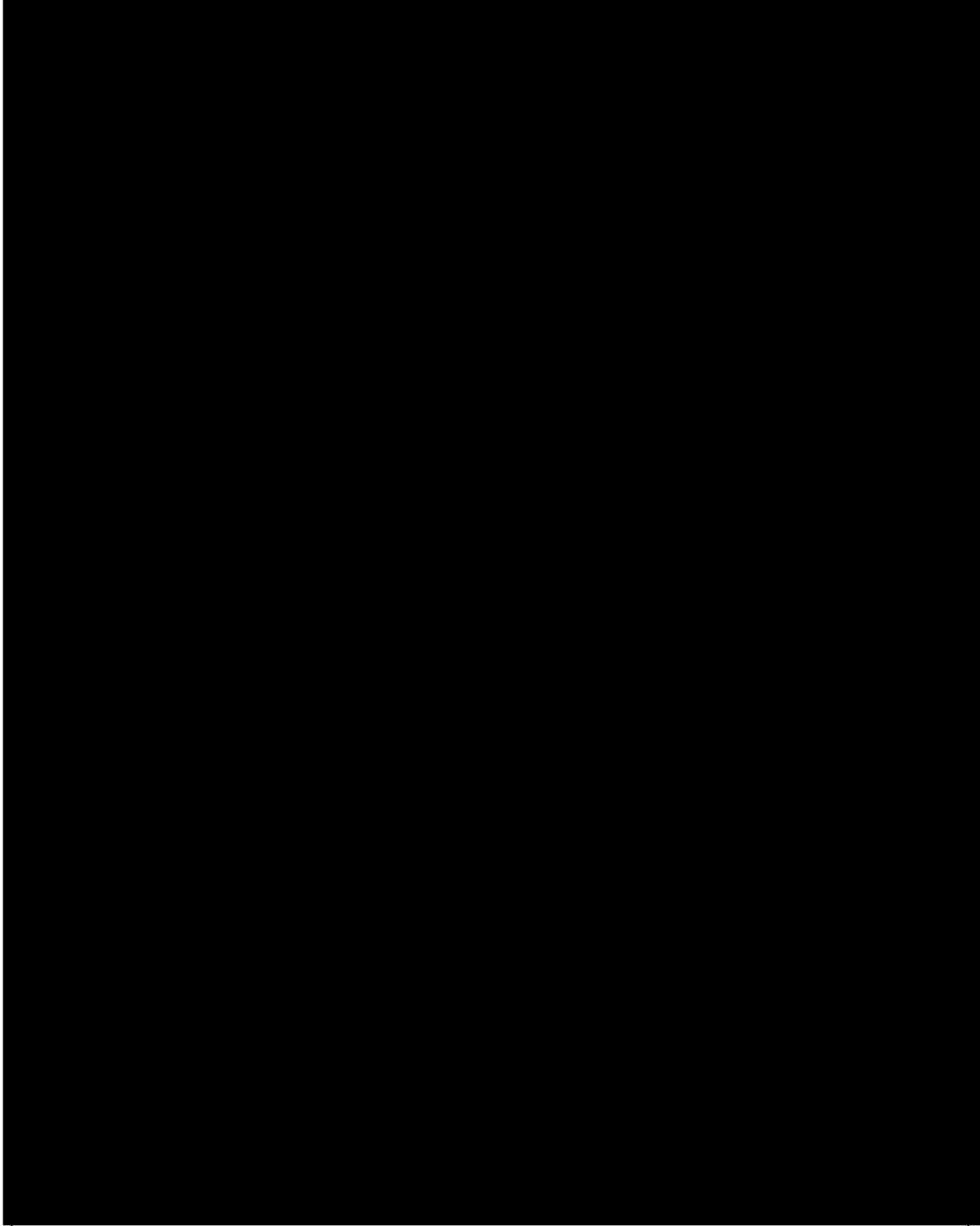

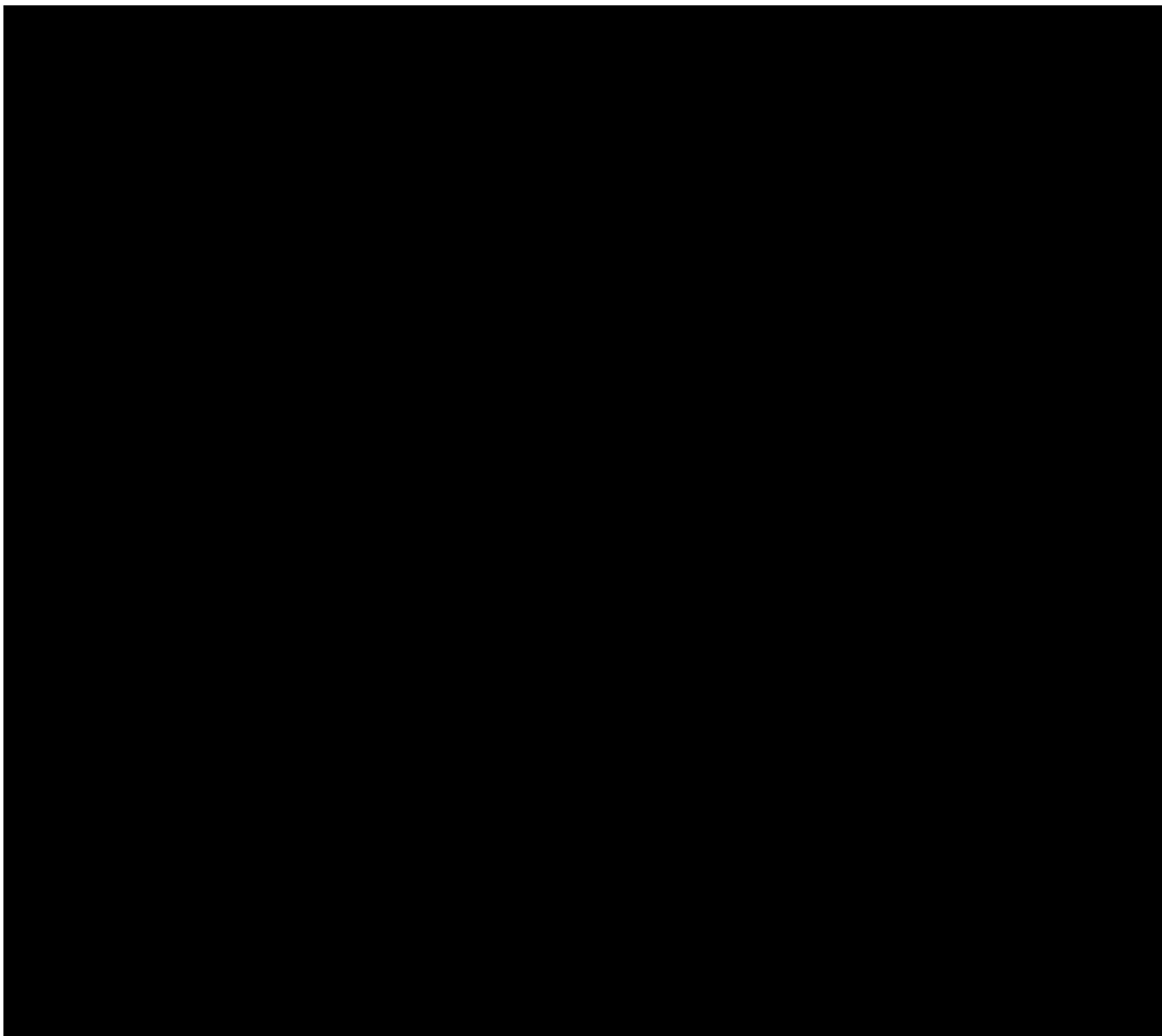
