

ALBERT STAUCH: Hello?

LETECIA STAUCH: Hey.

ALBERT STAUCH: So, hey you said there was an emergency that you needed to talk about?

LETECIA STAUCH: Yes, are you - are you, because I sent you the message about stopping searching and I said are you ready to, like, work together with me? Yes, I sent that to you.

ALBERT STAUCH: Okay, so, what is it?

LETECIA STAUCH: What do you mean what is it? I'm telling you - Oh my God. I don't know, I don't know to clear to say this - do you believe me now that I didn't do anything wrong?

ALBERT STAUCH: I - I mean, I'm just trying to get you - You made it seem like there was some urgent news that you had to tell me and this is -

LETECIA STAUCH: [inaudible] you and I sent you the link you were talking about with the landfill that was old!

ALBERT STAUCH: Oh, so there wasn't really anything urgent and pressing that would help me find Gannon?

LETECIA STAUCH: I'm asking you, are you ready to work together with your wife to do it?

ALBERT STAUCH: Yeah, I'm telling you I'm going off your list number one Gannon so let's, let's focus on that, okay.

LETECIA STAUCH: So, you read my list. Why are people sending this about lies about airports and all this -

ALBERT STAUCH: I don't know.

LETECIA STAUCH: You can't have a straight goal in common.

ALBERT STAUCH: I don't know. I - I don't care about social media, never have. Who cares what people are saying? I rode - I rode with my mom to the airport.

LETECIA STAUCH: Okay. Where are you?

ALBERT STAUCH: Where am I?

LETECIA STAUCH: Yes.

ALBERT STAUCH: I told you, I just stepped out of work on lunch break.

LETECIA STAUCH: Like wh- As the node?

ALBERT STAUCH: No. As in the headquarters.

LETECIA STAUCH: Okay, are you gonna be, like, able to stay with your wife so we can work on this together?

ALBERT STAUCH: I'm not making any promises.

LETECIA STAUCH: I just need - I need to know like now, like starting tomorrow.

ALBERT STAUCH: Well, you're not even here so if you're telling me starting tomorrow -

LETECIA STAUCH: I can't fly the dogs!

ALBERT STAUCH: Well how did the dogs get to where you're at if they couldn't fly?

LETECIA STAUCH: [inaudible] in the car with friends. I have - All I've been doing is - The dogs can't get on a airplane -

ALBERT STAUCH: What friends?

LETECIA STAUCH: The only thing [inaudible], I stayed with a friend named Michelle [inaudible], some of Jace's people, Janine that works with Harley, we stayed at their house.

ALBERT STAUCH: Okay.

LETECIA STAUCH: We've just been staying everywhere. The dogs cannot get on an airplane.

ALBERT STAUCH: Okay, fair enough, but I wanna - I wanna get back to Gannon.

LETECIA STAUCH: I want you to tell me I'm gonna work together with me.

ALBERT STAUCH: That's not a priority.

LETECIA STAUCH: - be together so we can work out everything, figure this out, get a plan in place.

ALBERT STAUCH: But why, why, why is - Why is the safety of a child contingent upon anything other than finding him?

LETECIA STAUCH: [inaudible] help if we're not together!

ALBERT STAUCH: Yes you can.

LETECIA STAUCH: [inaudible] find - I can't do any of that together. [inaudible] together and write it down ten freaking times and work through it. [inaudible] I've begged for this.

ALBERT STAUCH: But I still - I still don't understand how you helping me with Gannon is contingent upon anything else -

LETECIA STAUCH: It's not contingent, I'm your wife. Did you file for divorce?

ALBERT STAUCH: [whispering on the line, "step 1"]

LETECIA STAUCH: Did you?

ALBERT STAUCH: I didn't hear what you said, what?

LETECIA STAUCH: Did you file for divorce?

ALBERT STAUCH: I told you that already, no. Do you want me to?

LETECIA STAUCH: Ok, no. I - Are, are you cheating on me?

ALBERT STAUCH: Am I cheating on you? No. Listen, we need to focus on Gannon, okay. You, you told me you had -

LETECIA STAUCH: It's not like some big plan.

ALBERT STAUCH: No, it's not. Yeah, it is. You're right. It's a big plan to find my son.

Absolutely. Okay, so listen to me. You made this, like you always do in these scenarios, you made it seem like we can fix this immediately. You got some big piece of information - Listen, listen -

LETECIA STAUCH: - to me and be open-minded in order to [inaudible] and [inaudible] you taking my side in order for it to even be working, 'cause if you'll go against me you fuck me, you be whatever - You try to do whatever, all these things, we can't get to what you need.

ALBERT STAUCH: Okay, so, alright. That - But that's what I wanted you to say because you just told me that finding Gannon *is* contingent upon what - you're getting what you want. You - Yeah, you said if you do - If I don't fuck you or don't be with you and don't sleep with you -

LETECIA STAUCH: I didn't say that.

ALBERT STAUCH: Yeah, that's what you said, in essence, is that if I don't give you what you want we don't find Gannon. So, listen - But, hold on, hold on, listen -

LETECIA STAUCH: - together.

ALBERT STAUCH: I'm going back in now. I thought you had some emergency -

LETECIA STAUCH: [inaudible] okay. [inaudible]

ALBERT STAUCH: If listen - If you tell me information I need to know about Gannon like who took Gannon or what happened to Gannon then we, we talk about this other this other seven parts of your list, okay. But, number - Number one is Gannon. Nothing happens - If - For anybody in the rest of my life, period, until I get information about Gannon or find him. I thought you didn't have a car sounds like a car to me.

LETECIA STAUCH: I told you! I'm driving [inaudible] someone's old vehicle because I don't have [inaudible]

ALBERT STAUCH: All right, go ahead. I'm sorry. I'm sorry, go ahead.

LETECIA STAUCH: I need you to tell me that you have confidence and believe in me, okay?

ALBERT STAUCH: Number one on the list is Gannon. So, okay.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I believe in you and have confidence in you that you'll tell me the truth.

LETECIA STAUCH: Alright. Number One, finding Gannon. All right so why come there hasn't been any kind of, like, locations searches anything outside of only where I went. [inaudible] most concerning thing to you is that the first things that has to be done. Okay, so, tell me why that's not happening.

ALBERT STAUCH: That's a question we need to ask the law enforcement, not me.

LETECIA STAUCH: But that's not something that you have even thought of to ask? Because, I mean, you called me to ask about this landfill that was something was messing around with your head, being a dick, [inaudible] several times -

ALBERT STAUCH: I'm sure - Yes, I've asked them this, 'what, why are you searching there?' 'Well, you know we can't tell you anything.'

LETECIA STAUCH: Okay, so then. Okay, next question. Everywhere that I went, okay, was searched. [inaudible] acres upon acres upon acres when I didn't even go to those acres.

ALBERT STAUCH: [whispering on the line]

LETECIA STAUCH: How do we find Gannon - If none of those things - He was none of the places that I went, does that not make you open up your eyes to say that I'm not involved someone else is?

ALBERT STAUCH: Yeah, you're absolutely right I - And ,like, back to your first question I believe in you, okay. But I believe you know that someone else involved and you know who. That's what I want, okay. So, but - But, then - But, see, then you keep sending me messages, 'emergency we can fix this right now,' but then you never tell me anything. Never -

LETECIA STAUCH: [inaudible] number two, that's the second thing. We know that, alright. Anything I haven't done - So, why come when I gave them the information that I gave them, why didn't they - Why did they not look into it? Why did they not believe it? Why?

ALBERT STAUCH: What information? About, about Quincy Brown?

LETECIA STAUCH: [inaudible] anywhere -

ALBERT STAUCH: Are you talking about Quincy Brown? What information are you talking about?

LETECIA STAUCH: No, I did not.

ALBERT STAUCH: What information?

LETECIA STAUCH: Okay. you just said they don't tell you anything right? That's what you said.

ALBERT STAUCH: Okay. Yeah, exactly.

LETECIA STAUCH: So, which means they would have gotten information from me.

ALBERT STAUCH: Okay, so what information was it?

LETECIA STAUCH: - information that I told them, they have not covered any areas except only the areas that I drove.

ALBERT STAUCH: Okay, but what information are you talking about? Why won't you give me that information? I'm the father of the missing child, Tecia.

LETECIA STAUCH: But I've already told you one time and when I told you it wasn't good enough.

ALBERT STAUCH: Well, tell me again. Tell me right now I'm - I'm in believe Tecia mode.

LETECIA STAUCH: Do- Okay. How long do you have?

ALBERT STAUCH: Like, five to seven minutes. Honestly I gotta get back in.

LETECIA STAUCH: [inaudible] five to seven minutes.

ALBERT STAUCH: Well, what do you need? Tell me what you need. An hour? Ten minutes?

LETECIA STAUCH: Are you on lunch? I mean, I'm trying to mess you up at work.

ALBERT STAUCH: No I'm working like, I'm working like four hour days. So, I mean I've come out because I told you I'd come out around this time, okay. But I - I got a another hour or some work and then I'm I'm leaving for the day. Because they're just trying - Like I told you this morning, they're trying to phase me back in, so I don't want to be out here for 20, 30 minutes.

LETECIA STAUCH: Okay, so then what time can you sit down and talk with just you not with you and all your other, other, uh, clan.

ALBERT STAUCH: Right now.

LETECIA STAUCH: So you got 30 minutes to give me right now?

ALBERT STAUCH: Listen, I'll make up some bullshit when I go back in there but yeah, I got - I'll give you 30 minutes right now. Walk me through it.

LETECIA STAUCH: Alright. Now, I need you to answer this question. Why - How many of the videos - so it can all make sense to you - have you saw other than one video?

ALBERT STAUCH: Listen. This is not Albert answers a bunch of questions. You tell me -

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: No, no you tell me what I'm missing or haven't seen. That - That's what this is about. This is not you -

LETECIA STAUCH: Have you seen a video of anyone pulling into our yard after 4 o'clock?

ALBERT STAUCH: Have I seen a video?

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Have I seen any video of that I'm not sitting here answering questions okay I haven't seen other than what's been released. I haven't seen what's other than been released to the public. I'm not sitting here getting questioned. You said you had a story to tell me about this -

LETECIA STAUCH: Didn't say I had a story -

ALBERT STAUCH: Okay. okay.

LETECIA STAUCH: - helping you.

ALBERT STAUCH: Okay, well help me. Okay, I'm listening.

LETECIA STAUCH: Did you see any of the videos?

ALBERT STAUCH: I'm listening. I'm not being questioned, okay. Tell me what I'm missing in the video. Just tell me. Don't ask me. Tell me.

LETECIA STAUCH: In the video when Harley comes home and Laina - I'm sure you had to see this - just tell me where Harley parked her car.

ALBERT STAUCH: I have no clue, Tecia. Tell me what you're trying to tell me. Now you're gettin' me upset.

LETECIA STAUCH: You haven't seen this?

ALBERT STAUCH: No, I have not seen anything. I told you that I've seen what is on the internet on the video about the truck. That's it.

LETECIA STAUCH: Okay, so can you wait by your phone for five minutes -

ALBERT STAUCH: You said - You said 30 minutes and just - If you have something

LETECIA STAUCH: [inaudible] 30 minutes, but I need you to wait by your phone for five minutes because I have this girl's kids in here.

ALBERT STAUCH: You have what?

LETECIA STAUCH: Her kids are in her car. I drove to get some food. I have her kids in here so I just need five minutes to pull up in the yard for the kids to get out.

ALBERT STAUCH: What, but - What - What does that keep you from sending a video?

LETECIA STAUCH: It's not sending a video! I don't want to talk about it with kids around.

They're, they're - they can hear me. I'm asking you for five minutes. Just give me five minutes, let me pull in the yard. And they get out.

ALBERT STAUCH: Just tell me what you got to tell me. There's no kids in the car. I don't hear a peep, okay.

LETECIA STAUCH: Can you - There is a kid in the car!

ALBERT STAUCH: [inaudible] listen, I'm going - Listen I knew - Either you tell me now I'm just gonna put the phone down and go back into work, okay, 'cause I don't got time to sit here you jerk me around. I'm tired of you jerking me around.

LETECIA STAUCH: - literally almost to the streets.

ALBERT STAUCH: Listen, I don't have five minutes. I got the 30 minutes you asked for. I got that. You start telling me whatever it is you got to tell me. Who cares if a kid's in the car? If - I mean, that that should be a good thing that you know information that can help you find the missing kid. I'm sure they've heard about it.

LETECIA STAUCH: I don't know if they did. They might've not've.

ALBERT STAUCH: Well -

LETECIA STAUCH: Look. I'm turning on her street, just hold on.

ALBERT STAUCH: Yeah, okay.

LETECIA STAUCH: I swear to you! I'm literally turning on her street right here.

ALBERT STAUCH: I don't - I'm not questioning you. I'm in believe Tecia mode. I'm just waiting for some facts that I can believe.

LETECIA STAUCH: [inaudible] turning on her street.

ALBERT STAUCH: Okay, I believe you.

LETECIA STAUCH: Like I'm, passing the church right now -

ALBERT STAUCH: What church?

LETECIA STAUCH: - and then I'm going on to this.

ALBERT STAUCH: Alright, so -

LETECIA STAUCH: The church! I guess their church. I don't know if they go to church there. I don't know.

ALBERT STAUCH: Oh, you pass by but there was no sign? Okay, cool.

LETECIA STAUCH: Yeah there was a sign! I'm looking at the roads!

ALBERT STAUCH: Okay.

LETECIA STAUCH: - miss the turn -

ALBERT STAUCH: All right, hey, I believe you.

LETECIA STAUCH: - know my way around -

ALBERT STAUCH: I believe you. I'm not trying to question you I'm just - It was - I just want to know if I knew the church or the pastor or anything, sorry.

LETECIA STAUCH: I'm literally turning in. And right now all I'm gonna do is pull over here. Can you go inside with your mom and I'll just - Yeah. And I'll be in in a minute to [inaudible] Alright, give me one minute.

ALBERT STAUCH: Sure. Okay. You there? Tecia.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Yep, I'm here.

LETECIA STAUCH: [inaudible] and then um I'll get the dogs and I get back. (no!) [inaudible] weekend[inaudible] gotta get to work. Okay. Literally [inaudible] she's getting out. [inaudible] um stuff for your mom. Alright. Where did you put mine at? Right there? Okay. Thank you. See a little bit. Sorry, her daughter is like, old age. Anyway alright. [inaudible] was telling you all that is I need you to believe, Albert, I need you to believe that someone did take Gannon. I need you to believe that I've already given the police department a description. I've already did that. I need you to quit thinking that it's somebody just made up, because it's not. Obviously, I didn't do it. There's no way possible that I could have been hours and hours away in a certain window. I need you to help them re-look at that. I'm telling you Gannon would have left our neighborhood anywhere between that time frame and it wouldn't even be surprised if it weren't like the kid in North Carolina -

ALBERT STAUCH: What certain window are you talking about?

LETECIA STAUCH: The certain one I'm talking about between three and anywhere that evening because here's why. There was a lot of people out and about in the neighborhood, everywhere -

ALBERT STAUCH: So you weren't home during that certain window, is that what you said?

LETECIA STAUCH: Do what?

ALBERT STAUCH: You said you weren't home during that certain window or he could have left in that certain window?

LETECIA STAUCH: I'm saying that's when it happened. So, by the time I called, okay. Gannon still could have been in the neighborhood.

ALBERT STAUCH: What, but you said when "it" happened. What is "it" Tecia?

LETECIA STAUCH: I told you already. You haven't looked at it to see - Okay. Go to the Rings. See we went out the front door. When we left we went out the front door, okay. When we left I set the alarm. I went out the front door. I came back in the front door. I made sure the alarm was set, went out the garage. You can see that on the Ring. When I came out, I think it was like 10:07, 10:08-ish maybe, we left out. We were in the garage.

ALBERT STAUCH: Okay.

LETECIA STAUCH: There was no more, at that time, there was no more, um, anybody going in and out of the house. And the dogs do not set off the motion in the house.

ALBERT STAUCH: Right.

LETECIA STAUCH: They don't, okay.

ALBERT STAUCH: Not, not when they're in their crates you're right.

LETECIA STAUCH: Yeah, the dogs are in their crates and as sure as heck if I'm somewhere upstairs they're with me they're not just roaming around doing their thing. They're following somebody that they love, okay. When we came back, I told you 15,000 times about the car following us at Petco. The reason I left the car - the phone - at Petco... You wanna know why? Why don't y'all go check the alarm on it. I set an alarm for it to go off if I hadn't come back in the time frame to call the police. I set the alarm on there, Albert. LETECIA STAUCH: I never knew anybody was in the truck.

ALBERT STAUCH: But if they followed you from the house didn't they see y'all get into the truck?

LETECIA STAUCH: I was like, not the house as in our house, as in like the area -

ALBERT STAUCH: Alright, alright. Okay, alright. Help me be in believe Tecia mode, okay.

Alright, don't start spinning. Just tell me -

LETECIA STAUCH: I'm not spinning!

ALBERT STAUCH: Okay.

LETECIA STAUCH: [inaudible] make me go through the whole entire thing!

ALBERT STAUCH: Okay I'll - I'm - Go ahead, go ahead.

LETECIA STAUCH: Okay, so I get there. I was playing with these period pad things because apparently dogs have periods, okay. So, I'm holding the thing and I sat there and I set alarm just for the alarm to go off. [imitates ringing] like whatever whatever, that was for the alarm to go off. Maybe I was being too super superstitious. I just was being whatever - Who - I don't know, okay.

ALBERT STAUCH: [big yawn] Sorry.

LETECIA STAUCH: And now you're yawnin'?

ALBERT STAUCH: I, I'm - Listen, this is - I don't sleep good at night. I haven't for years, you know that, so go ahead.

LETECIA STAUCH: Albert, I was supposed to like deliver papers.

ALBERT STAUCH: Deliver -

LETECIA STAUCH: I couldn't do it, Albert.

ALBERT STAUCH: Deliver papers? For what? Tecia.

LETECIA STAUCH: When I went to Nevada there was this pregnant lady. So, I agreed to help the pregnant lady because she was really, really pregnant. She gets in - She gets in the car, which is why Gannon was not in the front seat, he was in the back seat.

ALBERT STAUCH: Wait, you said when you went to Nevada?

LETECIA STAUCH: I went through Nevada on my way to Petco!

ALBERT STAUCH: Oh. I'm like what? You're in Nevada? Anyways, go ahead.

LETECIA STAUCH: Right. When - I realized she's not pregnant. Once she gets in the car.

ALBERT STAUCH: Was this the same lady that was following you?

LETECIA STAUCH: I don't know if they were following us -

ALBERT STAUCH: Oh.

LETECIA STAUCH: - I just know there was a car following us. When I get off I turn where Harley gets little eyelashes done because I thought I would lose them. Then, I saw a pregnant lady she looked legit like eight months pregnant.

ALBERT STAUCH: What kind of car was following you? 'Cause maybe -

LETECIA STAUCH: - told you this 15 times -

ALBERT STAUCH: Okay.

LETECIA STAUCH: It was like. it was a little, blue something. Like a coupe or something like this.

ALBERT STAUCH: Okay, so like a blue - not red, right - just a blue one?

LETECIA STAUCH: No, there was a - The red earlier in the day, was nothing. It's already been checked out.

ALBERT STAUCH: Okay, alright.

LETECIA STAUCH: The reason I know that was being checked out because I had somebody in Lorson Ranch do it.

ALBERT STAUCH: Alright, I'm just making sure I make sure I keep these cars straight. So, it was the blue one not the red one.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Don't get upset. I'm just trying to get it straight. I'm not picking holes in your story. I'm just making sure we're on the - on the blue car, okay. So, now go back to the pregnant lady that gets in the front seat.

LETECIA STAUCH: So the pregnant lady gets in the front seat, but she's not really pregnant. I don't know that she's not really pregnant but she says she just needs a ride. I feel bad. She looked really, really pregnant like - long - like eight months.

ALBERT STAUCH: Hmm.

LETECIA STAUCH: Huh?

ALBERT STAUCH: I said, 'hmm.' I'm just listening.

LETECIA STAUCH: You know what, I'm not gonna help if you're gonna do this to me.

ALBERT STAUCH: Are you saying I don't believe you?(?)

LETECIA STAUCH: I really really came in this to be honest with you.

ALBERT STAUCH: Okay, I'm just listening.

LETECIA STAUCH: No, you aren't. You're being a dick by saying "hmm." That's being a dick to me!

ALBERT STAUCH: I don't know why you're saying that, but, does the pregnant lady know what happened to Gannon? Does she know where Gannon went?

LETECIA STAUCH: That's pretty scary, right? You're making fun of this like -

ALBERT STAUCH: No, I'm not. If somebody got in my truck with a pregnant belly full of cash I'd be worried to death. You're right.

LETECIA STAUCH: I don't know how else to help other than to know we were in the wrong place at the wrong time.

ALBERT STAUCH: Okay, are you talking about Petco?

ALBERT STAUCH: I'm sorry you think that, but go ahead.

LETECIA STAUCH: I'm not - Forget it, man. You're not wanting to stand by my side, you don't want to help.

ALBERT STAUCH: I'm right here standing by your side listening to, uh, the truth, okay. I'm in believe Tecia mode like I told you.

LETECIA STAUCH: Yeah, and then what're you gonna do? Tell me a lie and then hang up?

ALBERT STAUCH: Are you telling a lie?

LETECIA STAUCH: No, that's what you're gonna do! You're not gonna believe it. I told you it was beyond your wildest imagination to know we was in the wrong place at the wrong time.

ALBERT STAUCH: He was in the wrong place or y'all were in the wrong place? Okay. We was in the wrong place, okay. Alright. I mean, are you are you telling me this - I don't know. ALBERT STAUCH: No, I'm trying to - I'm trying to make sense of all of it, okay. You want me to believe you. I'm giving you the benefit of the doubt. Tell me the rest of the story.

LETECIA STAUCH: Albert, to sum it up, it's just being piled up in the wrong place at the wrong time with people who are money laundering wanting me to - want me or whoever they can get - to deliver a paper to these Mexican restaurants and you're supposed to get packages back from them and I wouldn't do it. So that's why we were on County Line Road because I was scared to death. We, I left. So I was going round and round and round to make sure there's no cars following me.

ALBERT STAUCH: So is that where they were trying to send you or you just went there because you knew that - You knew that was out in the boonies?

LETECIA STAUCH: No, because 25, I got on interstate 25 and it was backed up.

ALBERT STAUCH: Oh, so you did like we did that one time and took a detour?

LETECIA STAUCH: - nothing to do with whatever. They've already searched the entire area. I'm innocent. That's who has Gannon, okay.

ALBERT STAUCH: The pregnant lady with the cash?

LETECIA STAUCH: No! Whoever has [inaudible] 'cause I've already given it to the Mexican guy! Why do you think I told you that about the Quincy thing because the whole Mexico. We need to be looking at any routes going into Mexico and I've been telling you this!

ALBERT STAUCH: No, but you told - No, okay alright. I'm out of believe Tecia mode now, okay, because you told me Quincy Brown was in Colorado Springs. His family told your news reporter that he's in Mexico, okay, you didn't know that beforehand. Of course, you have nothing to say about that. I'll talk to you later.
