

LETECIA STAUCH: Hello?

ALBERT STAUCH: Hey.

LETECIA STAUCH: Hello?

ALBERT STAUCH: Hey, can you hear me?

LETECIA STAUCH: Yeah, I can hear you.

ALBERT STAUCH: So, I just got off the phone with that Amber lady and -

LETECIA STAUCH: Uh huh.

ALBERT STAUCH: I don't know, I kinda feel stupid now 'cause she's like no I ain't heard from nobody about nothing like that.

LETECIA STAUCH: I sent her a message!

ALBERT STAUCH: I'm just telling you what she said to me.

LETECIA STAUCH: [inaudible] or a landline cause I sent it to the number you gave me so if it was a landline maybe she didn't get it but if it's a cellphone then she got it.

ALBERT STAUCH: Ok, I'm just telling you what the lady told you. I don't know. Like I told you, I don't know what's going on.

LETECIA STAUCH: Is it a cellphone or a landline?

ALBERT STAUCH: I don't know, she I got - I called and she answered, that's all I know, I mean you wanna hang up and try to call her?

LETECIA STAUCH: I'm telling you it's gotta be a cellphone.

ALBERT STAUCH: Do you wanna hang up and try to call her? I'm just so sick of this, I'm just, listen [inaudible]

LETECIA STAUCH: [inaudible] hanging up to call the FBI.

ALBERT STAUCH: You don't have to, I'm just asking do you wanna hang up and try to call her instead of messaging her. What's I'm saying is I just want things to go back to like they were like Christmas, like, right when we got the two puppies. All the kids were there, everybody was so happy, kids were playing their switch, we were playing with the puppies and it's just life was just like happy as could be and then like, and then here we are. I just wanna go back to that Tecia, why can't we just get back to that place in our life?

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: What?

LETECIA STAUCH: Do you think for a second that's not on my mind every single day and that's not what I want? I - I put in so much effort in Christmas and what [inaudible] how much effort I put into Christmas and holidays for everyone? And you think for a second that's not what I want? I go out of my way for all of our children, I have tons and tons of clothing, everything that's [inaudible] Who do you think bought it? Who do you think did all that? Do you want -

don't you think I love doing that? Want to [inaudible] and I pray every day that's exactly - I wake up every morning looking for you and realize I'm not beside you then realize I'm not helping the kids get ready for school. You think I don't know that and want that? I didn't like I wasn't going through some terrible [inaudible] you know I loved my life I hate myself [inaudible] that's wrong. We had a great life (or house?) we have a great family, like really?

LETECIA STAUCH: So don't bring up Christmas and how you want the dogs, you think [inaudible] that I don't get to be like oh gosh you know [inaudible] guess what! It's the 17th so happy anniversary every 17th month by month by month, think that's not coming up, you think I don't want to do that? You think the kids do not think about that every time? ALL the kids you know why Landen pops up and gets to be the saint cause it's the 100th day of school? I GOT THE KIDS IN THE SCHOOL! I kept them in school! I homeschooled them! You think I don't want all that back? Come on now!

ALBERT STAUCH: Well how -

LETECIA STAUCH: You think I don't want [inaudible] doing all these different things when Gannon finally gets to middle school because maybe just maybe the [inaudible] one of us [inaudible] for him to get [inaudible] like you know [inaudible] interested in sports so I can be at the schoolhouse and be a part of. You think I don't miss all this and want it?

ALBERT STAUCH: Well how do we get it back? How do we get back to just a month and a half ago .That's what I wanna know. 'Cause a month and a half ago there was 5 people and two dogs, now it's just me so how do we get back there.

LETECIA STAUCH: [inaudible] Albert -

ALBERT STAUCH: Like I don't even have, listen, I don't even have Laina, she's in Texas right now I'm frickin' -

LETECIA STAUCH: [inaudible] that's your fault, let me just go ahead and tell you [inaudible] you shouldn't have allowed that to happen that was irresponsible on your part ok and you could think that I'm wrong or for whatever reason you want to ? don't agree with that because at the end of the fucking day she's still a drug addict, she still don't take care of her kids and she still don't have a place to live. I wouldn't have let my child left with her so that's on you, that's not me. I didn't make that decision, and would've never made that decision.

ALBERT STAUCH: So, but. She's coming back, don't get me wrong. She's coming back, I'm just talking about this weekend ok. She's down there with them but even then how do we get back to the five of us? The five of us. Me, you, Harley, Gannon, and Laina? How do we get back to that point? How do we have a family and two dogs and a two story house and all the things that we had and three cars and you know the American dream. Right now I'm living the American nightmare. How do I get back to the American dream? I need you to help me get there.

LETECIA STAUCH: Albert. The first step is we figure out wh- the people in this world are cruel, ok, they are, people are cruel, ok. You in your mind know better than [inaudible] that American Dream you just talked about? We would have never had it if any of those five people in our home would have been cruel. If any of those five people would have been out to hurt people or do bad things to people ok. So that's the first step that you need to realize is that this is

not me against you. Yeah, of course people - always in marriages you're gonna have disagreements but you know good and well we literally just got off a cruise for our anniversary. I made sure that the children were in the best care possible with someone staying there not only with Harley, ok, someone, an adult like to make sure that they had everything they needed, not a worry in the world. You know I've always done that. I've always security systems installed, checked the ring app, check the alarm. You know me as that person so [inaudible] you put that in your mind that's the first step because you can't be against your wife on this and you can't be thinking what these people are thinking online that I'm this devil [inaudible] because that's not true. Without me, without me, and God, the children would not be in our home and without you and God, the children would not be in our home because they were in a horrible situation, [inaudible] back to where it is, we need to figure out [inaudible] who can help us, who can help us figure out the best way to get Gannon. Whether whatever it is. Do you want me to give him my legs? Do you want me to give him my arms?

ALBERT STAUCH: No, no no listen I'm telling you, I told you this yesterday. I feel like this is all gonna be my fault in the end okay because I was gone when this happened so, don't.

LETECIA STAUCH: No -

ALBERT STAUCH: Don't sit there and offer your legs and arms up when it's my fault.

LETECIA STAUCH: I'm not gonna let you say that and here's why ok, let me tell you here's why, because when you were in Oklahoma for 5 months I had to be the one staying and checking to make sure the kids were ok, I had to be the one driving, making sure [inaudible] this, that,

[inaudible] people barely [inaudible] I had to do that for you. I had to drive through the night to Orlando through a hurricane to get them to you in Oklahoma, ok.

ALBERT STAUCH: But you gotta understand, let me tell you how I feel, let me tell you my feelings. What is one of the most important things to me that I always say? Protection, right? And I failed in that because I couldn't protect my son and I couldn't protect you from getting your head smashed and all these other things ok, so that's how I'm feeling right now, so how do we get back to what we were with 5 people in our family?

LETECIA STAUCH: We were! We are that. Why are we saying get back to it? That's what we are.

ALBERT STAUCH: No, because I'm one person, Gannon's unknown, you and Harley bounced, Laina's with Landen, ok. That's not 5 people. That's four people somewhere and one person unknown. So how do we get Gannon back number one?

LETECIA STAUCH: Let me ask you a question okay. We're gonna sit if we're gonna sit here and we're gonna say okay we're gonna focus on two separate things here. The first thing is we're gonna come back to getting Gannon back and all that. But let me ask you what you just said. Let me answer to what you just said. You can't teach your mind that that's what you wanna get back if A) - you, [inaudible] now, let me back up and say this. Tecia and Harley didn't leave, this is what happened. Tecia and Harley came back after they took absolutely everything from me. I went in, you were laying on the sofa and I tried to talk to you. I said come to the bedroom let me talk to you ok. I tried but then they, you helped them, you did, instead of just calling to say hey

listen they wanna take Harley's care and they wanna take her phone you didn't never say that ok, you could've been trusting and said that to me. You know good and well I have a lot that I've worked hard for to throw away [inaudible] you could've called me, you could've said that. Instead they chased us down and your child that you're saying you want back in your life and you want was put in handcuffs when she was buying underwear.

ALBERT STAUCH: I'll stop you right there. All that's my fault, you're right. I could've stopped it, I could've said, 'no, leave the girls alone.' You're right, ok. Keep going, tell me the rest of it.

LETECIA STAUCH: So, when I come back ok, after all this I, we had the most important thing that you knew I needed, the most important thing that means the world to me and all of that was our items specifically my diamond ring were in that car. I tried to reach out to you to say can you please at least ask them can we have those things, you wanted nothing to talk to me because it means the world to me to have my ring because I took my vows for better [inaudible] and I tried reaching out to you hey they have my ring they have my ID I don't even have money because they have my card. You wouldn't even talk to me so then you wonder why I said if my husband would not even talk to me he would not even warn me that my child was about to be put in handcuffs *(she is crying now)* ok, [inaudible] because I was yelling at Harley not to move [inaudible] and [inaudible] told them to shoot me right there [inaudible] on camera

ALBERT STAUCH: Listen, I'm sorry. That's my fault. No I want you to know, I'm telling you, all this is my fault, ok, I'm acknowledging that. Keep going. I'm just trying to be a team here.

LETECIA STAUCH: So then you tell everybody I leave when the truth is you didn't step up in any of that to say [inaudible]

ALBERT STAUCH: Ok, alright, I'ma stop you there you told the world on camera you left, I didn't. So let's clarify that and then you can go on.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Ok, go ahead.

LETECIA STAUCH: [inaudible] why I wasn't, they asked why I wasn't out there.

ALBERT STAUCH: Ok.

LETECIA STAUCH: Listen to me! In the situation I'm sitting here getting all my things taken and I and people think I don't have feeling why this [inaudible] sitting up in our house when she [inaudible] think about our kids [inaudible] she didn't even call Laina on her birthday which is four days before and you think I'm not angry? You think I was sitting there mad thinking you don't give a fuck about them? Yeah. Call me ? for that. I'll take the blame for being [inaudible] that you ever left that bitch anywhere near our house the way she did our children. [inaudible] that she came to our house drunk and I had to let her stay at 46974 [inaudible] Drive? And you locked me out and told me I was on her team? Because you were drunk and I wouldn't let her lie or whatever ? Let her [inaudible] those kids? That's why. Because I don't care what the situation is, you should've put her ass in a hotel, but you didn't, [inaudible] to our children. I don't care what the times were because that didn't do anything but put a wedge between us so yes when I

came back that night I had no other choice but to get clothing. I had no intentions of getting but a few things of clothing but then when I see this bitch Victoria and all these people I'm not gonna name any names [inaudible] with my motherfucking clothes on and then I see people using my products you can say what you want to in a time like this you shouldn't worry about that, I'm not worried about the material things, it's the principle in my home. 'Cause I don't They disrespected my like that, there's no telling what they did to you or would've did to our children that is why I was angry so be mad at me and what you want because I took clothes from there because I didn't want them burned, I had a when I walked in that house the first time that ? had been moved, that shouldn't have happened Albert. You shouldn't have let that bitch Veronica walk around and move my shit that was wrong. Where was this bitch at when we needed help? When I needed somebody to help sometimes where was she at? Where was she at when we needed help sometimes when you would be working? When we needed a babysitter? Where the fuck was she at? And you let her walk around in our home and move my shit and then you let her go downstairs and do what she did to Harley? Oh, that was it.

ALBERT STAUCH: When who did what to Harley? No, I don't know. Who did what to Harley?

LETECIA STAUCH: Oh! Why don't you ask Veronica about when she walked downstairs and talked to Harley. And then my mother wasn't allowed to say a word to the kids. She wanted to make sure we got our things. You ask her that.

ALBERT STAUCH: No, I'm asking you, I don't know what the hell you're talk-

LETECIA STAUCH: Then you ask Harley Hunt that, man. You let that woman follow that child downstairs and didn't even step in to say a motherfucking word.

ALBERT STAUCH: Follow her downstairs? Wait wait wait, I don't know what happened, Harley can tell me later, I don't know.

LETECIA STAUCH: Yeah. So my point is when you, you could [inaudible] I left I wasn't trying to be apart. You did not step in to help me defeat any of the odds, you tried sit there and tried to talk to people, to try to remember anything else, to try to go through the steps of it, I immediately had to go into a defense mode fighting for myself when nothing, nothing [inaudible] I was told, I was [inaudible] and [inaudible] that bitch in my home [inaudible] and you wonder why I was like well why I am I gonna be here for? You shouldn't have even let her brother even put his hand on one of our handguns, you had no business with that.

ALBERT STAUCH: I, hey you better stop right there because I, hey, no. I was in total control of those weapons the whole time. You will not do that to me. Go ahead.

LETECIA STAUCH: You were in total control! But he had no business doing that -

ALBERT STAUCH: Who gives a crap about that, come on now.

LETECIA STAUCH: My point is, Albert, you let these people come in during that time, the first, you, the first few days and you let them control [inaudible] and you could say you didn't and maybe you were hurt, maybe you were upset, maybe your focus was on one thing and I understand that I'm not trying to do nothing but say ok [inaudible] thinking about that in my

mind and I still want my husband and I still know that he was not in his right mind there and then [inaudible] continually [inaudible] was not [inaudible] you could've stepped in and said right then that you are not a [inaudible] or you were not related to me by blood [inaudible] your sisters are, I know your mom is, if you're not a Stauch and you're not related to me by blood you need to leave this house. That's exactly what -

ALBERT STAUCH: Okay, alright, alright. Tecia, no stop, stop. Listen, I'll tell you. Put all that on me, I don't care, ok. We can fight about all that for the rest of our lives, you're right. I let people come into the house that ain't got no blood relation to me, you're absolutely right, ok. But the bigger issue here and I've let you go on, I'm trying to be respectful and let you talk and talk and talk but all this is about you and your damn stuff and not a damn thing about Gannon.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Yes it is. Yes it is.

LETECIA STAUCH: [inaudible] no, I, you asked me how. I said we're gonna talk about two separate things, that's what I told you. So that's the first thing. Now the most important thing is Gannon, you asked me how to have everything back, American dream like you said in December. Yuu just realize where your actions could've been different [inaudible] so until we have trust to put those actions back together and bring it back together as one, as one Albert, as one, you didn't marry me or I didn't marry you for it to turn our backs on each other in tough times. That's not how it works in life. You know me better. I know you better. You know, you

had to live with the [inaudible] of things that your father's done. I've never once said to you I don't trust you with my child, and I feel like you're bad around them. Never once.

ALBERT STAUCH: Actually you have said that, actually you have said that, which is bullshit, but go ahead, I'll listen to ya.

LETECIA STAUCH: NO I did not. You were both not sober and Landen was trying to get me to turn on you.

ALBERT STAUCH: Okay, alright.

LETECIA STAUCH: I'm talking about in our home, You know good and well if I went somewhere and Harley was there I was never worried for a second.

ALBERT STAUCH: Alright, so stop. You're not, stop stop. Let me interject because this is supposed to be about Gannon, this part, part one was, no listen please lis-

LETECIA STAUCH: [inaudible] so we can go get Gannon.

ALBERT STAUCH: Ok, the problem is here, you said until we have trust the problem is we're not there yet, ok. We're, because a few minutes, no no no listen listen, I'ma tell you why right now, ok. I've given. No -

LETECIA STAUCH: [inaudible] want to hear it.

ALBERT STAUCH: I'm gonna tell you why. I'ma tell you why and then I'll let you talk, ok. Please listen. I'ma tell you why. Because, ok, I've taken the blame for everything that I'm

responsible for in this situation probably more than I Should have but I'll take the blame for all of it ok. Quincy Brown's got the boy ok. But the part that I still don't have trust about it when I brought up the fact there's a puddle of blood in the house, you mentioned a head wound, you didn't even say a damn thing about that, Not a peep Tecia, you blew right past it so fill in the -

LETECIA STAUCH: - talking about!?

ALBERT STAUCH: Fill in the blanks for me.

LETECIA STAUCH: No no no no noonononono. What are you talking about a head wound? I never said to you about any kind of head wound. Now see this is where -

ALBERT STAUCH: No, you did, you said in the bicycle incident which you later told me was not true that you.

LETECIA STAUCH: - already told you I made that up because you wouldn't never believe anything I said.

ALBERT STAUCH: Ok, so how did the puddle of blood get there because it wasn't there before we moved in, so. Ok, tell me about the puddle of blood in the corner. No, you said the wall. You said there was something on the wall, who cares what it was, you cleaned it. I don't know anything about that other than what you said.

LETECIA STAUCH: - we cleaned everything from when Gannon, okay, I've already told you this.

ALBERT STAUCH: No, you didn't because we haven;t talked about this. There was a puddle of blood the size of like one of those paper dinner platter plates I mean it was, it was significant, and that was on the concrete which means it had to be significantly bigger and more thicker or whatever, I can't hear you.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Hello?

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: You're talking about something.

ALBERT STAUCH: I'm talking about something, no it was not already there, okay, that blood was not already there. How did the blood get there ok. It was a significant amount of blood. How did it get there in the corner of Gannon's room under his bed which you told me the bed were pushed together so how did the blood get there?

LETECIA STAUCH: Are you done yelling at me?

ALBERT STAUCH: I'm not yellin'. I'm not yellin'. How did the blood get there?

LETECIA STAUCH: [inaudible] you can tell all your little police people that are listening -

ALBERT STAUCH: Did Quincy Brown bang Gannon's head up against the wall or something? Did he bus Gannon's head open? Did he hit him with a 2x4? What did Quincy Brown do to Gannon? What did he do to Gannon that put blood on the floor?

LETECIA STAUCH: [inaudible] cause you were. I'm not stupid. I know you have police there, I know you have people there.

ALBERT STAUCH: You can believe whatever you want obviously 'cause I've had so many frickin' stories that you believe that were true to tell me and then you always back off of 'em ok, so you can believe whatever the hell you wanna believe. All I believe is what I saw.

LETECIA STAUCH: That's what you've -

ALBERT STAUCH: All I believe is what I saw - blood on the floor in my son's room and my son is missing, ok? That's the two things I know. Gannon was hurt in my house.

LETECIA STAUCH: I don't know! How many times do I have to say this to you? I don't know!

ALBERT STAUCH: You don't know how he got hurt. Ok.

LETECIA STAUCH: You asked me fifteen times the same exact question and I'm given you the same exact answer I don't know, then you tried to turn it and you tried to ask me another way and then you tried to turn around and you try to change up nights and sleep like you really care and then you come back and ask me the same question again and I've given you the same answer. If you're so concerned about -

ALBERT STAUCH: But you had no, stop no 'cause you haven;t given me the same answer it's been a different story every time.

LETECIA STAUCH: [inaudible] to go find him and see what he did to Gannon. You are too busy worrying about something that you think you can solve.

ALBERT STAUCH: I'm still waiting on the address, you were supposed to give me the address! You were supposed to give me the address from your lawyer's people!

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Yes. 'Cause you said they had it.

LETECIA STAUCH: [inaudible] FBI friends

ALBERT STAUCH: Now you're changing your story, you're changing your story, you called the police, not me. I wasn't there. I'll take the blame for not being there, for not protecting you - you called the police. Why did you call the police?

LETECIA STAUCH: I am.

ALBERT STAUCH: Actually no stop right there, you called the police and told them that he ran away, not that Quincy Brown took him, what the fuck Tecia? Answer that for me. You know without a shadow of a doubt Quincy Brown and I believe you. Quincy Brown has my son. This motherfucker from somewhere up north of here, ok, but you called the police and said he ran

away. Don't tell me you were freaking out, ok, no. Don't give me some bullshit story, Tecia. Tell me the goddamn truth right now.

LETECIA STAUCH: [inaudible] if you're not gonna listen to my answer then why are you talking.

ALBERT STAUCH: I'm listening. This is it. This is the line in the sand. Quincy Brown got my son and you told the police he ran away and there's blood in his room.

LETECIA STAUCH: [inaudible] I'm I'm guilty why would I call the police?

AL: I said Quincy Brown was guilty, I didn't say you. I said Quincy Brown, why are you talking about yourself? Why did you just say if you were guilty? You told me you weren't the whole time, why'd you say if you were guilty? You said Quincy Brown and I said Quincy Brown you keep bringing it back to you, not me, there's -

LETECIA STAUCH: You are implying -

ALBERT STAUCH: No, I said there's blood in the room, Quincy Brown took him, you called the police and said he ran away. Explain all those things to me right now.

[LONG SILENCE]

LETECIA STAUCH: Albert. If you calm down I'ma answer your questions.

ALBERT STAUCH: Oh, I'm calm, I'm as calm as I can be.

LETECIA STAUCH: [inaudible] calmer.

ALBERT STAUCH: I'm as calm as I can be.

LETECIA STAUCH: Because I'm not stupid. Yeah.

ALBERT STAUCH: I'm not stupid either, you fucking lied to me and you fucking lied to the police, I'm not stupid either so you better get right.

LETECIA STAUCH: I told the police when I got there what happened.

ALBERT STAUCH: Man you told them he ran away and the whole neighborhood was looking for a runaway for days and days and days, you're lying. You are now lying and I'm calling you out, you're lying.

LETECIA STAUCH: That is not true. That is not what happened. When they interviewed me I told them exactly what happened.

ALBERT STAUCH: I don't give a fuck what you said, you told me he was a runaway so I called and called and I cursed the lady out on the recorded line told her to get there for my runaway son, ok, you never once told me Quincy Brown had the boy and there was blood in his room so you better get it straight right now.

LETECIA STAUCH: When you stop yelling at me.

ALBERT STAUCH: When you start telling the truth, tell the truth and I'll stop getting upset. You're lying!

LETECIA STAUCH: I told you the truth!

ALBERT STAUCH: You are lyin' Tecia.

LETECIA STAUCH: [inaudible] you call me back.

ALBERT STAUCH: Go ahead and hang up, you call me back when you got the truth, you're fuckin' lying.

[long silence]

LETECIA STAUCH: Are you done yelling and cursing at me?

ALBERT STAUCH: I'm done, go ahead.

LETECIA STAUCH: So, for a second, for a minute, I need you to just breathe, ok? 'Cause you're yelling at me and I can't even answer a question when you're screaming and every time I try to open my mouth you're screaming and yelling at me.

ALBERT STAUCH: Every time there's a lie, I'm gonna call you out so let's go, let's so who -

LETECIA STAUCH: There's nothing for there to be a lie!

ALBERT STAUCH: Okay, I'm just gonna warn you, I'm firing a warning shot right now. You lie, I'ma tell you you're lying. Go ahead.

LETECIA STAUCH: I haven't even said nothing and you're still running your yap. You're still running your yap.

ALBERT STAUCH: Alright, I'm shutting my yap, go ahead.

LETECIA STAUCH: Still running your yap. [silence] If there was blood in Gannon's room that would have been already from when he cut his foot, I've already told you that. Okay? I told you that his arm from him getting burned was bleeding some and so was his foot, I've already told you that.

ALBERT STAUCH: Ok, you're lying, you're lying, stop. That's a lie. Change it again because that's a lie. Here's the game we're gonna play. Every time you lie, I'm gonna call you out. You can't bleed that much from a burn. You can't bleed that much from a burn. You can't bleed that much from a cut on your foot from a 2x4. I'm not stupid. You're lying. Go ahead, change it again, you're lying.

LETECIA STAUCH: [inaudible] you said a plate size.

ALBERT STAUCH: A plate, a dinner plate, that's what seeped through, Tecia. That means there was a puddle of blood on the damn carpet to seep through the carpet, an inch of carpet pad, and onto the concrete pad where it looked like it had been sittin' there for days, ok, that's what I saw, so tell the fuckin' truth.

LETECIA STAUCH: [inaudible] maybe you should ask the people who were there living because I never was there with you that contaminated the crime scene, maybe you should ask them.

ALBERT STAUCH: Tecia, guess what. Guess what.

LETECIA STAUCH: [inaudible] fuckin' asses on the contamination.

ALBERT STAUCH: Alright, good.

LETECIA STAUCH: Who did that? Who did it?

ALBERT STAUCH: Guess what, guess what. You just tellin' on yourself now. You're worried about a damn loophole, you're trying to find a loophole, ok.

LETECIA STAUCH: Who contaminated it?

ALBERT STAUCH: Okay, there's another loophole, alright there's another loophole.

LETECIA STAUCH: [inaudible] contaminated.

ALBERT STAUCH: Okay, there's three loopholes there already.

LETECIA STAUCH: [inaudible] contaminated [inaudible] sound funny to me that they left from Texas with a child missing, maybe they contaminated it.

ALBERT STAUCH: Alright, alright that's fine, so that's -

LETECIA STAUCH: [inaudible] when I'm talking -

ALBERT STAUCH: Landen, Landen, Veronica, and me, that's four loopholes right there, alright, I'm waiting. I'm waiting on you to quit lying. You just told on, hey between me and you, you just told on yourself 'cause you just said they contaminated a crime scene is what you said.

LETECIA STAUCH: NO! I said you, y'all contaminated meaning y'all put it in there then.

ALBERT STAUCH: Oh, we put it in there.

LETECIA STAUCH: [inaudible] say about that do you? Do you?

ALBERT STAUCH: See, here you go, here you go with the spin game oh you were.

LETECIA STAUCH: Maybe your brother did.

ALBERT STAUCH: You were on the cut foot and the burnt arm, now it's a spin game, ok, alright keep going with your spin.

LETECIA STAUCH: You're the one who said you know the answer, so I mean shit if you know the fucking answer why am I [inaudible] back to you but the bullshit you said to me.

ALBERT STAUCH: Yeah, that's frickin', I know what the answer is, frickin' Gannon's blood! It's Gannon's blood from a head injury! Now how did he get a head injury? How did he get a head injury over there in the corner? I mean you frickin' told on yourself saying you pushed the beds together. You pushed the beds together, we've never pushed the beds together, you're lying.

LETECIA STAUCH: [inaudible] Let me tell you something, Albert, if you went in somewhere where there was blood and you were allowed to walk in there, maybe you did it.

ALBERT STAUCH: Oh, maybe I did it huh.

LETECIA STAUCH: You shouldn't have been allowed anywhere to see this.

ALBERT STAUCH: Wait a minute, wait a minute.

LETECIA STAUCH: You just said you walked in somewhere to see it, did you do it!? Did you do it? If that was the case what you're telling me you shouldn't have even been allowed in there!

ALBERT STAUCH: Oh, oh, oh, oh, oh, oh, oh, oh, ohhhh. I was in Oklahoma, that's what I got to say. That's my loophole. Okay. You wanna try to pin it on me, go ahead.

LETECIA STAUCH: You walked in there the other day.

ALBERT STAUCH: Yeah, I walked in there and saw it after, you told on yourself cause you - hey -

LETECIA STAUCH: Maybe you put it in there because you know why?

ALBERT STAUCH: Alright, alright, listen let's calm down. Let's calm down. Let's calm down. Let's calm down, ok.

LETECIA STAUCH: [inaudible] you walk in supposed time [inaudible]

ALBERT STAUCH: Listen, let's calm down.

LETECIA STAUCH: Did you walk [inaudible] maybe you walked in the room huh?

ALBERT STAUCH: What do you think is gonna happen.

LETECIA STAUCH: [inaudible] Veronica was in there too.

ALBERT STAUCH: What do you think is gonna happen when they solve this crime? OK? What do you think?

LETECIA STAUCH: Landen and Veronica walked in there too, huh?

ALBERT STAUCH: What do you think, I don't know who.

LETECIA STAUCH: [inaudible] and accuse me of [inaudible] you said you went somewhere [inaudible] did she do it?

ALBERT STAUCH: Just tell, hey -

LETECIA STAUCH: [inaudible] if this was a crime scene y'all were fucking allowed to be in there.

ALBERT STAUCH: Tecia, ok.

LETECIA STAUCH: You're telling me, you tell me better than this 'cause I know you're pretty smart. Tell me better than this. So you admitted to me that you were allowed to walk into a crime scene?

ALBERT STAUCH: No, I said I saw it. Don't twist my words, I saw it.

LETECIA STAUCH: Who, who else went in a crime scene [inaudible]

ALBERT STAUCH: I, ok, you wanna, hey, you.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: You wanna know who else walked in there? You.

LETECIA STAUCH: Yeah.

ALBERT STAUCH: Gannon with a head injury, Quincy Brown, and a puddle of blood walked in there. That's who walked in there so what do you think is gonna happen when they find that boy and put all these pieces together, ok. What do you think? What do you think?

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: What do you think is gonna happen?

LETECIA STAUCH: If that's what you think.

ALBERT STAUCH: You can say whatever you want, you can say whatever you want, ok maybe this was a freaking accident, maybe we can fix it, ok. But the, the truth, the truth don't, the truth don't lie.

LETECIA STAUCH: [inaudible] accuse me, ACCUSE ME, [inaudible]

ALBERT STAUCH: I didn't accuse you, I accused Quincy Brown and maybe there's a story, a part of this that's an accident.

LETECIA STAUCH: There was no head injury to Gannon Jacob Stauch I don't know about it or I didn't do it.

ALBERT STAUCH: Why is it an or? Why is it an or? OK, that's why I don't trust you.

LETECIA STAUCH: I didn't do it!

ALBERT STAUCH: No, you didn't say and, you said or -

LETECIA STAUCH: [inaudible] do this to me?

ALBERT STAUCH: Listen, listen, all of this stuff doesn't matter because by the time I saw a puddle of blood on the floor, Gannon was already gone. He was already walking slugging to the truck, okay, and God knows where he is if he's even alive and that's what matters, ok.

LETECIA STAUCH: Walking sluggish to the truck?

ALBERT STAUCH: Yeah, absolutely. Absolutely. I'm sure he was. Why did you, anyways.

LETECIA STAUCH: [inaudible] To the truck, really?

ALBERT STAUCH: Why would he be walking sluggish to the truck? He never does that when he has a tummy.

LETECIA STAUCH: Sluggish. How can you determine sluggish from a video?

ALBERT STAUCH: The same way you can determine a shadow's somebody getting out of a truck, ok, the same bullshit, ok.

LETECIA STAUCH: [inaudible] any different than walking!

ALBERT STAUCH: Look, you claim, a shadow you claim a shadow means Gannon got out the truck, we never saw him. We saw him walking to the truck, we saw him walking to the truck.

LETECIA STAUCH: [inaudible] Quincy Brown [inaudible]

ALBERT STAUCH: I was walking sluggish when I cut my finger. Gannon was walking sluggish after he had a significant head wound with a puddle of blood on the floor.

LETECIA STAUCH: I've never seen Gannon walk sluggish.

ALBERT STAUCH: Ok, I'm telling you. I'm telling you he was walking sluggish 'cause he was hurt and there was a puddle of blood on the floor and it's probably his blood. I haven't seen no frickin' evidence but I guarantee you it's his blood because it all adds up, Tecia and he was walking sluggish 'cause of that. Just like I was walking sluggish when I cut my finger off, you hit the nail on the head honey.

LETECIA STAUCH: I don't even understand like you're talking, see this is what's not making any sense. You're trying to say that he got hurt before [inaudible] I don't even know that he got hurt [inaudible]

ALBERT STAUCH: Oh, I'm glad you caught yourself.

LETECIA STAUCH: [inaudible] video so you're saying he got hurt Monday morning?

ALBERT STAUCH: I'm glad you caught yourself. Yep, I'm glad you caught yourself though. Hey, listen, let's stop ok 'cause this is going nowhere. We can fix this. No! I want Gannon. I don't want you in trouble, I'm blaming Quincy Brown ok, I'm blaming frickin' Quincy Brown, I want my son.

LETECIA STAUCH: [inaudible] tell me how, how we were supposed to be back the way in our American dream and you started screaming at [inaudible] in the middle of the [inaudible]

ALBERT STAUCH: Because of my son! It's my son's blood all over the frickin' blood, ok. My son's blood. If it was Harley's blood you'd be screaming, too. You're screaming and it's not even your son.

LETECIA STAUCH: You saw this blood and it's Gannon's.

ALBERT STAUCH: I'm assuming, who else's blood would be on the floor?

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Ok good, yeah you got me, I'm assuming. I'm making a serious, legitimate assumption putting all the pieces together that it's my son's blood. Is Laina cut up? Are you cut up? Is Harley cut up? No, Gannon's the only one and we don't know so yes I'm assuming. I'm not cut up, I wasn't even there.

LETECIA STAUCH: I'm gonna tell you this Albert.

ALBERT STAUCH: You can tell me whatever you want to, we, now is the time when we fix this. Right now, ok?

LETECIA STAUCH: Ok, and I'm telling you right now, you [inaudible] listen. Instead of yelling back at me.

ALBERT STAUCH: Alright.

LETECIA STAUCH: Gannon Stauch was not sluggish other than if his stomach might have been hurt and his foot there was nothing wrong with Gannon on Monday morning, he had his Switch, he was playing his Switch and there was nothing wrong with him.

ALBERT STAUCH: Okay fine.

LETECIA STAUCH: Maybe he was a little tired because the boy stayed up late at night with his stomach hurting which I messaged you about.

ALBERT STAUCH: Okay fine.

LETECIA STAUCH: Maybe he was a little tired for that part of it but you can't assume that someone's sluggish and hurt on Monday morning. That is not true ok. Gannon was under my care and was fine. If he'd been sluggish and hurt getting in your truck there would've been blood in your truck! [inaudible] all online talking about he was looking like he was drugged. Really? Gannon drugged. I mean, he only takes his medicine, one, his stomach was hurting he had a lot of miralax in his system trying to clean him out.

ALBERT STAUCH: So, you did give him, wait wait I wanna stop you cause you said you didn't give him anything and you say you did him something. This whole time you didn't give him anything.

LETECIA STAUCH: No, you're a fucking liar because I told you I gave it to him on Saturday night.

ALBERT STAUCH: Ok, I don't remember that but now you say you basically say you goked him up on miralax.

LETECIA STAUCH: I already told you this so don't try to correct me and tell me I'm lying when I know for a fact. He was probably very tired! If you go back and look at your phone I messaged you up until 3 or 4 AM in the morning 'cause we didn't sleep. I'm sure Laina went to school completely exhausted so if he walked out maybe a little bit tired, and you saw that, then blame me because you know why? We didn't go to sleep.

ALBERT STAUCH: So now he is tired and sluggish and a minute ago he's not tired and sluggish.

LETECIA STAUCH: I said if you think that then that's why.

ALBERT STAUCH: Ok, alright, I'm just trying to clarify 'cause you say he wasn't and now he is, ok.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I can't hear you, I can't hear you.

LETECIA STAUCH: I said, if he would've had a head injury that you're talking about, ok, he would have blood in your truck, ok. He would have there would have had to have been something done to him supposed head injury you're talking about [inaudible]

ALBERT STAUCH: I agree with you.

LETECIA STAUCH: [inaudible] Ok? There would have been blood all over your truck, ok, that's just how it would've been if, I understand as a father you are freaked out ok I understand at this point you're gonna curse at the world because you're without your child. I understand that. When I thought Harley was lost on that freakin' cruise boat ? I understand what you're saying when it comes to attack mode, protect mode, attack mode, ok. But you wanna know how do we get back to that, then you have to believe that when Gannon Stauch left that house that day he was not in any shape or form had been bleeding hurt nothing other than him hurting his foot, ok, his stomach hurting and you know what, I was going to leave him at home.

ALBERT STAUCH: Wait, what about the burns?

LETECIA STAUCH: You already knew this.

ALBERT STAUCH: Ok, you said, you said, I'm just clarifying 'cause you said in any way shape or form and he had burns on his arms, ok. This is my baby boy now we're talking about.

LETECIA STAUCH: You said his head, I'm trying to clarify.

ALBERT STAUCH: Alright, so I got you. He didn't leave the house, no no he didn't leave the house with a head injury alright, so did you bring him back and then he got a head injury or did you bring him back with a head injury ok then he ran away with a - did he run away or did Quincy Brown take him with a head injury? OK? What version of that is the truth because the boy was bleeding in the house so how, where did the blood come from?

LETECIA STAUCH: Albert, I'll tell you once again.

ALBERT STAUCH: Alright.

LETECIA STAUCH: You can say all you want to with the assumptions that you have, ok. Gannon had already been bleeding from his foot, ok. I already cleaned it up outside.

ALBERT STAUCH: Did he bleed in that corner of the room? OK. I'm sorry, I'm sorry.

LETECIA STAUCH: Can I talk!?

ALBERT STAUCH: OK, go ahead.

LETECIA STAUCH: He'd already been bleeding from his foot. We then at that point in time fixed the room. The only reason I put the room, cleaned it up or whatever was because later on I did that before you got there.

ALBERT STAUCH: So you cleaned up the room before I got there, ok.

LETECIA STAUCH: [inaudible] listen to me! As far as putting, making the thing back up, fixing his Legos back right, I did that.

ALBERT STAUCH: Cleaning the wall right, that was part of the cleanup?

LETECIA STAUCH: Cleaning the wall? Gannon and I had already done that.

ALBERT STAUCH: Okay, okay, I'm just trying to put a timeline together.

LETECIA STAUCH: You're talking about cleaning something prior, like it was prior to what you're even talking about.

ALBERT STAUCH: Ok.

LETECIA STAUCH: You're not understanding.

ALBERT STAUCH: I'm trying to understand because you told me you cleaned up the rape scene in his room initially and now you know.

LETECIA STAUCH: Yes, my clothing and I've already told you that.

ALBERT STAUCH: Okay.

LETECIA STAUCH: Okay? I've already told you this. Albert -

ALBERT STAUCH: What about the corner where the blood was? Did you clean that up too? OK, was that part of the cleaning? That's fine if that was part of the rape cleanup but was that part of the cleanup?

LETECIA STAUCH: Now you're trying to [inaudible]

ALBERT STAUCH: No I'm trying to understand all of this you never told me the rape wasn't true and the banging your head wasn't true. You told me the bicycle wasn't true, you didn't tell me this part wasn't true, so did you clean up the corner too? Is that part of the cleanup? Because that's where the blood was, I mean if that all adds up to an accident to me and that Quincy Brown is responsible, ok, and that you just got scared and freaked out or was it your blood from when you banged your head? I mean what happened? How did that -

LETECIA STAUCH: I thought you were sure it was Gannon's blood.

ALBERT STAUCH: I'm trying to figure it out, I'm assuming it's his but if you banged your head that hard to pass out you probably were bleeding too, maybe you fell into the corner cause the beds were pushed together, I don't know alright, I'm just trying to understand and then you cleaned it up and that was part of the cleanup that you talked about. Just explain to me what's going on here.

LETECIA STAUCH: This is embarrassing to explain to you Albert. It's embarrassing.

ALBERT STAUCH: It shouldn't be embarrassing to me, babe.

LETECIA STAUCH: Don't call me babe cause you dont really want me as your babe. You're not trying to be loving to me.

ALBERT STAUCH: I'm trying to find out what happened to my son, all that, everything else is a, is part of the situation after we find Gannon, whatever we decide at that point.

LETECIA STAUCH: [inaudible] Gannon's blood!

ALBERT STAUCH: In the corner?

LETECIA STAUCH: Wherever it would have been in the room.

ALBERT STAUCH: Ok, keep going. I just, I'm gonna shut up 'cause this is freakin' me out.

LETECIA STAUCH: Don't even start with the whole freakin' me out like you care.

ALBERT STAUCH: I care, I don't want nobody to bleed what are you talking about? So you cleaned up your blood and Gannon's blood in the corner? Why didn't you tell me that?

LETECIA STAUCH: I did! You just said I told you about the cleaning part and whatever about it! [inaudible] it doesn't matter what I tell you, you think it's funny, you just wanna laugh at me, that's what you wanna do.

ALBERT STAUCH: I don't wanna laugh, I don't wanna, no. I wanna know where my son is and what happened. How did your blood get there and how did Gannon's blood get there?

LETECIA STAUCH: Listen to me.

ALBERT STAUCH: Ok, I'm listening.

LETECIA STAUCH: I already told, I've already told investigators that ok.

ALBERT STAUCH: Ok, alright, well tell me, 'cause I don't know.

LETECIA STAUCH: No no no no no no. If they let you in on this supposed crime scene that you shouldn't have even been on if it was a crime scene then they probably let you in on everything ok. Or they did things illegally. Whatever they did, my point is it's embarrassing to tell you that ok. Embarrassing! Ok? Because you know why? You're not gonna take my side so what does it matter?

ALBERT STAUCH: I am gonna take your side.

LETECIA STAUCH: [inaudible] side trying to put me on trial, have you been in the car to go find this dude? Or have you put me on trial?

ALBERT STAUCH: I - you told me you were getting the address or the phone number something from the attorney's assistant, okay.

LETECIA STAUCH: [inaudible] gonna do a whole report on it.

ALBERT STAUCH: Okay, so why can't I have the address and go there and -

LETECIA STAUCH: [inaudible] to be on the TV in a minute.

ALBERT STAUCH: So now I can't do anything because I gotta wait for the TV report? The breaking news story? When you have the information? Come on, come on.

LETECIA STAUCH: You don't gotta wait for the breaking news report you can [inaudible]

ALBERT STAUCH: Listen, back up.

LETECIA STAUCH: [inaudible] she's protecting you.

ALBERT STAUCH: No, all I know her's from a voice on the phone. Listen, what I want is what I told you I wanted initially. I want our 5 people in our family, two dogs.

LETECIA STAUCH: American dream.

ALBERT STAUCH: Christmas presents. Yes. that's what I want, ok, and if this was, I'm just talking about that's the last time we were all together, happy enjoying that I could think of.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I'm just talking about good times in our life.

LETECIA STAUCH: What'd you say?

ALBERT STAUCH: I said that's the last thing I could think of, presents.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: What?

LETECIA STAUCH: That starts with you. That starts with you! Saying, I want my wife and my daughter here and Laina here and we're gonna sit down and we're gonna all go find Gannon.

ALBERT STAUCH: Right and we can fix this that's - our family can fix this, all 5 of us. Maybe it was an accident, I don't know.

LETECIA STAUCH: [inaudible] of us.

ALBERT STAUCH: All five of us can fix this.

LETECIA STAUCH: [inaudible] talk to Laina, that's how sorry that shit was. Sorry! That's how sorry that shit was. You could've, you could right now fix this. You could right now say listen my wife, my child and my child, we're all gonna be in this one location, because our home has been taken over and we're gonna write it down if we have to wake up every morning and write down every detail as we are pursuing this person.

ALBERT STAUCH: Ok, and that's what I'm trying to do, that's what I'm doing with you. I'm writing down every detail, this adds up to an accident and Quincy Brown.

LETECIA STAUCH: It's not about.

ALBERT STAUCH: No, you said we can get together and write down every detail. We're on the phone together Tecia, we can write down these details.

LETECIA STAUCH: [inaudible] the only way you wanna do it right [inaudible]

ALBERT STAUCH: I offered you a meeting.

LETECIA STAUCH: A meeting?

ALBERT STAUCH: Yes.

LETECIA STAUCH: Ok, make up your mind, one minute you offered me a meeting, next minute you said how do we have our lives back.

ALBERT STAUCH: Alright, and I also told you it starts with the truth ok you still haven't told me.

LETECIA STAUCH: [inaudible] the truth!!

ALBERT STAUCH: Oh, yes ok. How did the blood get in the corner? Your blood and Gannon's blood, how did it get there? That's the truth that we need, ok, how did it get there?

LETECIA STAUCH: It doesn't matter what I tell you, you're gonna call me a liar.

ALBERT STAUCH: No just tell me what the truth is, it does matter.

LETECIA STAUCH: If I tell you you're gonna call me a liar!

ALBERT STAUCH: Tell me the truth and I won't call you a liar.

LETECIA STAUCH: I've already told you, you called me a liar. I could tell you that I freakin' [inaudible] him with a baseball bat and you would still be like "you're lying" [inaudible]. I already told you, I keep telling you that someone was trying to stick something in my asshole and Gannon's asshole and you would tell me I was telling a lie. You wouldn't care.

ALBERT STAUCH: Actually I would, if you told me the truth. I would absolutely care cause if you got hit with a baseball bat we wouldn't be talking right now, ok. So, that's why I just need the truth of how did the blood get there. Now we've established it's Gannon's blood.

LETECIA STAUCH: I just told you didn't I?

ALBERT STAUCH: Tell me again you didn't tell me, you said if I told you this or if I told you that, you didn't tell me anything.

LETECIA STAUCH: You are all over the place, if you're that blind to it then that's on you.

ALBERT STAUCH: So, somebody hit Gannon with a baseball bat and then molested both of y'all.

LETECIA STAUCH: No.

ALBERT STAUCH: So it's blood from his butt?

LETECIA STAUCH: No [inaudible] baseball bat like as an example how you wouldn't believe nothing I said.

ALBERT STAUCH: So somebody raped and molested both of y'all and that's blood from his butt is what you're telling me. And blood from your butt.

LETECIA STAUCH: [inaudible] anything because I'm not gonna relive it.

ALBERT STAUCH: Well, Gannon's out there hopefully reliving it every day. I hope he's out there living.

LETECIA STAUCH: I hope he's not because you know why?

ALBERT STAUCH: You hope that he's not living? You're hoping he's not living? I said I hope he's out there living.

LETECIA STAUCH: Reliving it every day, oh my god, do you see what you did?

ALBERT STAUCH: Yeah, I saw what I did. I took what you said.

LETECIA STAUCH: I said I hope he's not living it every day, like, as in living through someone hurting him, and you took that as me saying something different.

ALBERT STAUCH: But why are you so worried something did something to you and Gannon, this Quincy Brown guy, you're not gonna be in trouble. You're not gonna be in trouble but

you're talking about contaminated crime scenes but I'm not telling you you're gonna be in trouble, I don't even know! Ok, you're worried about all this stuff.

LETECIA STAUCH: See?

ALBERT STAUCH: Immunity - no, you're worried about immunity, you're worried about contaminated crime scenes but you didn't do anything!

LETECIA STAUCH: [inaudible] worried about that. I'm telling you, you didn't like that I came back with you when you said something like that, you didn't like that.

ALBERT STAUCH: No, you can come back with whatever you want, ok. It's not a competition, it's not a competition, actually it is a competition to find that boy.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: [inaudible] the constitution.

ALBERT STAUCH: What constitution? I can't hear you.

LETECIA STAUCH: [inaudible] against the law if someone's being [inaudible] crime scene not a person is allowed to be in there breathing, walking, everything [inaudible]

ALBERT STAUCH: But why are you worried about that? Why are you worried about that? You're not on trial here.

LETECIA STAUCH: You don't like when I come at you with the truth.

ALBERT STAUCH: No, You're not on trial here, the truth is how did the blood get there. Tell me, okay.

LETECIA STAUCH: Now you're asking me again.

ALBERT STAUCH: How did the blood get there? I'm not saying it's your fault, listen.

LETECIA STAUCH: [inaudible] fifteen times.

ALBERT STAUCH: Because you won't tell me so I want you to acknowledge for me that if what you're saying is true, I don't know the constitution like you do, okay, you went to law school and all that stuff right, so, if the police allowed somebody to go in there that's the police's fault! Okay, that's not my fault, that's not your fault.

LETECIA STAUCH: No no no no no no no. Do you ever let people talk and answer you?

ALBERT STAUCH: Yes.

LETECIA STAUCH: [inaudible] this is what I told you all the time you should've been a lawyer.

ALBERT STAUCH: Right, okay.

LETECIA STAUCH: You asked [inaudible] now I'm out here where I'm trying to tell him you would not let someone answer you for nothing, like, you would sit there at work and let people [inaudible] but you would talk shit to me.

ALBERT STAUCH: No, I'm not talking shit, I'm asking you for the truth.

LETECIA STAUCH: No, it doesn't even make any sense to me. You won't even, like, protect us at freaking Burger King but you'll talk shit to us.

ALBERT STAUCH: I'm not talking shit I want my family, I want my son. He was bleeding when he left the house you told me that.

LETECIA STAUCH: [inaudible] too [inaudible]

ALBERT STAUCH: You told me he was bleeding.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: You told me he was bleeding when he left the house, you just told me that there's blood all over the floor and he left with Quincy Brown.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: I didn't ask you that.

LETECIA STAUCH: [inaudible] I know that I'm getting messages. I know that I'm getting whatever saying something about money. I sent it to you, you didn't acknowledge that, did you?

ALBERT STAUCH: I did acknowledge that.

LETECIA STAUCH: Why are you attacking me?

ALBERT STAUCH: But if, you gotta understand -

LETECIA STAUCH: There's no blood!

ALBERT STAUCH: Okay, fine.

LETECIA STAUCH: If you believed 100% believed 100% that I did not hurt Gannon Stauch, you would not be interrogating me like you're a police officer.

ALBERT STAUCH: Ok, I'm not, but I'm gonna go over you exactly what I know from what you told me.

LETECIA STAUCH: I don't need you to go over -

ALBERT STAUCH: I'm going over it! You called 911, you reported a missing child ok, then when I got home when I got home, no, you called, let me rephrase that because you said he was a runaway. You said he left and the cameras prove he didn't.

LETECIA STAUCH: No, I didn't say that, the police did.

ALBERT STAUCH: You told me that he went to a friend's house, you told me that, ok, that he went to a friend's house and didn't come home alright you told me that.

LETECIA STAUCH: I thought he was hiding.

ALBERT STAUCH: Then you changed the story to the cops and to me -

LETECIA STAUCH: No.

ALBERT STAUCH: - and to everybody.

LETECIA STAUCH: I thought he was hiding.

ALBERT STAUCH: Ok. Fast forward and I saw blood now you've confirmed you also saw blood, ok [inaudible]. And then I ask you to tell me the truth over and over and over again and you don't. Then I even offer I can help you fix it, it could be an accident, Quincy Brown could be at fault. I could be at fault, ok, but you just keep going down this road and now, and how do you expect me -

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: How do you expect me not to blame myself because my sons's missing and nobody can find the truth and it's in my household? OK. How do you expect me -

LETECIA STAUCH: Do you want me to tell you like, what do you want me to tell you?

ALBERT STAUCH: Where the blood came from and how it got there, that's what I wanna know.

LETECIA STAUCH: I told you.

ALBERT STAUCH: You did not.

LETECIA STAUCH: I keep saying it fifteen times.

ALBERT STAUCH: You didn't say how it got there.

LETECIA STAUCH: [inaudible] bleed, come on.

ALBERT STAUCH: What? Say, what?

LETECIA STAUCH: If you get hurt you bleed.

ALBERT STAUCH: Okay, how, you got hurt?

LETECIA STAUCH: It's common sense!

ALBERT STAUCH: You got hurt? And you bled? And you and Gannon bled in the same puddle? It was one puddle not two, there was one puddle.

LETECIA STAUCH: No.

ALBERT STAUCH: So you sat back to back and bled together is that what happened?

LETECIA STAUCH: No, that's not what happened, that's where you go again about interrogating me.

ALBERT STAUCH: I'm not, I'm trying to put together what happened to my son and my wife so tell me where's the second puddle of blood if you were both hurt equally and you remember all of that now.

LETECIA STAUCH: Equally?

ALBERT STAUCH: Okay.

LETECIA STAUCH: I'm sitting back here as you try to put words in my mouth.

ALBERT STAUCH: I'm not, I'm trying to understand, I'm trying to understand. Well tell me what happened then, tell me where the blood came from! How it got there! Tell me!

[long silence]

LETECIA STAUCH: I can only go on what I heard.

ALBERT STAUCH: Okay, tell me what you heard then.

LETECIA STAUCH: I told you I am not [inaudible] you guys can stop trying to make me to be the criminal when I'm not.

ALBERT STAUCH: I'm not, I told you I'm taking blame for it. No, no let's clarify. I, let's clarify.

LETECIA STAUCH: You got mad and -

ALBERT STAUCH: Let's clarify.

LETECIA STAUCH: - to clear your name.

ALBERT STAUCH: Let's clarify.

LETECIA STAUCH: [inaudible] be stupid enough to clarify to you?

ALBERT STAUCH: 'Cause I'm not blaming you.

LETECIA STAUCH: [inaudible] that I'm clear [inaudible] I'm not a criminal! I did -

ALBERT STAUCH: You're right, you're not a criminal for hearing things, nobody is, what did you hear? What did you hear?

LETECIA STAUCH: Testify? [inaudible]

ALBERT STAUCH: Testify to your husband about your son. Our son is missing.

LETECIA STAUCH: Did you just say that? You won't even let you wife and daughter and your other daughter be with you right now.

ALBERT STAUCH: Because you won't tell me the truth.

LETECIA STAUCH: [inaudible] and you're worried about family?

ALBERT STAUCH: Just tell me what you heard, please.

LETECIA STAUCH: But you better believe Laina was with you but yeah Harley's supposed to be your daughter too, right.

ALBERT STAUCH: You took Harley, I want my family. You and Harley chose to leave and I never asked to leave ok. I wanted it the whole time.

LETECIA STAUCH: [inaudible] was trying to worry about you [inaudible] about her wanting to pay her car payment and you changed [inaudible] on her why?

ALBERT STAUCH: I had to do that because I'm responsible for it. Yes, okay, yes. But that doesn't matter right now you can make the car payment all you want to that doesn't matter right now, listen.

LETECIA STAUCH: But you want your family right?

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: I said you want your family?

ALBERT STAUCH: I do.

LETECIA STAUCH: You want your family? A 17 year old who worked her fuckin ass off to pay for the car?

ALBERT STAUCH: Okay, and I worked my ass off to be able to finance the car for her, okay, but you need to tell me what you heard because that -

LETECIA STAUCH: Well then you should've given her the option to get it back herself and finance it.

ALBERT STAUCH: She can get it back whenever they release it.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Alright, you said earlier listen -

LETECIA STAUCH: [inaudible] your family treated her in that situation.

ALBERT STAUCH: Yes, exactly, and a father, and don't tell me how a father is supposed to feel. You're talking about what you said is most important to you which is things, you said that. Items, ok. I'm talking about what's most important to me, what's most important to a father is his son. His, the most important thing to a father is his children. I want my son back and you have the information and you won't given to me, you won't tell me what you frickin' hear when he was bleeding to death.

LETECIA STAUCH: I said, you said the most important thing to you was your son.

ALBERT STAUCH: My son, my children. I said that. My children. My son is missing right now, my two daughters are not missing. My two daughters are not missing.

LETECIA STAUCH: [inaudible] should've talked to her and said listen -

ALBERT STAUCH: Laina is safe and sound, Harley is safe and sound.

LETECIA STAUCH: [inaudible] love and care [inaudible] put Laina to bed last night.

ALBERT STAUCH: Right. Where's Harley at?

LETECIA STAUCH: You wouldn't let us come.

ALBERT STAUCH: Exactly, thank you. Thank you. And Thank you. You won't tell me where she's at to protect her and keep her safe. She wouldn't tell me that. Tell me, tell me what you heart.

LETECIA STAUCH: Albert [inaudible]

ALBERT STAUCH: Listen, listen, you're worried about you now, you're worried about you.

This is about Gannon. Gannon's bleeding to death and you heard it.

LETECIA STAUCH: Gannon's missing and you [inaudible] something.

ALBERT STAUCH: No, Gannon's -

LETECIA STAUCH: [inaudible] the motherfucking FBI but you -

ALBERT STAUCH: I'm on the phone with you. You want togetherness, I'm giving you that.

You said Gannon's bleeding.

LETECIA STAUCH: [inaudible] FBI on the phone.

ALBERT STAUCH: You said Gannon's bleeding and you -

LETECIA STAUCH: [inaudible] make this a priority then, you want your family and you mean that and you're not trying to be [inaudible] throw me under the bus.

ALBERT STAUCH: Hey you wanna get the FBI on the phone and tell 'em what you heard? I'll call that lady right now. I'll call that lady right now and tell 'em you have the key piece of evidence. Amber, I'll call that Amber lady and tell her you have the key piece of evidence that they're missing.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: What?

LETECIA STAUCH: Call her on threeway.

ALBERT STAUCH: Call her on threeway? Alright, I gotta go to my message and look up the number or you can read the number to me, hold on.

LETECIA STAUCH: What did she say when you called her?

ALBERT STAUCH: What?

LETECIA STAUCH: What did she say when you called her?

ALBERT STAUCH: She said that you hadn't -

LETECIA STAUCH: [inaudible] over this so I'm just trying to understand why the FBI needs to call.

ALBERT STAUCH: I don't know okay, I am telling you she reached out to me and said I'm with the FBI, how can I help you? That's what she said. We're to the point now where the FBI is involved so somebody saying they can help me then they can help me and that's what I want so I reached back out to her. You didn't message her. You lied to me.

LETECIA STAUCH: Yes I did! [inaudible]

ALBERT STAUCH: Alright, I'm gonna add her into the call, you ready? And you better tell you what you goddamn heard Tecia about that boy bleeding to death. Alright I'm adding the call right now. Threeway is starting, don't go nowhere.

AMBER CRONAN: This is Amber.

ALBERT STAUCH: Amber, hey, this is Al again. I got Tecia on the other line, can I merge you in?

AMBER CRONAN: Sure.

ALBERT STAUCH: Tecia are you there? Tecia are you there? Tecia?

LETECIA STAUCH: Yes I'm here.

ALBERT STAUCH: Amber are you there?

AMBER CRONAN: I'm here, this is Amber.

ALBERT STAUCH: Okay Tecia, tell Amber whatever it is you got to say about what you heard when Gannon was bleeding to death because that's what you've been telling me.

LETECIA STAUCH: I did tell you, Quincy Brown was beating him up and hurting him. Can you hear me?

AMBER CRONAN: Yeah, did you say Quincy Brown was beating him up and hurting him?

LETECIA STAUCH: Yes, I've been telling everybody this for days.

AMBER CRONAN: Mmhm. So maybe uh you know because obviously I am FBI and not uh El Paso County, I'd like for you to kinda go through the story with me. I know it's awkward, I know it's weird. I know it's hard to talk to a stranger telling strangers things like this, but, uhm, I mean

every detail helps us that's why we try to ask you as many questions as we possibly can. So I'm sorry that you're gonna have to go through it.

LETECIA STAUCH: [inaudible] many times, talk to different people and no one has ever tried to help me so I haven't tried to not tell you anything [inaudible] there was three people that called.

AMBER CRONAN: Ok, well, and I'm sorry that you know here I am I'm another person uhm talking to you. If I'm making you relive something again and I know it's a very personal situation but I do wanna get as much information as I can from you because every detail does matter and it counts so I mean, I'd like you -

LETECIA STAUCH: Let me just call you back, 'cause - Can I call you back ' cause I don't have a phone so I'm gonna walk and get someone's phone [inaudible] credits off of wifi [inaudible] gonna be a long conversation.

AMBER CRONAN: Okay.

LETECIA STAUCH: Is it that same number that I text or that 719 number that he gave me?

AMBER CRONAN: Well 719 is a cell phone and I didn't receive any text messages.

LETECIA STAUCH: [inaudible] 'cause I'm on this like text app 'cause they took my phone, in a minute I'm gonna walk and grab another phone and call you right back okay.

AMBER CRONAN: Okay.
