LETECIA STAUCH: [inaudible] worded it too personally because like basically it was just saying you know if I know someone personally then that means [inaudible]

ALBERT STAUCH: So, I mean, I don't understand what you mean by that. You had them reworded or he reworded it?

LETECIA STAUCH: No, when you're in there talking to someone that was the question I said. You said those were the questions that you wanted. I said to you that I would have to say you know so then he worded it as do you know personally who's involved with your stepson's disappearance.

ALBERT STAUCH: Right.

LETECIA STAUCH: And I said no and I was telling the truth.

ALBERT STAUCH: So, what do you mean by that?

LETECIA STAUCH: Albert, there's nothing I mean by that. What I mean by that is I can come to y'all. I'm fully fine with you know, having an attorney, you know showing this to law enforcement, whatever. But at this point I'm just gonna show it, get it verified and [inaudible] not see it but hear it and that's what I - That's all I can do for now because anything else I've done I've been turned into being a horrible person so nothing else I can do can help 'cause I'm just not a valid source or person that anyone wants to help to hear about information, nothing. That's an improvement.

ALBERT STAUCH: What do you mean by that's an improvement. I thought you gave them information that they're using in the search.

LETECIA STAUCH: I did, however.

ALBERT STAUCH: So that makes you be valid if you gave them information and they're using that.

LETECIA STAUCH: No matter what information that I give them, they would not be searching places they are based on that information. Normal law enforcement agencies, like the little girl in South Carolina, they took those steps immediately. They shut off the neighborhood. They shut off any cross intersections. They even went as far 'cause it was an easy section of crossing over, they shut off a state like -

ALBERT STAUCH: Okay, but where did you say for them to look if they're not looking where you said?

LETECIA STAUCH: They don't care what I say Albert.

ALBERT STAUCH: I care.

LETECIA STAUCH: They wanna hang me.

ALBERT STAUCH: I care what you say 'cause I don't. I don't wanna hang anybody. I just want Gannon back. So I absolutely care what you said.

LETECIA STAUCH: It's been a hard, hard month for everybody right.

ALBERT STAUCH: Right, right.

LETECIA STAUCH: I mean this time last month we were getting ready to get off a cruise boat, having the time of our lives, right?

ALBERT STAUCH: Right but Tecia, yes, I know that. We were on a cruise and we had a good time but that, you completely skipped past my question like what did you say? Where did you say for them to look?

LETECIA STAUCH: They didn't ask me anywhere specific to look. I'm telling you that the law

enforcement in South Caroline took those approaches based on what was told to them.

ALBERT STAUCH: But what did you tell them? You're telling me what they didn't do, tell me what you did. I don't care about them.

LETECIA STAUCH: I already told them in the witness statement. I'm not gonna go through this again with you.

ALBERT STAUCH: You're not gonna tell me? The father of the child?

LETECIA STAUCH: You knew and it wasn't good enough for you.

ALBERT STAUCH: No I did not know, you've never told me.

LETECIA STAUCH: Oh my God.

ALBERT STAUCH: No.

LETECIA STAUCH: You told me nobody else was involved, you told me I was making up stuff so I'm not going down that route with you.

ALBERT STAUCH: No, I - I'm not talking about any of that. None of that matters, the other

person, none of that stuff matters now. I wanna know where you told them to look that they're

not looking.

LETECIA STAUCH: I never said I told them to look where they're not looking.

ALBERT STAUCH: But you said, yes you did you said you gave them information that you're not using.

LETECIA STAUCH: Albert, based upon my statement they would a took the same methods that the police department took in South Carolina in that situation. They would immediately step in

and shut off everywhere. They [inaudible] for one person and look where we're at. We're at

Wednesday February 19th. Wednesday February 19th.

ALBERT STAUCH: You're telling me, yes it's 23 days now, you're right. It's 23 days. Where

did you tell them? What information did you give them that they're not paying attention to like

in SC?

LETECIA STAUCH: That's not what I said. You know this.

ALBERT STAUCH: But that is exactly what you said. You said you gave them information,

they're barking up the wrong tree and they're not doing like they did in SC. That's exactly what you said.

LETECIA STAUCH: I said they're not [inaudible]

ALBERT STAUCH: But what does that mean?

LETECIA STAUCH: Day one! They should have shut the neighborhood down.

ALBERT STAUCH: Why?

LETECIA STAUCH: Day one!

ALBERT STAUCH: Why?

LETECIA STAUCH: Okay, see. Nevermind.

ALBERT STAUCH: No, but you're telling me what should have happened but not the

information.

LETECIA STAUCH: I've already given it to you and you haven't supported me. You've told everybody the complete opposite all that happened here? How you're sticking by Landen ? ALBERT STAUCH: I can't, I can't hear you. But, why should they have shut the neighborhood down? What's in the neighborhood that matters?

LETECIA STAUCH: Nothin'.

ALBERT STAUCH: Then why should they have shut it down?

LETECIA STAUCH: That's just the process that they should've done.

ALBERT STAUCH: What about all this stuff they keep finding and asking me about is from the

house?

LETECIA STAUCH: What stuff?

ALBERT STAUCH: Just all this random bullshit, I mean.

LETECIA STAUCH: I don't know. I mean, you keep saying, you keep saying that it's random

bullshit but you won't tell me.

ALBERT STAUCH: Yeah but you know what?

LETECIA STAUCH: Ask me a question, I'll tell you if I know what it is.

ALBERT STAUCH: How do I know somebody's not taping me right now? Yeah because I've

seen all these pictures and all these things that they're asking me is this Gannon's? Is this from

the house? If this gets out then I mean, we might never find Gannon.

LETECIA STAUCH: Albert, I never [inaudible]

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: People called my Facebook, this guy, they even got one of them, the FBI's got one person who did this already, and they're probably gonna get in trouble for obstruction but the lady that Amy Bolton has been talking to has already been on this and got one person doing it. They're gonna come after a lot more, so I haven't went and posted any of this stuff.

ALBERT STAUCH: Listen, I'll tell you one thing - I'll tell you one thing that I've seen that is almost absolutely from my house. Remember that board that I was making those foot, or those shoe, compartments out of?

LETECIA STAUCH: Board?

ALBERT STAUCH: Yeah, that particle board. That big sheets of it that I was gonna make that thing for Harley, for her shoes, remember? That I made the one and painted grey? You know what board I'm talking about? You know that big sheet of board? Like -

LETECIA STAUCH: [inaudible] board [inaudible]

ALBERT STAUCH: Yeah, yeah so they got a piece of that from the house they found somewhere.

LETECIA STAUCH: A piece of particle board? I mean, what does that mean?

ALBERT STAUCH: That, you - That's what I'm asking you what that means. Why a piece of

board from my house is found out in the middle of nowhere and I see a picture of it.

LETECIA STAUCH: In the middle of -

ALBERT STAUCH: And I see a picture of it, ok. I mean, they didn't tell me where they found it they just said, 'does this look like it's from your house? Does this look like it might be Gannon's' and I'm like, 'yeah it looks like it's from my house', I got all kinds of stuff like that at my house. LETECIA STAUCH: Albert, I haven't even been there so I don't know anything about any wood.

ALBERT STAUCH: Tecia, you know all the wood at the house, all that stuff.

LETECIA STAUCH: I understand. I know the wood but you guys ought to believe I didn't leave with any wood. Well there was wood in the back of the truck. There was a whole pile of wood in the back of the truck. Was there a big sheet of particle board back there like you're talking about? ALBERT STAUCH: No it wasn't a sheet it was a piece of it that they showed me a picture of. Just a piece.

LETECIA STAUCH: Then I mean, I don't know. I didn't get rid of any wood or any of your board or anything like that.

ALBERT STAUCH: Did you get rid of anything?

LETECIA STAUCH: No! I didn't get rid of anything. Nothing. If someone has took something from your house since you've been there, someone took it when all these people were there. I haven't even been there to touch board, nothing.

ALBERT STAUCH: So, ok, if you didn't take anything like that, board, wood anything and get rid of it in that area, why were you in that area?

LETECIA STAUCH: In what area?

ALBERT STAUCH: The area where the truck was seen at, the area where they're searching. I

mean. I'm guessing, assuming this picture that they showed me came from that area.

LETECIA STAUCH: That they're searching?

ALBERT STAUCH: Right. You told me about that bike accident or whatever? That area, that you went to and you told me you went to and you also told me you told them you went to - LETECIA STAUCH: You gotta say the roads and names of the areas, are you talking about County Line Road?

ALBERT STAUCH: Yes, County Line Road and wherever they're searching at. I don't know the exact areas.

LETECIA STAUCH: County Line Road.

ALBERT STAUCH: Yes, why were you there? What purpose do you have to go to PetCo and

then countyline road and then back to PetCo?

LETECIA STAUCH: 'Cause I was gonna go. Gannon was asking about the castles because

remember the time we went riding and there was castles and his grandma who had just left was

talking about the castles?

ALBERT STAUCH: Castles?

LETECIA STAUCH: Remember, like, we took the back road and she was with us one time and it was like these old little castles -

ALBERT STAUCH: No, grandma, my mom was never with us when we did that.

LETECIA STAUCH: Well you -

ALBERT STAUCH: Never.

LETECIA STAUCH: You said something about grandma would like these or something like that.

ALBERT STAUCH: Alright, okay.

LETECIA STAUCH: So that's what we were talking about. I said, I was taking that road 'cause you can take that road and drop off, because if you go back and look at the traffic cameras, [inaudible] drive was pretty busy so I took that road on that back road. I said something I was like, 'hey, remember we were driving through here one day' and he's like, 'oh yeah, about the castles' and I couldn't find the road with the castles.

ALBERT STAUCH: Okay, I mean. So you went to look at castles, then what?

LETECIA STAUCH: I drove up and was going to Castle Rock on that back road. I think it turns

into like, I don't know, what is that [inaudible] 45 or something and I couldn't figure out how to

get back to 25 from there which wasted a lot of my time.

ALBERT STAUCH: Why couldn't you figure out to get back to 25?

LETECIA STAUCH: I didn't know how to do that, I didn't know how to get to 25.

ALBERT STAUCH: You didn't have your GPS?

LETECIA STAUCH: I didn't have my phone.

ALBERT STAUCH: Right right. I forgot, I'm sorry.

LETECIA STAUCH: I had my watch.

ALBERT STAUCH: Okay.

LETECIA STAUCH: But the problem with getting it on my watch is [inaudible] you hardly can't cut the words into where you're going. It'll work if you do it on your phone.

ALBERT STAUCH: Right.

LETECIA STAUCH: [inaudible] should know this because my watch was with me. People making this big deal about freaking phone or not, the watch is gonna [inaudible] the same way a phone does so I wanna tell 'em get the fuck outta here, duh.

ALBERT STAUCH: Yeah. Right, right, you're right.

LETECIA STAUCH: I mean, and that's not, like, I'm not stupid. I'm not trying to be like, 'oh

[inaudible] my phone but I got a fucking watch with me,' I'm not stupid [inaudible].

ALBERT STAUCH: So, you just went out there to ride randomly to look at castles?

LETECIA STAUCH: No, that is not what I did. I was gonna go to Castle Rock real quick.

ALBERT STAUCH: Okay.

LETECIA STAUCH: I've already said that. So, if anybody put any kind of board or something

out there, whatever the hell it was, maybe it was somebody who was in the house, everything -

ALBERT STAUCH: So somebody was in the house and they took the board and took it out there where you were at? 'Cause -

LETECIA STAUCH: I said unless someone did that - I didn't take any boards, unless something fell off the truck.

ALBERT STAUCH: Ok. Why would something fall off the truck if it was all down in the truck?

LETECIA STAUCH: I'm just trying to say to you. I'm just saying to you. I mean, I don't know.

ALBERT STAUCH: So, did y'all make it to Castle Rock?

LETECIA STAUCH: No, I just told you that I didn't know how to get back to 25.

ALBERT STAUCH: Okay, but you had to at some point, right?

LETECIA STAUCH: At some point I did but I don't remember when because it's been freaking

how many weeks?

ALBERT STAUCH: Right, okay so, so.

LETECIA STAUCH: Listen, Albert.

ALBERT STAUCH: No, hold on, hold on. One more question.

LETECIA STAUCH: [inaudible] you're not gonna do that to me.

ALBERT STAUCH: You're right, I'm not. I just wanna know where Gannon got out the truck because.

LETECIA STAUCH: Where he got out the truck?

ALBERT STAUCH: Yeah, it's not at the house so don't say that so where did he get out the truck?

LETECIA STAUCH: Can I tell you something?

ALBERT STAUCH: Yeah, tell me.

LETECIA STAUCH: If you think Gannon got out of the truck, whatever you think of, then y'all are over there doing all the searches, keep searching, keep searching, keep searching, okay. Keep searching and understand you've done nothing but make it a witch hunt. You've been in all these areas.

ALBERT STAUCH: Okay, alright. You're right, you're right. So, you're saying he never got out the truck, so I need to call them back and tell them to look for him in the truck.

LETECIA STAUCH: That Gannon, what do you mean look for him in the truck?

ALBERT STAUCH: Well, you said he never got out the truck.

LETECIA STAUCH: Gannon was laying down playing the switch in the truck. So I mean, I

don't know what your question is. I haven't done anything to Gannon.

ALBERT STAUCH: Did Gannon throw out that board? Or how'd that, you say it may have flew out, did Gannon throw it out, you think?

LETECIA STAUCH: Albert, if there's a board or something, it coulda been. I don't remember to be honest.

ALBERT STAUCH: You don't remember how it got out of the truck?

LETECIA STAUCH: If there's a board, I mean, I don't know. Maybe it got thrown out. I don't know.

ALBERT STAUCH: Okay.

LETECIA STAUCH: I really don't remember. Well I don't remember but I don't understand what's a board got to do with anything?

ALBERT STAUCH: I don't know. I don't think they'd show me a board if it wasn't relevant. I don't know.

LETECIA STAUCH: You just said they showed you a board. Did this come from your house? So this is where I don't, you talk about - You don't, you don't [inaudible] I'm recording you, or listening or whatever, but then supposedly this is what blows my mind. This is what blows my mind. Ok. The police in the country, and departments do not call people and give them videos and give them evidence. They don't. Because if they do they know that stuff could be thrown out for that so I don't believe for a second that police are calling people telling them. I don't believe that unless they're just pictures(?)

ALBERT STAUCH: But how would police know if it's relevant or if it's my wood or Gannon's sock or whatever? They gotta ask questions.

LETECIA STAUCH: You're, okay. It was his socks, okay. Now there's socks being thrown out. ALBERT STAUCH: I mean, yeah so, I mean, how did the sock get thrown out? That's another question.

LETECIA STAUCH: Okay, well, I mean. How do you know it's Gannon's sock?

ALBERT STAUCH: I mean, socks are socks. I mean, you know, I don't know unless they got DNA off of it.

LETECIA STAUCH: Ok, then if they, then they should say to you this is Gannon's sock, 100% is his sock -

ALBERT STAUCH: What about maybe or maybe not I saw a picture of carpet from the house.

LETECIA STAUCH: Carpet?

ALBERT STAUCH: Yeah.

LETECIA STAUCH: You saw carpet?

ALBERT STAUCH: Yeah the same -

LETECIA STAUCH: You saw carpet?

ALBERT STAUCH: Maybe.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Maybe, yeah. I didn't see no - I saw a picture of it. I mean I didn't say it's

in the woods. I'm just saying maybe I saw a picture of the same carpet that's in the house.

LETECIA STAUCH: You saw the same carpet that's in the house in the woods?

ALBERT STAUCH: I didn't say in the woods. I said I saw a picture that looked maybe, maybe not is the carpet from out house.

LETECIA STAUCH: Okay, so what was it? Was it like a big piece of carpet? What?

ALBERT STAUCH: I mean, I don't know. I don't know, I mean come on I saw a picture of it. It

wasn't next to a ruler or anything, okay. I've seen 20 to 30 pictures, okay. I'm just, maybe even

more, I just remember... I mean, I remember a board. I feel like I may have seen but the carpet's

been all over the story anyways, so I mean it's - I, I could be puttin', like you said, what?

LETECIA STAUCH: You saw the carpet the police were taking out of the garage? Is that the

carpet you're talking about?

ALBERT STAUCH: I don't know, I, I -

LETECIA STAUCH: That's all the carpet that would've been taken out the garage that Gannon got blood on from his foot. And I already told you this.

ALBERT STAUCH: Oh and did he cut his foot on the wood or did he, your Facebook also said he cut his foot on a tool, I don't know.

LETECIA STAUCH: I don't know if it was a tool, wood, what. He was looking for that daggone thing that you have.

ALBERT STAUCH: What thing?

LETECIA STAUCH: The thing that has the little holes in it or whatever and you can like slice

stuff.

ALBERT STAUCH: You were looking for something to slice stuff? What do you mean by that?

LETECIA STAUCH: To cut the wooden stuff!

ALBERT STAUCH: Cut the wood with stuff with something that has holes in it. Say what?

LETECIA STAUCH: Ridges!

ALBERT STAUCH: Ridges. You talkin' bout to make the wood smooth?

LETECIA STAUCH: It has a handle on it. We were looking for that because we thought that

that, it has a little handle on it or whatever, you know what I'm talking about?

ALBERT STAUCH: I think so.

LETECIA STAUCH: [inaudible] 'cause you know the dogs need a piece of carpet, I mean a piece of wood on the side of the [inaudible].

ALBERT STAUCH: Yeah.

LETECIA STAUCH: I was just trying to shave that down so we were looking for that thing. ALBERT STAUCH: Oh yeah the little, like hand [inaudible] or whatever that you make the wood smooth with?

LETECIA STAUCH: The dogs [inaudible] the side in the kitchen so I was trying [inaudible] I asked him to email you where the tools were at we're both trying to figure out [inaudible] trying to get the [inaudible].

ALBERT STAUCH: Did you ever find it?

LETECIA STAUCH: The piece?

ALBERT STAUCH: The wood, I mean not the wood the uhm, the clean(?) the thing with the handle on it.

LETECIA STAUCH: No.

ALBERT STAUCH: But I thought you said that's what he cut his foot on.

LETECIA STAUCH: I did not. I said he was going to get that and stepped on something in there. I don't know what he stepped on [inaudible] he was helping me 'cause I was gonna get the [inaudible]. We were unloading stuff out of the car. I was gonna go sell stuff online. I've already said this. I was gonna sell the Yeti online 'cause I never use it, I was gonna finish selling [inaudible] clothes and stuff. I mean -

ALBERT STAUCH: So, did you, are you gonna send me the results of this poly or not?

LETECIA STAUCH: I'm not gonna send them to anyone I need you to meet with you to let you see them.

ALBERT STAUCH: You'll meet me to let me see them?

LETECIA STAUCH: I have to let you know so when I have this thing with the Nancy Grace people 'cause they're gonna verify the validity of it, they're gonna have all that ready so that the public can hear it. So, I tried to talk to you first about it, you didn't wanna talk to me, you didn't wanna say anything and then you whatever [inaudible] whatever I get it, angry, hurt, you got all

this going on. I get it, okay, so then I [inaudible] I'll do it this way. I will meet you and go from there. But then I get on the phone with you and now it's like sock and this and that and who

knows what.

ALBERT STAUCH: Right, now you know how I feel.

LETECIA STAUCH: There's all these things. Right? All these things. And it's like, okay well I

mean, what did I do? What did I do wrong?

ALBERT STAUCH: I didn't ever say you did anything wrong the only thing I've ever come to a

conclusion was that it was an accident but, but -

LETECIA STAUCH: All [inaudible] completely the other day.

ALBERT STAUCH: No I didn't. I asked you, I asked you -

LETECIA STAUCH: [inaudible] You guys you are still [inaudible] the wrong person still

[inaudible] and they're not gonna find me putting Gannon somewhere. Or what you guys think.

[inaudible] You're not gonna find that. 'Cause I didn't do that.

ALBERT STAUCH: Well what did you do? Hello?

LETECIA STAUCH: What?

ALBERT STAUCH: I mean if you didn't do that, what did you do? Or, I mean, who is the person that did something? That's the missing link here to Gannon.

LETECIA STAUCH: Y'all didn't wanna listen the first time.

ALBERT STAUCH: Listen, I'm all ears now. I'm sitting here at Starbucks making a fool of myself, okay.

LETECIA STAUCH: How are you making a fool of yourself?

ALBERT STAUCH: 'Cause I'm sitting here trying to hide in the corner so nobody's looking at me, ok, I'm listening now, tell me, what happened? What did you do or who has Gannon? I mean, if you love me like you say you; Il help me stop having to look at all these pictures and hear all these stories and watch the news every night, okay? That's love. LETECIA STAUCH: Love is also when I tell you and you listen instead of just being like 'oh yeah, that really happened.' ALBERT STAUCH: Okay, I'm listening right now. LETECIA STAUCH: No! ALBERT STAUCH: You got my attention right now. LETECIA STAUCH: - start cursing me out. ALBERT STAUCH: No I won't, not at Starbucks. I'm not doing this. LETECIA STAUCH: 95% of everybody that takes a lie detector test lies [inaudible] only people who are like schizophrenia and things like that have problems with it, okay. I get it. I clearly [inaudible] and again I know you said I haven't seen this but you're about to because Nancy Grace is having someone verify, so that it can be [inaudible] ok [inaudible] So [inaudible] it's coming, alright. She wouldn't even fuckin' mess with it if it was fuckin' bullshit, okay? So with that being said that questions were asked. Am I gonna tell the truth? Yes. I told the truth. Did I harm him in any physical way [inaudible] I told the truth. [inaudible] Did you inflict any harm on him in any way [inaudible] No. I told the truth. So.

ALBERT STAUCH: Did they ask you if this was an accident?

LETECIA STAUCH: Did you accidentally, that was the first thing I just said to you, hurt him in any physical way?

ALBERT STAUCH: Did they ask you did he accidentally hurt himself?

LETECIA STAUCH: No, 'cause they only give you a certain [inaudible] but then it was then you

gotta go into that and be like are you involved in your stepson's disappearance?

ALBERT STAUCH: Did they ask you was he injured?

LETECIA STAUCH: They - Albert.

ALBERT STAUCH: Not if you did it but was he injured, did they ask you that?

LETECIA STAUCH: Okay, so here's - This is why you're gonna always have a problem with everything.

ALBERT STAUCH: No, I'm just askin' questions 'cause you won't show me the results.

LETECIA STAUCH: I will show them to you. I've begged you. I begged you to meet me. I

begged you to spend one night with you wife and you refused to see everything. I begged you.

You're ignoring me like I'm a piece of crap!

ALBERT STAUCH: Listen, tell me now, I'm listening. Just tell me now. Just tell me everything. You're talking about Nancy Grace and lie detector test, all that doesn't matter to me ok, you came up with the idea for a lie detector test and I said yes, do it. But now you won't show me the results but you said it was for me.

LETECIA STAUCH: No.

ALBERT STAUCH: Okay, so listen, no, you did, you did you said it was for me.

LETECIA STAUCH: You won't let - I begged you! You lied to me and tell me you were gonna meet me and then I get dressed and everything and then you ignore my emails that night. You think it's not hard on me that I gotta know my husband is fucking another bitch? Do you think that's hard?

ALBERT STAUCH: You think it's not hard for a father to not know where his son is? I mean -LETECIA STAUCH: I know it's hard, but you didn't deny that one, did you? ALBERT STAUCH: There's no reason to deny it, it's just not true. I'm not playing that game but there is a truth here that you're ignoring that Gannon's missing and you have information and -I'm listening. I'm listening, you said you did.

LETECIA STAUCH: I've given it to you guys. I've given it to you!

ALBERT STAUCH: I'm sick of, listen, I'm sick and tired of being alone and a way for me to get past that is for me to get the information I need and I know you have and I'm listening and I'm not gonna judge you. I just want the information. I don't care what happens, ok, I want my son. I really don't care. If you're not, if you're not guilty of anything then you're not guilty of anything. I, I that's not what I'm worried about. I really don't care. I don't care who did what. I just want my son home with me, now. That's what matters to me. And I've even offered to help you, to stand by you if you just tell me.

LETECIA STAUCH: I didn't do it!

ALBERT STAUCH: I can't hear you. I didn't say you did it, I just said tell me the information. LETECIA STAUCH: And I told you that [inaudible] it's not that.

ALBERT STAUCH: It's not an accident and you didn't cover it up. So you didn't do anything and there's no accident so, what, I can't hear you.

LETECIA STAUCH: There's no accident that happened.

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: Albert -

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: [inaudible] hear me.

ALBERT STAUCH: I cannot hear you, I can hear you in the background.

LETECIA STAUCH: I said, can you hear me now?

ALBERT STAUCH: Yes, I can hear you now.

LETECIA STAUCH: I said, there's no accident. So you think, in your mind that I'm gonna tell you an accident happened and I panicked and didn't know what to do and just threw him on the side of the road.

ALBERT STAUCH: Okay, if that's not the case then, there are kind of two options here. Either something happened on accident or something happened on purpose, okay. Either he hurt himself or you hurt him. I mean, you kinda paint the picture for me here, either you killed him or it was an accident how he got hurt. I mean, those are the things that you gotta decide in how you approach this, okay.

LETECIA STAUCH: I didn't do either of those, do you see what I'm saying?

ALBERT STAUCH: The part that I'm saying, then fill in the blank, he obviously got hurt, you told me that. Okay, he got hurt somehow but you won't tell me anything else.

LETECIA STAUCH: Albert. I've already told you, this is what's gonna happen. Let me tell you again, but you know what you're gonna do? You're gonna tell me I'm a liar and that's a stupid fucked up story and we're back to blaming it on someone else again. That's what you're gonna tell me.

ALBERT STAUCH: No, listen, listen. I honestly, let me back up, let me start over. I really don't care if you tell me the truth or not. I'm past that point, I just wanna know how I can get Gannon home.

LETECIA STAUCH: How do I know how you can get Gannon home if someone else is

involved? How do I know that? This is where you - this is where you have a disconnect with me.

'ALBERT STAUCH: Tecia, you gotta understand.

LETECIA STAUCH: See, until you can stand there and you need to be [inaudible] you should be telling these investigators 'my wife would not do this. Listen to her.'

ALBERT STAUCH: I've told them that, okay, I've told them that. I've told them that, you're a

schoolteacher, you've been a babysitter. I mean, why would all these people trust you with their

kids and then you do something like this? But the problem, the disconnect is you know

something if not who and I don't really care who, okay? I just wanna know where Gannon's at

and how we can find him. So you can tell me any, you can throw out any random name, Johnny

Tremaine if you want to, whatever kinda name you want to, I just want it to point to where

Gannon's at. I mean -

LETECIA STAUCH: Okay.

ALBERT STAUCH: The truth is. Okay, go ahead sorry.

LETECIA STAUCH: What's the truth? What?

ALBERT STAUCH: The truth is so far beyond me right now. The only truth I care about is where Gannon is.

LETECIA STAUCH: Okay, I don't know where Gannon is. So no matter what I say to you, you're still gonna get the same answer again. I don't know where he is.

ALBERT STAUCH: Okay, so how do we get to who took him?

LETECIA STAUCH: Well, you know, we should've been doing this like three weeks ago.

ALBERT STAUCH: I've been a week now talking to you and you still won't tell me this.

LETECIA STAUCH: I've told you, Albert!

ALBERT STAUCH: I don't want, sorry.

LETECIA STAUCH: I told you I went that way, I was, I told the people I went that way. Me!

Innocent people don't tell people where they went! They just don't!

LETECIA STAUCH: Listen, just give me something, just give me a guess. Like I said, the only

truth that matters is bringing Gannon home and where he's at.

LETECIA STAUCH: Give you a guess, Albert?

ALBERT STAUCH: Yes, absolutely.

LETECIA STAUCH: Gannon is not in Colorado.

ALBERT STAUCH: Your guess is that he's not in Colorado.

LETECIA STAUCH: Correct.

ALBERT STAUCH: Okay, why? What makes you guess that?

LETECIA STAUCH: Because Tecia didn't hurt him.

ALBERT STAUCH: Okay.

LETECIA STAUCH: - didn't dispose of him.

ALBERT STAUCH: Okay.

LETECIA STAUCH: Anything like that, okay, so Tecia was in Colorado with nothing and you guys have ran up all these places where y'all think I've been or whatever. So, and you haven't

found Gannon! So where's the connection with those two together?

ALBERT STAUCH: So, if you had to guess, where would he be at? Like you said you guessed

he's not in Colorado. I don't disagree with that because they've looked and searched and not

found a damn thing other than some random pictures of some bullshit, ok. They haven't found

Gannon, so if you had to guess where he's at, where do you think he's at?

[long silence]

ALBERT STAUCH: Hello?

LETECIA STAUCH: Yes.

ALBERT STAUCH: Answer my question. If you, if you had to guess where he's at, and he's not in Colorado, or you guess he's not, where would you guess?

LETECIA STAUCH: Probably somewhere, I mean as scary as it sounds, probably not even in the United States.

ALBERT STAUCH: What makes you guess that?

LETECIA STAUCH: I dunno, that's my guess. I don't have a reason for my guess, that's why

it's a guess.

ALBERT STAUCH: I just don't, that doesn't make any sense, especially 'cause. No, no I'm not,

I'm talking to myself really, but if that's your guess then that's your guess. I mean, if you think

Landen took him to Mexico, or, 'cause you keep saying out of the United States, 'cause you keep

saying she's involved -

LETECIA STAUCH: That's perfect. I'm not gonna ever say anything [inaudible].

ALBERT STAUCH: No.

LETECIA STAUCH: [inaudible] not your wife, anymore.

ALBERT STAUCH: Okay, listen, she's not my wife. You're my wife, so I hope you're not

talking bad about yourself.

LETECIA STAUCH: Yeah.

ALBERT STAUCH: You can 'yeah' me all you want, that's the truth, I mean, I just, you guess that he's not in the United States but you keep saying she's involved, how would she get him out of the United States? Hello?

LETECIA STAUCH: I don't care what you're gonna tell me, until I'm blue in the face. She's A, in my opinion, she's involved and her deal went wrong and now she is losing her mind and wanting to do everything she can to keep the finger pointed at me. That is what I feel [inaudible]. Because she wanted to plan to get the kids back, for Gannon to come back. 'Oh, you're not keeping them safe by letting them stay at home.' That was probably gonna be the first thing, like, 'you had them home alone,' or whatever. That's exactly what happened. And I'm against the world trying to prove it because I don't even have my husband on my side for it.

ALBERT STAUCH: But I told you all along I'll work with you. Stand beside you. Yeah it is, it's

working together to find Gannon. That's the only thing that matters right here.

LETECIA STAUCH: When you work with her.

ALBERT STAUCH: Yeah.

LETECIA STAUCH: Aren't you staying in the same hotel with her?

ALBERT STAUCH: Nope.

LETECIA STAUCH: There are pictures [inaudible] She's all in 'em.

ALBERT STAUCH: Well good 'cause I've been with my daughter. To be able to put my

daughter to bed doesn't mean anything. I told you the whole time I was in a separate hotel room.

LETECIA STAUCH: [inaudible]

ALBERT STAUCH: Whatever, no. That's her daughter too so we split time and I don't have to justify myself to you about that. It's her daughter, it's my daughter and we're splitting time and

we're helping take care 'cause guess what. Guess what's going on with Laina. Her brother's missing, okay. Have you thought about that?

LETECIA STAUCH: Laina?

ALBERT STAUCH: Yeah. And Laina, Laina's brother's missing and she gave her statements

that said, 'I love you Bubba, I miss you, come home.' Okay, yeah, and it, I mean - I can go, I

can take that down a rabbit trail but I don't really wanna do that right now, 'cause I don't wanna

piss you off.

LETECIA STAUCH: Take it down a rabbit trail because you said that. Really? Why would you say that? Why would you [inaudible] a child down a rabbit trail?

ALBERT STAUCH: No, not what she said. What another child said about it but I don't even wanna go there 'cause I'm not trying to do that.

LETECIA STAUCH: And the, okay, don't do that. You know why? You're already, you picked, your biological children mean the most to you.

ALBERT STAUCH: So do yours.

LETECIA STAUCH: Obviously, that's just life, okay. That's just life, okay. So don't go beating

these kids up over this.

ALBERT STAUCH: Yeah, okay.

LETECIA STAUCH: I did not want Harley to stay there with you with Landen being there.

ALBERT STAUCH: Oh yeah?

LETECIA STAUCH: I did not. I would've, [inaudible] stay here at home, safe word(?),

everything.

ALBERT STAUCH: Yeah, okay.

LETECIA STAUCH: As long as I was able to know she was okay every day but I was not doing it with Laina.

ALBERT STAUCH: Okay. Like I said, that's a rabbit trail I don't wanna go on 'cause I don't wanna bring an innocent child into this, you know, like somebody else did, so.

LETECIA STAUCH: Well, that's the truth.

ALBERT STAUCH: There's a lot of truths involved in that that we're not gonna get into right

now but you know what. Something that's been bothering me from the day Gannon went

missing, okay, that text that you, that was sent to me from his phone what complete bullshit

LETECIA STAUCH: What text?

ALBERT STAUCH: The text he sent to be about bath salts and all this bullshit. It sounds like a great story to me but it's not Gannon, okay. Yeah, so my question is -

LETECIA STAUCH: Now you'll get Mike's theory, here comes Mike's theory, go ahead

ALBERT STAUCH: Mike's theory? What is Mike's theory? Let me hear it.

LETECIA STAUCH: Naw, Mike's theory is that I gave Gannon bath salts.

ALBERT STAUCH: No, I was never even going there. My question is that absolutely wasn't Gannon sending those texts. I know, okay. So my question is this, did you send them or did somebody, like, force you to send them or somebody else was involved and they sent them? Tell me about the bath salts because that's not Gannon.

LETECIA STAUCH: Okay.

ALBERT STAUCH: That's just not Gannon.

LETECIA STAUCH: I didn't send them either.

ALBERT STAUCH: Ok, so who did?

LETECIA STAUCH: I don't know.

ALBERT STAUCH: Did somebody force you to send them?

LETECIA STAUCH: I don't know, Albert.

ALBERT STAUCH: You just said you didn't send them and I asked did somebody force you to send them and you said you don't know.

LETECIA STAUCH: I, listen. You're not getting anything from me -

ALBERT STAUCH: Yeah.

LETECIA STAUCH: - until you are on my team.

ALBERT STAUCH: I'm trying to be but you're not working with me. This is not like every other situation in our marriage where it's like I give in 100% and then you give me a little bit here and there. Just like with the money, remember? I had to tell you how much I loved you, had to put your picture on Facebook for you to tell me about the money you took. Not Facebook, Instagram. Remember that 8 or 9 thousand dollars that you took but it's the same thing you're trying to do here.

LETECIA STAUCH: [inaudible] my picture on Facebook?

ALBERT STAUCH: No, instagram, instagram. I said Facebook but I meant Instagram. You're the only one, when you took the money remember it was like, 'oh, you don't love me, you're hiding me,' but the point is here you're trying to get me to go all into you without anything from you and that's just not how this works. Okay? It's just not how it works. So in this situation, it's not money, it's not clothes, it's not an item, it's a person. So that's the buy in. The buy in is the person. You give me what I need to find Gannon and you've got a little bit of buy in from me.

LETECIA STAUCH: I already took a lie detector test and you told me you still want nothing to do with me.

ALBERT STAUCH: No, you didn't. You told me you did but I haven't seen it. You'll show it to Nancy Grace but you won't show it to Al Stauch.

LETECIA STAUCH: [inaudible] to meet. You wouldn't.

ALBERT STAUCH: I've asked you to meet, I've asked you to show up. Hold on, hold on.

LETECIA STAUCH: Could you, like, at least spend time with your wife? That's what I said.

That's all I said. And if you went on this thing, 'cause like, you know that it bothers me

[inaudible] this is exactly how Landen wanted it.

ALBERT STAUCH: No, no, let me tell you. The buy in here is also that, look, look. The poly,

that's bullshit. You were never gonna do a poly. I set it up and my card never got charged.

LETECIA STAUCH: You told me you wouldn't give me the name so I scheduled my own.

ALBERT STAUCH: Okay, so now the story's changing, again.

LETECIA STAUCH: [inaudible] change, I paid \$500.

ALBERT STAUCH: Okay, send me the credit card receipt.

LETECIA STAUCH: [inaudible] did it.

ALBERT STAUCH: Show me the credit card receipt and show me that you did it.

LETECIA STAUCH: I will see, I will meet -

ALBERT STAUCH: Listen, Nancy Grace might believe it, but I don't believe it.

LETECIA STAUCH: Okay, fine then. Fine. If Nancy Grace don't believe it and her crew don't

verify it and see for herself and now you're saying she's a liar? Is she a liar? Is she a liar?

ALBERT STAUCH: I don't know nothing about no Nancy Grace I don't even know how that's even relevant, okay. LETECIA STAUCH: Okay here, I have it right here, I'ma send it to you. ALBERT STAUCH: Let me ask you this while you're sending that to me -LETECIA STAUCH: Huh. ALBERT STAUCH: Huh. LETECIA STAUCH: You want a future with me? LETECIA STAUCH: Yes.

ALBERT STAUCH: What is our future gonna look like without Gannon? Answer that for me and think before you give me some bullshit. Think long and hard about what our future looks like without Gannon.

[long silence]

LETECIA STAUCH: Hello? I don't have any involvement in Gannon and I feel like that I've proven it with the polygraph and answering the questions to try to get people on the right track of looking, [inaudible] the future, we'll be together and [inaudible] takes a lot of lot of help from Jesus Christ and praying that every single day, as hard as it may be, that it'll be one of those things where people come home, or whatever.

ALBERT STAUCH: You say come home? He's not a runaway. Somebody's got him is what you said.

LETECIA STAUCH: Meaning that [inaudible] people have done this and something happens they take them, they tie them up in basements and all this stuff, there are [inaudible] stories of this. There are -

ALBERT STAUCH: You're not convincing. I asked you what our future looks like without Gannon and you just went on some tangent about you didn't do anything.

LETECIA STAUCH: I said that we'd be supportive and we'd work together to keep every effort

in finding Gannon if it means we have to join organizations together to help other people find

their children while we're searching for Gannon. If it means that everything we do from

building stuff or setting up monuments or things like that for people to come and be like, 'hey

can you help like we have help.' That's our future.

ALBERT STAUCH: Okay, alright.

LETECIA STAUCH: - because that's a greater plan that God could have.

ALBERT STAUCH: Okay, so. Okay, so. Fair enough. So our together starts now, it doesn't start when Gannon doesn't come home, ok. Our together starts now so start with the bath salts. That was bullshit wasn't it?

LETECIA STAUCH: No.

ALBERT STAUCH: So, Gannon sent me the text with the bath salts.

LETECIA STAUCH: Okay, so.

ALBERT STAUCH: No, I want you to think. I want you to understand why I ask you that because we know the friend was bullshit because he didn't leave to go to a friend's house, okay, and the bath salts were directly involved with the friend. So if there is no friend there is no bath salts.

LETECIA STAUCH: There is, and here's why.

ALBERT STAUCH: So there is a friend or there is bath salts?

LETECIA STAUCH: Oh my.

ALBERT STAUCH: Okay, I'm sorry go ahead go ahead, I'm sorry. I'm listening, I'm sorry. LETECIA STAUCH: The bath salts were involved [inaudible]. When I talked to Gannon he clearly said that they had talked to him about bath salts at school like during that drug thing, right?

ALBERT STAUCH: The one that had been uh, weeks before he went missing? LETECIA STAUCH: Right. He said he already knew about bath salts during this time. He already knew. He knew what they could do, dangers, and things like that. However, someone did tell him that if they could bring bath salts 'cause it's part of the challenge that he would get to play with them. Gannon didn't want to do anything with bath salts. In fact, I even showed Gannon how bath salts can be good, meaning I said when you went and did your bath bomb if you put some bath salts in there it kind of helps you breathe a little, it helps you relax. Gannon didn't have any intentions to go eat or snort or whatever bath salts. Or at least not from my opinion, I don't think he did. I think he just sincerely wanted to play with whoever this was. ALBERT STAUCH: So, why, so this was, when did he ask him about this?

LETECIA STAUCH: About what?

ALBERT STAUCH: The bath salts. When did the thing come up with the friend because another thing about Gannon is he, you know, say the puberty class, as soon as he hears something he comes home typically that night and talks about it. So, he waited two, three days to talk about it? LETECIA STAUCH: ? Gannon talked about ?

ALBERT STAUCH: Him and what?

LETECIA STAUCH: [inaudible] talked about it.

ALBERT STAUCH: I can't hear you.

LETECIA STAUCH: He came in immediately and talked about how Friday, immediately.

ALBERT STAUCH: To you?

LETECIA STAUCH: When he came in.

ALBERT STAUCH: Okay, but... And you didn't mention it to me Friday?

LETECIA STAUCH: But he said when he was talking that they're not good for you.

ALBERT STAUCH: Right.

LETECIA STAUCH: Blah blah blah, there was no in - He didn't say anything like, 'hey, I'm about to go do bath salts.'

ALBERT STAUCH: Right, right. But you're, you're - Okay, you're a good mom. Why would a good mom not tell her husband, you know, the father of the child that day, 'hey Gannon asked

about bath salts? We probably need to address this,' 'cause you usually do that, so you -

LETECIA STAUCH: I didn't think about it.

ALBERT STAUCH: So you waited till he was missing to text me about bath salts?

LETECIA STAUCH: No! I sent you, what are you talking about? I sent you the - You sent me

the message about bath salts and I said to you yes he came in last night, go read your messages.

ALBERT STAUCH: Okay, but last night from that message, the message was Monday, okay. So,

you just said last night being Sunday and then a second ago you told me Friday, so.

LETECIA STAUCH: He came home Friday talking about it, yes.

ALBERT STAUCH: Okay, but you said he asked you Sunday, you just said he asked you Sunday.

LETECIA STAUCH: He asked me Sunday do we have any -

ALBERT STAUCH: Come on.

LETECIA STAUCH: Asking about it and having any are different.

ALBERT STAUCH: Come on, Tecia. Even - So. Friday he comes in and asks you about it, and they're bad, and we all know how he is about bad stuff, okay. He hates it, his mommy does bad stuff he thinks, Mike does bad stuff okay. So Friday he tells you, you guys have a conversation of bath salts and he still comes back Sunday and asks you if you have any?

LETECIA STAUCH: Yes, the bad stuff was not just bath salts it was in general.

ALBERT STAUCH: But you just said it was.

LETECIA STAUCH: He was telling me about the things that people who were talking about [inaudible] his class is a halfway decent class like good kids, like one of the moms, I know who she is, I could show you a picture. her son is in the opposite class that Gannon's in and he's just a nightmare, ok. So I guess on recess they're outside, they have conversations about this and all he was talking about is the people that were talking about bad things. That's it. He didn't have any, he didn't say to me hey I'm gonna whatever. I'm telling you someone peer pressured him that they could hang out and play. That's just the thing. Peer pressure. Gannon had no intentions of doing nothing but playing at somebody's house.

ALBERT STAUCH: Whose house?

LETECIA STAUCH: I've made that clear to you. I don't know.

ALBERT STAUCH: That's not like Gannon, that's not like Gannon either to not tell us. LETECIA STAUCH: Well, that is the truth okay, because you can sit here and say some things are not like Gannon but we've caught him doing certain things.

ALBERT STAUCH: Like what? When?

LETECIA STAUCH: We will catch children do some things and we have to be like - They can't always stay in our life, that's not like them. What we instilled in them and hope that they make the best decisions when crossed with these things, but the bath salts has completely nothing, nothing, to do with what Gannon was gonna do. Gannon was not gonna go do anything bad with bath salts.

ALBERT STAUCH: Well hey, listen, my battery's getting low, so, I just want you to know that if

my battery cuts off I'm not changing my thing here that together, one of the first things together

is you give me the polygraph results, ok.

LETECIA STAUCH: And I agreed [inaudible] meet you and then [inaudible].

ALBERT STAUCH: No, you send it to me and then I'll meet you.

LETECIA STAUCH: I am not sending it to you.

ALBERT STAUCH: Okay then we're not together. We're not together in this.

LETECIA STAUCH: I am not sending a copy.

ALBERT STAUCH: Tecia, I need you to send me a copy of the polygraph results or it's not clear

to me that we're together in this.... Cut my phone off
