### DUST CONTROL APPLICATION – 2024 SEASON

**Product Used:** Road saver DC

Customer (defined below) applies for dust control application to be performed by Advanced Situation Mitigation LLC (“Advanced”) and more particularly for Advanced to apply sealant in a 400-foot-long flagged area of county road on or adjoining the Customer’s (defined below) property in an amount subjectively determined appropriate by Advanced, at the cost for Customer below. The Customer agrees to the aforesaid and pricing below and further agrees to the following terms which are a condition to Advanced accepting Customer’s application and agreeing to perform the application.

- **Application and payment must be received or arranged in our office before April 29th.**
- Specific application dates are based on when \_\_\_\_\_ County (the “County”) has prepared the roads and authorized Advanced to begin spraying. Dates are subject to change and are impacted by weather. The first application occurs Mid-May through Mid-June. The second is approximately 60 days after the first application or when the county says we can apply.
- Applicant agrees to maintain flags to mark outer limits of the area to be treated. Flags must be in place April 28th until October 31st. Failure to do this could result in the area being bladed to which you expressly waive any claim against The County or Advanced for any damage resulting therefrom. If the area is not marked, drivers will either center on your house or use their best judgment for location.
- Advanced will use a walk behind roller device to layout property. If your flags are set longer than the footage paid for, your dust control will not reach both flags. If your flags are set shorter than the footage paid for, your dust control will extend past your flags.
- The county reserves the right to blade the treated area to maintain public safety. Your road will be bladed after October 1st.
- **Disclaimer of warranties.** There are no representations or warranties given by Advanced as to the dust control chemical used or Advanced’s application of it beyond the terms in this document. Advanced disclaims any implied warranty for the product used and Advanced’s application of it including warranties of fitness and merchantability, to which you agree. Advanced does not warrant the performance of the product due to factors such as weather, surface preparation, gravel materials, heavy traffic patterns and maintenance of the roadway.
- The customer acknowledges that in doing the application that Advanced is not an agent of the County and the County is in no way liable for damage caused by the actions or omissions of Advanced or the chemical Advanced applies.
- Payment is required with this application. Advanced will deposit the Customer’s check, card or cash once it is received.
- The terms herein cannot be amended except by a signed writing of Advanced amending these terms.
