APPROVAL OF MEETING MINUTES

The meeting minutes of November 2023 were presented for approval. A motion to accept the minutes with corrections was made by Eric Self, the motion seconded and the motion passed.

SECURITY REPORT

Jose Amstutz attended the meeting and presented a verbal report.

He discussed safety tips to residents & recommended the nonemergency number for residents to call 936-760-6800 to report nonemergency concerns. He also encouraged the residents to use the vacation watch option while away.

FINANCIAL REPORT

Treasurer Eric Self presented the Financial Reports as of February 29, 2024. He stated the operating account totals \$629,673.14; The total in reserves \$395,770.36; Expenses for the month of February 2024 were \$30,122.35.

NEW BUSINESS & SCHEDULED MAINTENANCE

- *The monument that was damaged from a wreck has been completed and the driver's insurance has reimbursed the community.
- *O'Neal & Holmes will prepare association taxes & audit.
- * A motion was made, seconded, and passed to accept the Lake Houston Lawn Care bid for landscape maintenance. The board voted to approve the contract with Lake Houston Lawn Care, by a vote of 3 to 1. The board is aware that director Pat Twohy is an employee of the company, however Pat Twohy does not have, and is not related to anyone that has, a financial interest in at least 51% of the profits of the company; as a result 209.0052 of the Texas Property Code does not apply to this contract. The board is aware of the perception of hiring a company that employs one of its directors, however, the board believes that approving the contract proposal and the vendor is

in the best interest of the Association and sees a benefit in having a direct contact with the vendor on the board. The board believes these benefits and the interest of the Association outweigh any perceived conflict.

- * A motion was made, seconded, and passed to accept KCPC bid for pool maintenance.
- * A motion was made, seconded, and passed to accept the bid for irrigation repairs. Earth Care will not get paid until the property is walked by President Twohy.
- * A motion was made, seconded, and approved to move account 329393 to the attorney for a deed restriction violation.
- *A motion was made to send account 329120 to the attorney for a deed restriction violation.
