- *One resident who attended the meeting had concerns regarding trespassing and fishing on the lakes. The Board explained that the lake is not owned by the community, but is property of the MUD and they will need to defer to the MUD to determine if No Trespassing signs can be installed.
- *One resident had concerns about the pool lifeguards and private parties being held during pool hours. Sterling Association Services will get in touch with the pool company to let them know that there are to be no pool parties during regular pool hours.

APPROVAL OF MEETING MINUTES

The meeting minutes of March 21, 2023 were presented for approval. A motion to accept the minutes was made by Kenn Munn, the motion was seconded and the motion passed.

SECURITY REPORT
