- Currently have United States Federal IRS 501(c)(3) approval status, and can provide a copy of such
- Only request monies for specific projects that have no federal or state funding
- Only request monies that directly impact women and children in need
- Operate in Allegheny, Beaver, Fayette, Greene, Washington or Westmoreland counties

Requests are reviewed by WOMEN of Southwestern PA, Inc. and their determination is final.

Applications must be RECEIVED by the Philanthropy Committee of WOMEN of Southwestern PA, Inc. between 3/15/2026 and 4/30/2026. Applications received outside of this timeframe cannot be considered.
