APPROVE / MODIFY LAST MEETING MINUTES

July Meeting Minutes were approved. Sue Wells motioned to approve and Adam Hearnsberger second the motion.

WHAT HAS BEEN HAPPENING AROUND THUNDERBIRD POINT - Bob McDonald

- TPOA member lodges complaint regarding new construction within the Water District's easement.
 - o Board reiterated that the TPOA does not override the Water District.
 - This particular resident did not have a permit from the Water District for his/her building.
- TPOA member admonished regarding loose dogs and possible pool party. Resident was reminded of the dog regulations and that only five people are allowed in the pool area per card holder. More discussion was made as the *Dog Situation Update* came up on the agenda.

- Update concerning pool fence. Board discussed purchasing a second self-closing gate
 with latch. Three estimates necessary for the purchase. Adam and Bob will discuss further
 and will bring more details to Board.
- Board discussed the retaining wall at the HOA boat ramp. May possibly need to be replaced

 suggested \$30,000 expense. Discussion on bringing a load of rocks for the time being.

 Denise will provide copy of the ramp survey for Board to review.

GROUND AND POOL MAINTENANCE REPORT- Craig Shafer

- Craig voiced some concern over sand in road. Board believes the sand was put there by the County and not a concern.
- Craig continues to have problems with the tires on HOA mower.
- Having pool problems with minors (under 14 years of age), climbing chain linked fence, breaking rings in pool that holds rope in pool.
- Pool was serviced on August 15 by Grigsby Pools. Report follows.
- Adam recommended a large metal sign be adhered to new fence with a few specific rules on it.
- Adam discussed the pool closure date tentatively set on or before October 1. Cover will
 go over the pool on or before October 18. Bathroom will be winterized typically in
 December.

DOG SITUATION UPDATE - Sue Wells

- This month there have been five official complaints.
 - One bite, no complaint sent to HOA. Resident went to the hospital in "Titus County" and the Camp County Sheriff's Department did not address the dog owner because the complaint was filed more than a week after the incident.
 - Sue sent four letters to dogs' owners.
- A complaint (form on website) must be filed with HOA before action can be taken.
 - 30-day action letter will be sent to owners of offending animal.
 - o 10-day letter to follow
 - If still no action by dog owner:
 - Fine issued, then;
 - File with Court.
