


DHR, Benefits Division Update

As a Fairfax County Government retiree and subscriber in a county-sponsored health plan, your first step should always be to contact the insurance carrier's customer service line if you have questions about your plan or concerns about a bill or claim. When contacting a vendor partner's customer service team, many issues, including denials related to timely filing, incomplete claim submissions, and contract and fee schedule disputes, may be quickly resolved through a real-time adjustment by providing requested or additional information. Contact information is available on the back of your insurance card or through our Retiree Benefits Page on the county's public website: Resources Retiree Benefits.

Understanding Dementia: Community Support and Resources

Dementia is a general term for a decline in mental ability severe enough to interfere with daily life. According to the Alzheimer's Association, approximately 7 million Americans are living with Alzheimer's disease, a common form of dementia, with numbers expected to rise to 12.7 million by 2050.

The Fairfax Area Agency on Aging, in the Department of Family Services (DFS), recognizes the importance of community support and offers resources. It's important to remember that these efforts alone are insufficient. Awareness and education, which are vital in fostering an inclusive environment for individuals, require the active participation of the community. Programs, such as free DFS family caregiver consultations, provide caregivers with information and referrals tailored to their situation. Additional programs, such as Caregiver webinars and the Dementia Caregiver series, aim to empower and enhance caregivers' overall health and effectiveness by assisting caregivers in managing their responsibilities.

In Fairfax, VA, the Dementia Friendly Fairfax initiative is a beacon of hope. Dementia Friendly Fairfax envisions a community where people with dementia and their care partners can engage in various activities, be supported in the highest quality of life, and live independently for as long as possible. The Dementia Friendly Fairfax initiative started through a partnership with Goodwin House, Insight Memory Care Center, the Fairfax Area Commission on Aging, and the Fairfax Area Agency on Aging. The Dementia Friendly Fairfax Action Team provides Dementia Friends Information Sessions to educate people about dementia and the most common type of dementia, share five key messages about dementia, and explain one approach to communicate with a person with dementia effectively. Participants in the session, known as Dementia Friends, are encouraged to turn that understanding into practical actions.

The annual cost-of-living adjustment (COLA) for FY 2026 has been announced at **2.4%.** This percentage is applied to your base benefit and any



accumulated COLAs from prior years. The new amount will be effective with your July 2025 benefit payment. If you have been retired for less than a year, your COLA will be prorated.

EXAMPLE, retired more than one year: 7/1/2025 COLA = 2.4%

The increase (\$51.67) will be added to the current COLA balance, bringing the COLA total from \$138.62 to \$190.29 beginning with the July benefit payment.
