Sign-in at the start area tent. Sign-in opens an hour before and closes 10 minutes before assigned start time. Failing to sign in for the road race stage may result in time or point penalties.

Center line rule (3B1) is in effect. Riders must remain inside the cones at all times. Failure to do so may result in penalties up to, and including, disqualification.


Feed Zone: The feed zone will only be available in the Women's Pro/1/2 and Men's Pro/1/2 races and is located about 200m west of the entrance into Naranja Park on the uphill. Feeding is prohibited on the first 4 laps and the last lap.



Parking: Enter rider parking at N. La Canada Dr. and Silverleaf Dr. Proceed east on Silverleaf to Copper Spring Trail, then south to the Copper Creek Elementary School parking lot. **No rider parking inside of Naranja Park**.

All riders should use the north entrance of the park only.

Rider Warm-Up Zone: The two south lanes of Tangerine Rd. are reserved for rider warm-ups. No vehicles will be permitted in the warm-up zone.
