Stage 2:

General Announcements:

Sign-in at the start area tent. Sign-in opens an hour before and closes 10 minutes before assigned start time. Failing to sign in for the road race stage may result in time or point penalties.

Center line rule (3B1) is in effect. Riders crossing the center line may be penalized and/or disqualified.

Finish line: riders will have full use of the road at 500m on their finishing lap. Any rider crossing the centerline before the 500m flag will be disqualified.

Water: Please be self sufficient. There is no water available at the venue. There are no neutral feeders in the feed zone. Please refer to the Tech Guide for Feed Zone instructions.

Wheel tags are attached to your race bibs. Please drop tagged spare wheels off to the wheel tent no less than 45 minutes before the start of your race.

Parking is on the north side of Continental Rd only. There is no overnight parking.

Driving directions: from I-19, take exit 63 and follow Continental Rd. to the venue (go past the performing arts center); do not take the Duval Mine Rd. exit from I-19 but keep going to exit 63.
