Columbia Basin Electric Cooperative (CBEC) is partnering with the Bonneville Power Administration (BPA) to offer cash rebates to install qualifying new irrigated agriculture system components including pressure regulators, nozzles, sprinklers, gaskets, and more.

**Easy Steps for Participation:**

- 1) Purchase and install the qualifying irrigation system components.
- 2) Complete, sign, and submit this Rebate Application, and the supporting receipt(s)/invoice(s) for any qualifying equipment. Receipt(s)/invoice(s) must list brand, model number, or other identifying information. Also submit a unique ID number or other method of identifying site of installed measures.
- 3) Mail complete rebate application and receipt(s)/invoice(s), within 90 days of purchase, to:

**3.0 General Information**

This irrigation program has been developed to encourage energy-efficient equipment and design in irrigation systems. It is an opportunity for irrigation consumers to receive a financial rebate and lower their electric bills.

These "deemed" measure rebates are designed to help cover a significant portion of the costs of repairing and replacing specific components that typically help the irrigation system use less energy.

Rebates are for the purchase of specified replacement parts and components for your existing irrigation system. The rebate varies by the sprinkler component or part incorporated in your sprinkler system. **The rebate shall not exceed 70% of the invoice amount for the measure, and shall not exceed the amount listed on the form.** Labor, if included, must be shown in the per measure cost.

**EXAMPLE:**

Your invoiced cost for all new flow-control nozzles is \$2 apiece and you purchased 64 nozzles (total invoiced cost = \$128.00)  
 -- Rebate for the nozzles is based on 70% of the invoiced cost since it is less than the rebate listed (rebate: \$128.00 x 70% = \$89.60)  
 Your invoiced cost for all new gaskets is \$3.00 apiece and you purchased 64 gaskets (total invoiced cost = \$192.00)  
 --Rebate for the gaskets is based on the rebate listed since it is less than 70% of the invoiced cost (rebate: \$2.75 x 64 = \$176.00)  
**TOTAL REBATE: \$89.60 + 176.00 = \$265.60**

**4.0 Application Agreement**

Upon signing this agreement, I certify and acknowledge the following:

- The system at the above designated location is served by Columbia Basin Electric Cooperative (CBEC)
- The system at the above designated location is used for the irrigation of agricultural crops or pasturage
- The equipment is installed on the system designated above and the system is operational
