



Arena Rental Form

Arena Event Rental: \$300.00 per day

Private use Hourly Rental: \$40.00 per hour up to four (4) hours.

Full day rentals will require a single \$150.00 damage deposit. A rodeo or any event with any type of stock will require a single \$300.00 damage deposit. Feeding stock in the arena is not permitted.

72 Hour Cancellation required for Arena Events to avoid forfeiture of deposit.

48 Hour Cancellation required for personal use rental to remain in good standing and not disrupt members use.

\$30 Tractor fee with a required tractor rake every 10 timed BRND events. Arena Maintenance to be provided by the 49er's arena director. Renters to provide equipment and staff to rake per every 5 timed events in accordance with BRND rules. Estimate based on pre-entries and final payment due following event.

A limited number of electrical hookups are available for \$15 each per night. Sign up is required at entry time.

Overnight parking is permitted at no cost for scheduled events.

Horse pens are available at \$10 per horse per day. Renter to clean stall after use.

Portable rest rooms: One unit is always on site.

Additional units: \$65.00 each per day

Properties must be cleaned and garbage disposed of properly to avoid a \$50 clean up fee from being deducted from the damage deposit.

The Cook Shack will open for all events scheduled 5 days in advance.

72 Hour Cancellation Policy – 72-hour notice prior to your rental agreement must be given to cancel your reservation. If notice is not given the \$150 damage deposit will not be refunded. Total Rental Fees are to be paid in advance, before the rental date. The damage deposit must be made to hold your rental date.
