

49er's Saddle Club Arena Rental Rates

Arena Rental \$300.00 per day.

Hourly Rental: \$40.00 per hour up to four (4) hours. 5+ hours = full day rental (arena only)

No stock may be fed in the arena. No stock is to be turned out in the pasture area. Members or non-members renting the arena will be responsible for the conditions of the arena.

Full day rentals require a single **\$150.00** damage deposit. A rodeo or any event with any type of stock require a single **\$300.00** damage deposit.

A limited number of electrical hookups are available for **\$15.00** each per night.

A limited number of horse pens are available at **\$15.00** per stall per day on a first come first serve basis. Water on sight All manure/feed must be removed by renter.

BRN4D races will require arena maintenance at the cost of **\$200.00** per day to maintain the integrity and safety of the arena. Maintenance will be provided by the 49er's Arena Director with a tractor drag for each 5 timed runs.

No cost elected services include:

Announcer's Stand with PA System Equipment is to be unaltered, and office cleaned.

49er Cook Shack will arrange concessions to be available at every scheduled event.

Portable restroom unit: We will provide the amenities and service.

Post event Cleanup Fee Cleanup is required to avoid loss of deposit. Arena must be free of debris and garbage hauled off or placed in the receptacle near exit.

48 Hour Cancellation Policy – 48 hours' notice prior to the date of your event must be given to cancel your reservation. If notice is not given the \$150 damage deposit will not be refunded.
