The Canton Center Commuter Rail is less than a 1/2 mile walk.

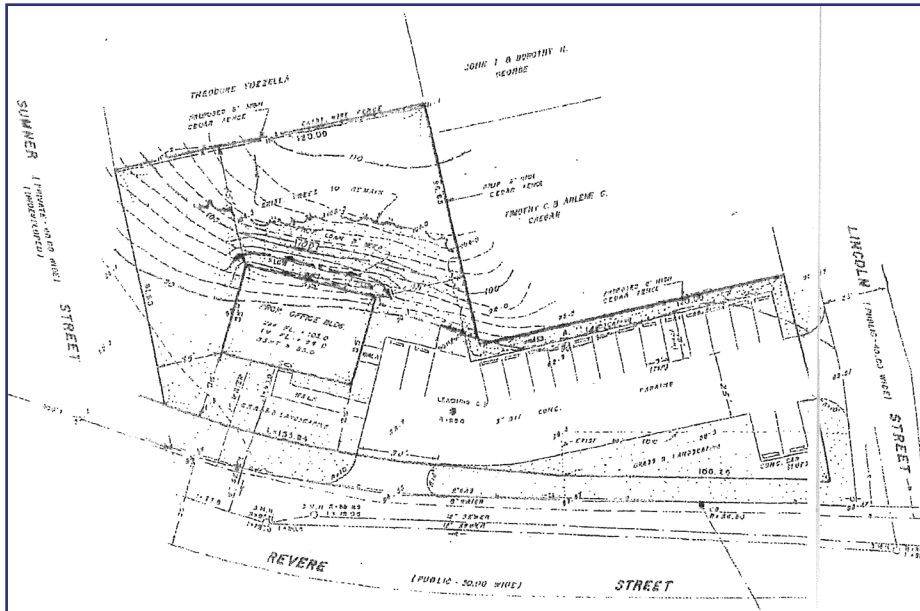

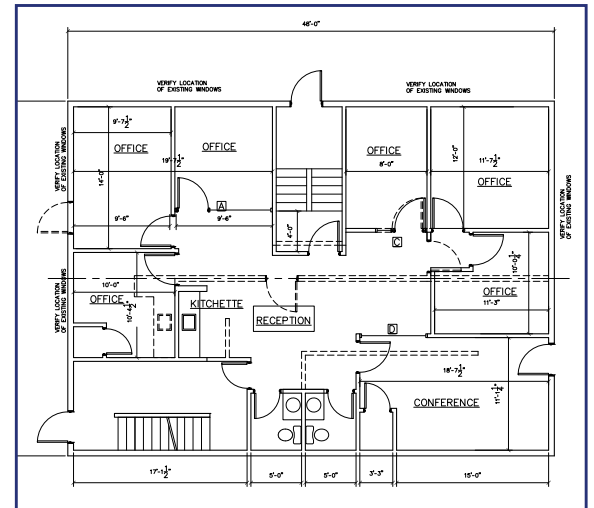
