



## **TERMS AND CONDITIONS**

Welcome to Tandemgps.com, a website owned and operated by Tandem Enterprises, LLC, and TandemGPS DBA, together referred to as the "the Service." and an organization dedicated to the growth, development, and expansion, of the Software, Functionality, and Appearance of the TANDEMGPS, a Digital Navigation and Speedometer App.

Tandemgps.com is offered to you, conditioned on your acceptance, without modification of the terms, conditions, and notices contained herein.

Your use of the Site, and the downloading and use of TandemGPS, "the App," constitutes your agreement to all such Terms.

### **Agreement between User and Tandem Enterprises, LLC, a Hawaii Corporation, and the Proprietary Managing Entity, TandemGPS, a Texas DBA**

#### **Privacy**

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

#### **Class Action Waiver**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/ representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and the Service agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
