- 1. Nature of the Company/Chapter Charter. Provisions for Scabbard and Blade membership may be established on a college or university campus which hosts an accredited Reserve Officer Training Corps program in one of four approaches (see "Administration" in the Manual for Company Officers available on the national web site):
 - a. Extension of the National Headquarters Company. No local company is organized. The commander of the ROTC detachment, or his or her academic representative, nominates qualified cadets and/or midshipmen using the paper Form MN, which is submitted to the national office for review by the National Company officers. When approved, member packets are sent to the ROTC commander for presentation. One or more National Company representatives will attend the ceremonies to conduct the initiation according to the Society Rituals. This petition should not be submitted. No charter is issued.
 - b. Provisional Company. As local preparations are being made to establish a company of the Society, a petition may be submitted for provisional status. A company management system packet will be sent to the company/academic advisor of the provisional company, which will be used to nominate qualified cadets and midshipmen for membership, submit reports, and maintain company records. The provisional company should proceed in acquiring a company charter, defining and conducting company activities, and otherwise preparing for a more advanced status of company organization. No charter is issued.
 - c. Honorific Company. Local companies in this status confer distinction through initiation into the Society and provide awards to non-Society members of the ROTC program, the military, or otherwise individuals of distinction. No other company activities are pursued. A charter is issued.

	 d. Academic Companies. Local companies in this status, in addition to the activities noted above, work in conjunction with the ROTC departments on campus to accomplish one or more of the programs listed below. A charter is issued and special support is provided to the company: Excellence, work with other campus organizations on special programs, such as tutoring or workshops for drill, physical training, tactics, leadership, etc., to advance academic excellence within the ROTC programs; Education, offer joint military education programs such as seminars, lectures, symposia, and field trips; JROTC, sponsor Junior Scabbard and Blade companies in JROTC; Regional HQ, function as a regional headquarters; Ethics, participate in the Association of College Honor Societies "Ethics" program (see the ACHS web site); Vi. Service, conduct local service projects devised by the company.
