This First Amendment to the Kerrville Summit Property Owners Association By-Laws ("First Amendment") is made on the 12 day of 5 ept Ent ber , 2023 by the Board of Directors of the Kerrville Summit Property Owners Association, a Texas nonprofit corporation ("Association").

RECITALS

- 1. The Kerrville Summit Property Owners Association By-Laws are recorded under Clerk's File No. 23-02786 of the Official Public Records of Kerr County, Texas ("By-Laws").
- 2. The By-Laws may be amended by a majority vote of the Board of Directors (the "Board") pursuant to Section 22.102 of the Texas Business Organizations Code.
- 3. The Board desires to amend the By-Laws to clarify certain provisions in Article VIII, Section 1.
- 4. The Board of Directors hereby adopts this First Amendment to the Kerrville Summit Property Owners Association By-Laws.

WITNESSETH

1. Article VIII, Section 1 of the By-Laws is deleted in its entirety and amended to read as follows:

<u>Section 1. Powers.</u> The business and affairs of the Association shall be managed by its Board of Directors, which may exercise all such powers as are note by law, the Articles or the By-Laws directed or required to be exercised and done by the Members. The power and authority of the Board shall include, but shall not be limited to, all powers, duties and authority vested in or delegated to the Board in the Declaration.

The Board shall have the power to administer and enforce the covenants, conditions, restrictions, uses, limitations, obligations, and all other provisions set forth in the Declarations applicable to the Property or any Additional Subdivisions. The Board may levy fines for violations of the provisions of the Declarations applicable to the Property or any Additional Subdivisions, all rules and regulations of the Association, and all other "dedicatory instruments" of the Association as that term is defined by Texas Property Code Section

202.001(1) or its successor statute and adopt (and amend as needed) an enforcement and fining policy.

I, the undersigned, being the Secretary of Kerrville Summit Property Owners Association, do hereby certify that the foregoing "First Amendment to the Kerrville Summit Property Owners Association By-Laws " was duly approved by a majority of the Board of Directors at a duly noticed and held meeting with a quorum of the Board in attendance.
