## Alberto Moreno,

Your entity registration in the U.S. federal government's System for Award Management (SAM) passed the Internal Revenue Service (IRS) validation of your Taxpayer Identification Number (TIN) and Taxpayer Name, known as the IRS TIN Match process.

This is one step in the overall registration process. If you have not already done so, you must complete and submit your registration. It will then be sent to the Defense Logistics Agency (DLA) Commercial and Government Entity (CAGE) Code system for assignment or validation of your CAGE Code.

You can check your registration status at any time. You must be signed in to check your registration status.

- 1. Sign in to <u>SAM.gov</u>.
- 2. From any page, select "Check Entity Status" at the bottom of the page under the "Customer Service" section
  - 3. On the "Check Entity Status" page, enter your Unique Entity ID or CAGE code
  - 4. Select "Search" to quickly check your progress
  - 5. Your registration status will be reflected under the "Entity Information" section

If your status is not "submitted", you need to complete and submit your registration.

- 1. Go to the <u>SAM.gov</u> website and sign in
- 2. In your "Workspace", select the "Entities" link
- 3. On the next page, locate or search for the "Work in Progress" entity you need to submit. Note: the registration status is displayed.
  - 4. Select the action icon to the right that has three vertical dots
- 5. Select "Update" and complete the registration. Review every page in the registration to submit. Start at the beginning, review, or update the content as required, and select "Save" and "Continue" on each page. At the end, be sure to select "Submit". You will see a confirmation message when you successfully submit your registration.

Remember, it is FREE to register in SAM.gov. Get free help at <u>SAM.gov</u> in the "Help" section and at the <u>Federal Service Desk (FSD)</u> where you will find SAM.gov user guides, quick start guides, helpful hints, videos, and frequently asked questions. If you are going through entity validation at SAM.gov for the first time and have questions, visit <u>this list of FAQs</u>.
