In compliance with the provisions of Oklahoma Statutes Title 158 Construction Industries Board, Chapter 70 Home Inspection Industry Regulations, this Whole House Inspection includes a thorough visual examination that meet or exceed these requirements for the inspection of the following systems:

Structural: Foundation, Visual Load bearing structural members, framing, crawl spaces, roof and attics

Exterior: Exterior finishes, walks, driveways, patios, decks, porches, steps/stairs, roof gutters, skylights, eaves

Electric: Service risers, panels, receptacles & GFCI's, switches, lights, fans, visible wiring & wiring methods

Plumbing: Plumbing fixtures & visible water supply piping, shower pan, outside faucets, water heater, water system leak test (for natural gas leak test, see options)

Heating & Air Conditioning (HVAC): Furnace, flues, condensing unit, fan, controls, condensation drain, ducts, bathroom exhaust fans/ heaters

Interior: Walls, ceiling, floors, steps, stairways, railings, doors, window glass and representative number of windows for operation and a representatives number of installed cabinets, garage doors & opener

Appliances: Garbage disposal, stove, cook top, oven, dishwasher, vent hood, free standing stove

Drainage: Adverse surface water flow or grading adjacent to structure

Roof: Roof coverings, roof drainage systems, flashings, skylights, attic ventilation, roof penetrations, and chimney

Appliances: Built-in kitchen appliances, excludes refrigeration equipment/ ice-makers, trash compactors.
