#### **PAGEANT APPLICATION AGREEMENT**

THIS AGREEMENT is made between The Miss Abdallah Shrine Rodeo Pageant, hereinafter referred to as "Pageant", and \_\_\_\_\_, hereinafter referred to as "Contestant".

WITNESETH:

Whereas, Pageant conducts the *Miss Abdallah Shrine Rodeo Pageant*, including the creation, publication and administration of all rules and regulations relating thereto, and whereas, Contestant desires to compete in the Pageant.

Now, Therefore, in consideration of the mutual promises set forth herein, the mutual benefits derived here from and other good and valuable consideration provided each unto the other, the receipt and sufficiency of which is acknowledged by delivery hereof, it is agreed:

1. Contestant certifies that she has never been married, pregnant or given birth to a child.
2. Contestants have never been charged and/or determined to have committed any crime of moral turpitude, nor has she had a title removed for any reason.
3. Contestant hereby grants permission to The Miss Abdallah Shrine Rodeo Pageant to verify any and all information contained on her application and attests that the information she has provided is true.

4. Contestant hereby releases The Miss Abdallah Shrine Rodeo Pageant of all responsibility in case of injury or loss to person or property involving her or persons related to her while appearing in the Pageant. The aforesaid also applies to people related to Contestant.

5. Contestant hereby releases title, claim and rights to photographs and/or public relations material involving her or her likeness to The Miss Abdallah Shrine Rodeo Pageant for use in Pageant and Rodeo promotion.

6. In the event Contestant receives The Miss Abdallah Shrine Rodeo title, she will complete the tenure of the title in accordance with the aforesaid regulations and in the best interest of Abdallah Shrine Rodeo, Abdallah Shriners, Shriners International and Shriners Children's; and will relinquish all claims and accouterments relating to the title upon the naming of her successor. In the event contestant is removed from title during her reign, will relinquish all claims and accouterments relating to the title, and the title shall be passed to the first runner up.

7. Contestant agrees to indemnify, defend and hold harmless The Miss Abdallah Shrine Rodeo Pageant and all rodeo committees, their officers, agents or employees from and against all loss of expense by reason of liability imposed by law for damages due to bodily injury. This includes death at any time resulting from/or sustained by any person or persons and/or damages to property, including loss of use thereof arising out of/or in damage to property due to any negligence.

8. Contestant agrees that the Abdallah Shrine Rodeo Pageant is the sole and exclusive entity to determine the existence and/or nonexistence of a violation of the rules and regulations, and that Contestant shall be finally bound by Pageant's determination, the same to be final and binding between the parties hereto. Contestant further agrees that Pageant is the sole and exclusive authority to interpret and enforce its rules and regulations.

9. In any legal proceeding in which Pageant shall be awarded any judgment enforcing any term and/or condition of this Agreement, Pageant, its employees, agents, sponsors, and/or representatives shall also receive reasonable attorney fees and all costs incurred in the prosecution and/or defense of said action.
