## a. Information You Provide

## **Examples include:**

## b. Automatically Collected Information

- Referring/exit pages and clickstream data

This information helps us understand how visitors use our Site and improve functionality.

## c. Cookies and Tracking Technologies

We use cookies, pixels, and analytics tools (like Google Analytics) to improve user experience, analyze traffic, and personalize content.

You can adjust your cookie preferences in your browser settings.

### 2. How We Use Your Information

We use collected information to:

- Respond to your inquiries or service requests
- Improve our Site and services
- Send updates or marketing communications (only if you opt in)
- Comply with legal obligations
- Prevent fraudulent or unauthorized activities

We do **not** sell personal data to third parties.

### 3. How We Share Information

We may share your information with:

- Business partners only with your consent
- Law enforcement or regulators when required by law or to protect our rights

All third parties are contractually required to protect your data and use it only for authorized purposes.

#### 4. Data Retention

We retain personal information only as long as necessary to fulfill the purposes outlined in this policy or as required by law.

When data is no longer needed, we securely delete or anonymize it.

## 5. Your Rights and Choices

Depending on your location, you may have the following rights:

- Opt-Out: Withdraw consent for marketing communications.
