## COMMON AREA MAINTENANCE AGREEMENT

- A. The Association has been established under and pursuant to that certain Declaration of Covenants, Conditions and Restrictions pertaining to Tract: -2 5150, as recorded in the Office of the Recorder for Santa Clara County, California, on August 27, 1972, in Book 9987, Page 715; and
- B. The Association is the owner of the common areas as shown on the final subdivision map for Tract 5150 ("the Common Area"), and is responsible under the terms of said Declaration of Covenants, Conditions and Restrictions for the management of the Common Area and the maintenance of all landscaping, walkways, buildings, structures or facilities constructed or installed therein; and
- C. City's approval of the subdivision map for Tract 5150 was conditioned upon the execution of an agreement by the owner of the Common Areas for perpetual maintenance of the same.

NOW, THEREFORE, City and the Association agree as follows:

1. The Association, at no cost to City, shall cause the Common Area, including any portion thereof which may be located within any public right of way, to

be at all times perpetually kept and maintained in good and orderly condition, repair and maintenance, in accordance with the requirements and standards as set forth in the development plan for Tract 5150 and such other requirements as reasonably imposed by City's Director of Maintenance, including, without limitation of the foregoing, the replanting and replacing of any lawns, trees, plants, shrubs and other landscaping that may become diseased, destroyed or die, and the maintenance and repair of all walkways, buildings, structures or facilities now or hereafter located within the Common Area.

The implementation of this Agreement may affect the safety and 2. welfare of the residents of City residing in close proximity to the landscaping, landscaped area and other improvements within the Common Area. When, in the opinion of City's Director of Maintenance, said landscaping, landscaped area or other improvements, or any part thereof, have deteriorated to such an extent that they no longer meet the aforementioned requirements and standards, the Director of Maintenance may give written notice of the deficiencies to the Association and a demand for correction thereof. In the event the Association fails to perform and complete the corrective work within ninety (90) days following receipt of the written demand from the Director of Maintenance to do so (or if the corrective work is of such nature that it cannot reasonably be completed within ninety (90) days, then in the event the Association fails to promptly commence such work and prosecute the same diligently to completion), then City shall have the right, but not the obligation, to cause such corrective work to be performed, in whole or in part, by its own agents and employees or by outside contractors retained by City for such purposes. Any and all costs or expenses incurred by City in connection with the performance of the corrective work shall be charged to the Association and will be immediately due and payable by the Association to City. Until such charges are paid in full by the Association, the amount thereof will constitute a lien and encumbrance upon each of the lots within Tract 5150 in the same manner and to the same extent as other dues and charges of the Association. Said lien may be enforced in a civil action brought in the name of City in any Court of competent jurisdiction, or in the alternative, shall constitute a special assessment against said real property and shall be collected at the same time and in the same manner as real property taxes are collected by City, all the provisions relating to tax delinquency being made applicable thereto. Nothing herein contained shall be construed to impose any duty, responsibility, or obligation upon the Director of Maintenance to inspect, visit or otherwise view said landscaping,

landscaped area or other improvements for purposes of determining whether upkeep and maintenance repairs are required pursuant to this Agreement.

- 3. Any demand by the Director of Maintenance pursuant to Paragraph 2 hereof, requiring the Association to perform corrective work, may be appealed by the Association to the Saratoga City Council by filing a Notice of Appeal with the City Clerk within fifteen (15) days after the Association's receipt of such demand. If an appeal is taken and the demand by the Director of Maintenance is affirmed, or affirmed as modified by the City Council, the period of time for the Association's completion of the corrective work set forth in Paragraph 2 hereof shall begin to run from the date the City Council renders its decision.
- 4. This Agreement shall constitute a covenant running with the land, and shall be binding upon and inure to the benefit of the heirs, executors, administrators, grantees, succesors and assigns of the Association.
- 5. The persons who execute this Agreement on behalf of the Association hereby represent and warrant to City that they constitute all of the members of the Association.
