Notice is hereby given that a regular meeting of the Board of Commissioners of Burnet County Emergency Services District No. 7 will be held on **Monday, June 24, 2024, at 5:30 p.m.**, at the Burnet Community Center at 401 E. Jackson Street, Burnet, Texas 78611, for the following purposes:

1. Call meeting to order;
2. Public Comment on Agenda Items: Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.

3. Receive monthly report from the Treasurer and consider:
  - (a) approval of payment of monthly bills and invoices;
  - (b) approval of monthly financial report; and
  - (c) current year budget amendments as necessary;
4. Receive monthly report from Burnet Volunteer Fire Department regarding financial matters, training, management activities, membership, and emergency operations and out of station times (including breakdown by apparatus) and call volume for fire/rescue calls and for EMS calls;
5. Receive monthly report from Lampasas Volunteer Fire Department regarding financial matters, training, management activities, membership, and emergency operations and out of station times (including breakdown by apparatus) and call volume for fire/rescue calls and for EMS calls;
6. Receive monthly report from the City of Burnet Fire Department regarding financial matters, training, management activities and personnel, membership, and emergency operations and out of station times (including breakdown by apparatus) and call volume for fire/rescue calls and for EMS calls;

8. Discuss and consider adopting the tax and budget planning calendar for 2024 and authorize payment for tax process publications;
9. Review adopted investment policy and investment strategies and consider approval of resolution confirming annual review;

10. Discuss status and approval of District's financial audit, and ratify District's filing same with the Burnet County Commissioners Court;
11. Discuss changes to Texas Commission on Fire Protection Regulations and consider associated action;
12. Discuss financing for new brush truck to be acquired by the Burnet Volunteer Fire Department and consider authorizing action on same;
13. Discuss status of contract with Lampasas Volunteer Fire Department;
14. Discuss and consider action to adopt a District Mission Statement;
15. Discuss and consider updates from Subcommittee on District's fire code;
16. Receive status report on strategic planning issues, discuss short-term and long-term goals for the District, and consider taking any necessary action;
17. Public Comment: Individual members of the public may address the Board for a maximum of three (3) minutes regarding general topics that are not on the current agenda. Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda; and
18. Discuss agenda, time, and date for next meeting.
