Notice is hereby given that a regular meeting of the Board of Commissioners of Burnet County Emergency Services District No. 7 will be held on **Monday, August 28, 2023, at 5:30 p.m.**, at the Burnet Community Center at 401 E. Jackson Street, Burnet, Texas 78611, for the following purposes:

1. Call meeting to order;
2. Public Comment on Agenda Items: Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item are called for by the presiding officer, but before Board discussion and consideration of the item.

PUBLIC HEARING, BUDGET AND TAX RATE ITEMS

3. Conduct public hearing on proposal to increase property taxes.
4. Discussion and action on Resolution Adopting Budget for fiscal year October 1, 2023 to September 30, 2024.
5. Discussion and record vote on District's 2023 tax rate, adopt an Order Levying Taxes, and authorize filing Order with the Burnet County Tax Assessor/Collector.
6. Acknowledge and approve posting of statement regarding adopted tax rate to home page of District Website.

- 15. Public Comment: Individual members of the public may address the Board for a maximum of three (3) minutes regarding general topics that are not on the current agenda. Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda; and
