MINUTES

September 22, 2025

A regular meeting of the Board of Commissioners of Burnet County Emergency Services District No. 7 was held on **Monday, September 22, 2025, at 5:30 p.m.**, at the Hill Country Community Foundation Building / S.H. Reed Building at 402 E. Jackson Street, Burnet, Texas 78611, for the following purposes:

- 1. Call meeting to order: Meeting was called to order by John Smallwood at 5:30 p.m. Present were Commissioners John Smallwood, Clayton Smith, Roy Hallmark, and Barbara Postel. Commissioner Brenda Goble was absent. Also present were Katy Hennings, Paralegal at The Carlton Law Firm, P.L.L.C.; Casey Daniels of the Burnet Volunteer Fire Department; Tim Weinrick of the Lampasas Volunteer Fire Department; and Mark Ingram and Curtis Murphy of the City of Burnet Fire Department, as well as residents of the District.
- 2. Public Comment on Agenda Items: None.

The Board of Commissioners addressed the agenda items in the following order:

15. Public Comment: Alan Treviño, Resident of the District and Chief Deputy of the Sheriff's Department, stated that he is running for County Judge and spoke briefly about himself and his candidacy.

BUDGET, PUBLIC HEARING and TAX RATE

- 3. Consider taking action regarding budget for fiscal year October 1, 2025 to September 30, 2026: John Smallwood moved to adopt the budget as presented to the Board. Roy Hallmark seconded the motion, and it passed unanimously.
- 4. Conduct a public hearing on the proposal to increase property taxes: John Smallwood opened the public hearing at 5:33 p.m. and asked for public comment.
 - Resident Gary Law expressed his opinions regarding the proposal to increase property taxes and discussion followed.
 - The public hearing was closed at 5:42 p.m.
- 5. Take a record vote on the District's 2025 tax rate, adopt an Order Levying Taxes, authorize filing the Order with the Burnet County Tax Assessor/Collector: John Smallwood made the following motion: *I move that the property tax rate be increased by the adoption of a tax rate of 7.8675 cents per \$100 valuation, which is effectively a 4.83 percent increase in the tax rate,* to adopt the Order Levying Taxes, and to authorize filing the order with the tax assessor/collector. Clayton Smith seconded the motion, and a record vote was taken:

The motion passed unanimously.

Acknowledge and approve posting of statement regarding adopted tax rate to home page of District website: Roy Hallmark moved to approve the posting addressing the adopted

tax rate to the District's website. Barbara Postel seconded the motion, and it passed unanimously.

Discuss water rescue capabilities of and training for the City of Burnet Fire Department and Burnet Volunteer Fire Department and consider taking related action: Discussion was held regarding water rescue resources and training for both the City of Burnet Fire Department and the Burnet Volunteer Fire Department. No action was taken.
- 14. Receive status report on strategic planning issues, discuss short-term and long-term goals for the District, and consider taking any necessary action: Discussion was held with regard to the property acquired for the new station and initial work that may be completed. No action was taken.
