CCC Settlement Agreement Status Report, 2008-2009

Introduction

The CCC Settlement Agreement Status Report, 2008-09, provides information regarding the extent to which District, area and school staffs of Broward County Public Schools (BCPS) have met the conditions stipulated by the August 1, 2000, Citizens Concerned About Our Children (CCC) Settlement Agreement and Release. To ensure that diversity and equity are promoted within BCPS, the CCC Settlement Agreement specifies nine conditions. Under each condition of the Agreement, the BCPS with the cooperation of the Diversity Committee established standards and indicators to address the terms of the Agreement.

The report includes information collected from the following sources: (a) survey of school staffs which identified each school's status for the standards under selected condition, and (b) school and district-level quantitative data analyses regarding measures related to select conditions. The data and findings contained in the report focus on the 2008-09 school year.

The CCC Settlement Agreement applies to all BCPS, with the exception of charters, as these schools are not addressed in the CCC agreement.

Method

Sources for the quantitative data were District files and records. The Deputy Superintendent for Curriculum & Instruction/Student Support and the Directors of Research Services and Diversity & Cultural Outreach cooperated to provide a template for the research process in 2004. Additional indicators and supportive data were developed based on feedback of BCPS staff and members of the Diversity Committee following review of the February 2005 preliminary report and the August 2005 final report. The process culminated in the specification of standards that were directly aligned to each condition. Identification of quantitative data to be provided by District sources was determined.

Quantitative Measures

Quantitative data were chosen if the identified measure provided information regarding the status of one of the conditions in the Agreement and if the measure was available either through the Data Warehouse or was maintained in a file by a District department. To ensure data accuracy, select departments verified the site-by-site information.

Results

Results are provided for each of the nine conditions. Each indicator includes findings, actions (if applicable), and source of information. Table provides a summary of the 47 indicators by status for the past four years.

Condition 1:

The SCHOOL BOARD agrees to develop a plan to survey the schools to ascertain the number, quality, age, and availability of textbooks in relation to student enrollment and identify any gaps present. As a result of said survey, and subsequent analysis of the results, the SCHOOL BOARD shall implement plans to provide equal allocation of current textbooks district-wide.

1.1 The school has purchased one core textbook per child for Reading, Mathematics, Language Arts, Science, and Social Studies for elementary, middle and high schools. The school has purchased one core textbook per child for Foreign Language at middle and high schools.

Status: Data collected in March 2009 Survey based on class enrollment proved limited. Actions taking place to provide a more in-depth accounting of the availability of textbooks across the district.

Findings/Actions: A Textbook Survey using Virtual Counselor was completed in March, 2009, the survey concluded that out of 29,562 Core Classes that require a textbook, 28,997 (98.1%) have at least one textbook for every student enrolled, and 565 (1.9%) are short one or more textbook per student enrollment. The data was presented at the June 4th Diversity Meeting and May 26th School Board Workshop. The survey was limited in that it only reflected the number of hard copy textbooks per student enrollment. The process moving forward will incorporate the end of year physical inventory with information on upcoming school year course offerings and projected enrollment to identify ‘gaps’ of instructional materials and address them prior to the beginning of the new school year.

The current annual physical inventory for the 2008-2009 year-end counts will be aggregated and imported electronically to be incorporated with information on course offerings and projected student enrollments at the school. The resulting report will identify anticipated ‘gaps’ for each core course offering. Materials are being redistributed or purchased to address the anticipated gaps prior to the start of the 2009-2010 school year.

A report or survey will be run after the 20-day enrollment counts to ensure instructional materials are aligned to enrollment. The new process will proactively provide data to drive instructional materials allocation process, versus reporting information at the conclusion of year. The annual physical inventory process will be automated on-line for the 2009-2010 year-end inventory. This will enable the physical material counts to be easily incorporated with information from the student database.

1.2 The school has implemented a plan that allows each student (grades 1-12) to take textbooks home.

Finding: Per the District Annual Customer Survey a downward trend was registered within all three groups at all school levels, 64.8% of all students surveyed, 69.3% of all parents surveyed, and 67.9% of all teachers surveyed were in agreement with the statement, “I/My child/Students can take home either a book in print, on CD, or access it online for each of my courses that use a textbook.” District staff are continuing to support the culture change to reinforce the use of all available textbook media.

1.3 The school has a textbook coordinator who tracks the textbook inventory.

Status: Met

Finding: 100.0% of schools have a textbook coordinator who tracks the inventory. See Appendix A for a listing of textbook coordinators by school.

1.4 The school has a process to ensure that all assigned core textbooks meet state adoption standards regarding age.

Status: Met

Finding: 100.0% of schools report that core textbooks meet state adoption standards regarding age.

1.5 The core textbooks meet the six-year adoption cycle standard.

Status: Met

Finding: 100.0% of schools meet the six-year adoption cycle standard for core textbooks.

1.6 The school is in compliance with District Policy 6.5 – Textbooks.

Status: Met

Finding: All schools comply with Policy 6.5.

1.7 The school has implemented a textbook replacement plan.

Status: Met

Finding:

- 100.0% of schools have a textbook replacement plan. See Appendix B for textbook obligations. Textbook obligations are not reported for students no longer active in the District.
- ETS has added a field in TERMS that gives the ability to track all obligations, including fields such as date paid, receipt number and total obligations outstanding. The obligations file has been made available through the Data Warehouse and include a series of reports that can be downloaded.

CONDITION 2:

The SCHOOL BOARD agrees to develop a plan to survey the present technology within the schools and analyze this data to identify any gaps present. As a result of said survey, and subsequent analysis of the results, the SCHOOL BOARD will implement plans to bring schools to parity in regard to the allocation and capacity of computers, and assure training of teachers in the use and application of technology and software.

2.1 The school meets District standard of one laptop computer per student enrollment count of six, a laptop computer for teachers, a printer in every other classroom, Internet access for each classroom, and upgraded electricity and energy management systems.

Status: Met

Finding: Fall FTE survey was analyzed and orders were processed by ETS for equipment (laptops and/or printers) needed to meet the current standard technology ratios. All procurements are complete, and school computers have been installed. See Appendix C for a school by school listing of student laptop computer and classroom printer ratios.)

2.2 The school facilities are equipped with the necessary capacity and infrastructure to meet the terms of 2.1.

Status: Met

Findings/Actions: 100.0% of schools are equipped with the necessary capacity and infrastructure to meet the terms of 2.1.

- All schools are currently equipped with the necessary infrastructure and equipment to allow flexibility to move computers into any classroom using either wired or wireless connectivity throughout their campuses. Student Technology Refresh Project has additionally provided every school new opportunities to create labs on demand, eliminating the need to have classrooms designated for fixed computer lab purposes.
- All schools are currently supplied by the District with software licenses for Apple Remote Desktop 2.0, CAB/First Class, Deep Freeze, Filemaker Pro, iLife/iWork, Inspiration/Kidspiration, LANDesk, McAfee Virus Scan for Windows/Macintosh, Windows/Macintosh OS, Atomic Learning, Comic Life, Pinnacle, MS Office, United Streaming and Elluminate Live and Turn it In.com (for high schools only).
- When relocatables are being moved from one site to another, there will be a period of time that the classroom will have no network connectivity until such time as it is reconnected to the Broward Schools network. At this time, all permanent and relocatable classrooms that are not in a transitional state have been provided network connectivity.
- The Strategic Plan for Technology 2007-2010 includes, but is not limited to: developing a standard process for software evaluation and procurement and ensuring that technical infrastructure continuously supports the District's current and future technology initiatives.

2.3 The school has implemented a plan to ensure that instructional staff is competent/proficient in the use and application of technology and software.

Status: Met

Finding: 100.0% of schools have implemented a plan to ensure that instructional staff is competent/proficient in the use and application of technology and software.

- Offerings of technology related staff development and training include CAB, Atomic Learning, Digital Education Teacher Academy, Daily Technology Application, Technology Support Certification Program, Virtual Technology Recognition Project, Virtual University, and New Teacher Academy Application Training.
- During the 2009-10 school year, a new program called the Digital Educator Administrator and Teacher Competency program will further assist teachers and administrators with integrating digital technologies into teaching and learning. This program provides a process for moving teachers and schools forward towards a 21st century learning environment. It addresses how digital tools, professional development, principal leadership, digital curriculum, instructional strategies and network infrastructure fit into a foundation, intermediate, and advanced level of instructional integration. It is a guide for school principals in making instructional technology decisions.
- The Strategic Plan for Technology 2007-2010 includes, but is not limited to: ensuring that technical human resources continually support the District's current and future technology initiatives.
- 86.2% of all teachers surveyed on the 15th Annual Customer Survey agreed with the statement, "I have been given adequate training to use technology to teach my students". (87.3% elementary, 86.1% for middle, 84.0% for high, and 86.4% for centers)

2.4 Public Support Technology Funds (PSTF) are spent each year to support, upgrade and maintain technology hardware and software in the school. (The State eliminated the Public School Technology Funds categorical in the 2006-2007 school year.)

2.5 Students and personnel have access to computers and technology.

Status: Met

Finding: 100.0% of all schools provide students and personnel access to computers and technology.

Additional Information:

- 74.9% of all students surveyed, 79.1% of all parents surveyed, and 77.9% of all teachers surveyed were in agreement with the statement, “I have/My child has/My students have sufficient access to computers and technology at school to do my/their schoolwork”.

2.6 The school is in compliance with District Policy 5306 – Technology Usage.

Status: Met

Finding: 100.0% of schools meet District Policy 5306.

CONDITION 3:

The SCHOOL BOARD agrees to implement the developed Standards of Service for all schools. This will establish a county wide grade level benchmark and a diagnostic/prescriptive procedure to identify all students' needs. The SCHOOL BOARD will analyze this data and implement plans to address the conclusions of said analysis.

3.1 The school has implemented a comprehensive plan to diagnose individual student achievement needs.

Status: Met

Finding: 100.0% of schools met this indicator.

- An assessment schedule has been implemented district wide that include the Benchmark Assessment Test (BAT), BAT mini-assessments, and electronic learning systems such as Integrated Learning System (ILS) software. The process of continuous diagnosis of student achievement progress is one of the key components the 7-8-9 Plan.
- Florida was selected as one of the six states to participate in a pilot differentiated accountability process. The Differentiated Accountability (DA) Plan aligns and integrates the state and federal systems of accountability. The plan separates schools by school grades and the percent of AYP indicators that are met, as well as by the number of years the school has not made AYP. Each category specifies the degree of school autonomy and the support and oversight that must be provided by the state and the district.
- Since the State of Florida has implemented a new accountability system, Broward realigned support to meet the new requirements and used this as an opportunity to be on the cutting edge of school reform and accountability.

3.2 The school has implemented a plan to disaggregate the data and use it to deliver instruction.

Status: Met

Finding: Virtual Counselor, the School Reports Menu and DWH Reports are all used to provide comprehensive student assessment results, down to the benchmark level, that allow the specific needs of each student to be identified. The Learning Village application provides a bank of grade level courses, unit plans, lesson plans, activities and resources aligned to the Sunshine State Standards, the National Educational Technology Standards, Information Literacy Standards, and Career and Technical Education Standards that are used to individualize classroom instruction to meet the identified needs of each student.

3.3 The school uses frequent assessments to measure and adjust instruction based on results – Weekly, Monthly, or Quarterly.

Status: Met

Finding: 100.0% of schools met this item.

- All schools participate in the Benchmark Assessment Test annually to provide diagnostic and proficiency information.
- All schools have access to mini assessments, which include reading, mathematics, and science and have been implemented district wide for the second time this year.
- Staff are expanding end of course assessments and revisiting primary grade level testing.
- All elementary and secondary schools use Computer Assisted Instruction (CAI) and Integrated Learning System (ILS) software.

3.4 The school uses student achievement data to determine professional development needs of teachers via Professional Growth Plans (PGPs).

Status: Met

Findings/Actions: All teachers complete the PGPs on-line via Intranet. In order to focus on building teacher capacity to improve student achievement, Human Resource Development (HRD) collects this data and analyzes to drive decisions regarding training and professional development.

The PGP component was added to the BRITE System in 2007-08 and is being piloted during the 2008-09 school year. This coordination creates a comprehensive and centralized system that supports the alignment of student achievement goals with staff development needs. The system was created in cooperation with ETS, HRD, Curriculum, and Program Development and Alignment.

CONDITION 4:

The SCHOOL BOARD agrees to develop a plan that shall establish a core of Advanced Placement (AP) and Honors Courses for delivery at every high school. Core courses will be taught at each high school. The SCHOOL BOARD also agrees to develop a plan for the utilization of distance learning for discrete courses and the implementation of procedures to rotate the live presentation of discrete courses to high schools throughout the county to assure equal access and availability for all students in all schools. This condition only applies to high schools.

4.1 The school offers student access to the AP curriculum (American History, Biology, Calculus, AB English Language Composition, English Literature, and Spanish/French). The school delivers AP core courses to every high school.

Status: Met

Findings/Actions: 100% of District high schools offered students the opportunity to enroll in each of the AP courses.

Tables 4.1a through 4.1c show the District total number and proportion of students by ethnicity, gender, Free and/or Reduce Price Lunch (FRL) status, Exceptional Student Education (ESE) status, and English Language Learners (ELL) status enrolled in AP, Honors, and Dual Enrollment courses. Appendix D shows school by school data on enrollment by ethnicity, in AP, Honors and Dual Enrollment courses.

- A Summer Institute is underway to provide AP teacher-training to 614 (six hundred fourteen) AP teachers districtwide utilizing College Board consultants. Principals were encouraged to enroll teachers in the summer institute by considering their experience with teaching AP as well as AP exam performance.
- The College Board will continue auditing teachers with respect to their training, syllabi, and textbooks. The AP designation is allowed only for courses where audit requirements are met.
- The Individual Development Plan (IDP) for new AP teachers or teachers with low pass rates mentioned in the previous year's report was not implemented. Contractual and staffing issues, including the alignment of District practice with College Board philosophy of "open gates to AP," made the IDP impractical in terms of cost/benefit.

4.2 Students have access to discrete courses not taught at school through Distance Learning and on-line through Broward Virtual Education.

Status: Met

Finding: 100.0% of the high schools have access to Distance Learning through videoconferencing and online courses through Broward Virtual School and/or Florida Virtual School. See Appendix E for Distance Learning participation by high school.

4.3 The school has implemented a strategic plan during the current school year that ensures an equitable rotation among schools of distance learning classes that are offered district-wide.

Status: Met

Finding: The summary of enrollments in AP or discrete courses delivered through distance learning options (videoconferencing, online learning) in 2008-09 indicates 100% of schools have access. Currently, 83% of high schools have students enrolled in such courses. See Appendix F for school by school student participation in AP courses through virtual education.

4.4 Evidence from Guidance staff that students are being provided with information that encourages enrollment in AP/Honors classes.

Status: Met

Findings/Actions:

- Documentation explaining the benefits of accelerated courses will be made available to all high school students in March 2009. This communication explains the different types of acceleration courses available to high school students and the benefits of taking accelerated courses.
- In September 2008, all parents of high school sophomores received a letter from the District regarding participation in the state required PSAT. This letter also stressed the importance of student enrollment in advanced courses such as Honors, Dual Enrollment (DE), and Advanced Placement (AP).
- In January 2009, high school guidance staff participated in an AP Potential workshop/training. 94% of all high schools attended. Missing schools were provided the information via personal conferencing with Advanced Academics & Guidance staff.
- During the 2008-09 school year, Advanced Academics staff has met with each high school leadership team regarding individual school plans for recruitment of students into rigorous course work.

4.5 The school has a process in place to ensure that PSAT scores or ETS flagged reports are used to guide students into AP and Honors classes.

Status: Met

Findings/Actions: 100.0% of the high schools have access to PSAT scores and flagged reports via the Intranet and the Data Warehouse.

- The Research Services Department calculated two prediction flags for 2008-09 ninth grade students. The College Readiness flag is used to identify whether a student will be ready for college, will be ready with assistance, or will not be ready for college by the time s/he graduates from high school. The AP Enrollment flag is used to identify whether a student will be likely to enroll in an upper-level course (AP/Dual Enrollment/IB) during his/her high school career, will enroll with assistance, or will not be likely to enroll. The data used to compute these flags included demographics, FCAT scores, and SAT scores as verification of college readiness. These reports are made available to all high schools through the Data Warehouse in June.
- Prior to the beginning of the 2009-10 school year, Research Services will provide a list to high school principals that identifies students at their schools that are flagged as likely to enroll but are not currently enrolled in an upper level course. High school staffs will use these student flags to assist them in directing students into the proper courses in 2009-10. Research Services will prepare a report at the 20th day of the 2009-10 school year that indicates the proportion of these students that change enrollment to include an upper-level course.
- All high schools have access to individual students' PSAT scores through the Data Warehouse and Virtual Counselor.

CONDITION 5:

The SCHOOL BOARD will conduct an inventory of athletic equipment and facilities at all high schools, identify any gaps present and implement plans to bring athletic facilities and equipment into parity based on District standards. The SCHOOL BOARD shall offer a core of athletic and other extra-curricular activities, including academic clubs, in each middle and high school and put in place a marketing plan to assure equal opportunity based on campus activities. The SCHOOL BOARD shall develop and implement a plan to assure equity in athletic field usage and revenue sharing at Lockhart Stadium and all other stadiums. (Exemptions for 5.1, 5.2, 5.3, and 5.5 of technical high schools, vocational centers, and alternative/ESE centers.)

5.1 The athletic facilities at the high school meet the District standards (access to baseball field, softball field, track, gymnasium, tennis courts) and are in satisfactory condition.

Status: Met

Finding: For project status and for a list of athletic facility projects contained in the DEFP and Athletic Capital Upgrades. See Appendix G for Capital Plan Athletic Projects.

5.2 The school provides the opportunities for high school students to participate in all the core sports. The school provides the opportunities for middle school students to participate in no less than 3 of 5 core sports.

Status: Met

Finding:

Varsity High School Participation:

Boys and Girls Basketball, Cross Country, Soccer and Track & Field 100% met; Boys Baseball and Football 100% met; Girls Softball, Volleyball, Flag Football and Cheerleading 100% met; Boys Swimming 97% met; Girls Swimming 96% met; Boys Tennis 93% met; Girls Tennis 96% met; Boys Wrestling 96% met; Boys Golf 86% met; Girls Golf 68% met; Boys Volleyball 75% met; Boys and Girls Water Polo 55% met.

Middle School Participation for Boys and Girls:

Basketball 100% met; Track 97% met; Flag Football 93% met; Soccer 92% met; Softball 87% met; Volleyball 85% met and Swimming 17% met.

5.3 Schools identified as offering core extra-curricular activity.

Status: 95% middle and 90% high schools met this indicator.

Findings/Actions: All 32 high schools offer significant number of core extra-curricular activities and clubs. Twenty-six of the 29 standard high schools offer full compliment of required activities. The three remaining schools do not offer one activity based on specific reasons indicated in Appendix I, which lists participation in core extracurricular activities.

This indicator will be revised to include core activities and clubs, and allow schools options to meet the indicator.

At the middle school level, 39 of 41 middle schools met the core extra-curricular activities. See Appendix I for a listing of participation in core extracurricular activities.

5.4 The school uses home field, Lockhart Stadium, or other off campus facility.

Status: Met

Finding: Stranahan, Dillard and Fort Lauderdale High utilize Lockhart Stadium as their home facility. The stadium is provided free of charge to these three schools. In addition, Deerfield Beach and Coconut Creek High are undergoing major stadium renovations at their on campus stadium. Both schools will be playing their 2008 home schedule at Lockhart Stadium. The stadium is provided to these schools free of charge. Finally, Monarch High does not have an on-campus stadium and has elected to play their home games at Lockhart. Again, the facility is provided to Monarch free of charge. Lockhart Stadium is the school system's county facility and is designed to provide game field usage for various public high schools. Revenue sharing is in place for all public school football games. Revenue sharing is designed to assist all high schools in funding their athletic programs. The designated home team is authorized to receive the first \$1,000 in gate revenue to cover hosting costs including paying ticket takers, game announcers, game personnel, game set up and clean up. After subtracting the first \$1,000 in gate receipts, the remaining gate receipts are equally shared by the two teams.

Gate revenue sharing provides the following benefits:

- Ensures that all public high schools will receive revenue from all football games played.
- Encourages the visiting team to bring fans to games. The more fans at a game, the larger the gate receipts and the larger the revenue split.
- Revenue sharing protects teams from cyclical cycles, up and down seasons that impact home attendance.
- Ensures that the better or more popular high school football teams do not reap all the financial benefits.

Revenue sharing exists at all football games whether held on-campus or at Lockhart Stadium.

CONDITION 6:

The SCHOOL BOARD agrees to develop a plan to survey all schools' media centers to ascertain the number, quality, age, and availability of media/library books in relation to student enrollment and identify any gaps present. As a result of said survey and subsequent analysis of results, the SCHOOL BOARD shall implement a plan to provide for equal allocation and access to media center materials including a district-wide take-home policy. Where gaps exist due to size of the school enrollment, the SCHOOL BOARD will consider establishing a sparsity supplement within District procedures to assist in providing an equitable distribution of media/library books.

6.1 The school provides a balanced collection of 15,000 (10,000 at elementary schools) usable library volumes, or at least 10 volumes per student if school enrollment is less than or equal to 1,500 (1,000 at elementary schools). (New schools have three years to reach SACS standards, therefore, new schools are excluded from this SACS standard.)

Findings/Actions: 98% Elementary Schools, 88% Middle Schools, 96% High Schools and 63% Centers met the standards.

In order to more closely monitor schools out of compliance, data by school will be provided to the Area Offices from the Learning Resources Department monthly.

6.2 All materials are catalogued using the District-approved cataloguing system.

Status: Met

Finding: All schools catalogue using the District system.

6.3 The library subscribes to a minimum of 35 periodicals annually and the selections serve all grade levels.

Status: Met

Finding: All secondary level schools and Alternative Education Programs media centers subscribe to at least 18 periodicals, subscriptions in print, CD-ROM, and Internet access format. In addition, as the District provides on-line subscription databases for schools, including hundreds of magazine and newspaper articles, all schools met the 35 periodicals total per SACS guidelines.

6.4 The library media materials collection includes electronic technological formats in support of the curriculum (e.g., on-line searches, CD-ROM programs, computer software, and laser disks).

Finding: All schools have access to hundreds of online subscription databases provided by the District; therefore, meet this indicator. See 6.3 above.

6.5 Budget expenditures meet maintenance of effort standards for the last three years - \$9.60 per elementary and middle school pupil and \$12.80 per pupil in high schools.

Findings/Actions: 54% Elementary Schools, 68% Middle Schools, 46% High Schools and 56% Centers met the standards.

Learning Resources will provide data monthly by school to the Area Offices that identifies the number of dollars to be spent by school (pending budget restraints) to bring each to the minimum standard of expenditures (dollars per student and school wide total).

6.6 Students and personnel have access to media services, materials, and equipment.

Status: Met

Finding: The Department of Learning Resources & Instructional Materials (LRIM) has explored the practicality of determining a standard fee to be charged for photocopying of various documents at all schools. The Department has determined that it would not be possible for LRIM to set a standard charge across the District for copies made on rental copiers. Schools’ staff determines what the costs to their school are based on operational costs and clientele and set charges accordingly. Trend data indicates that differences in the fees charged are minute with only a slight variance of 5 cents for B/W copies and a 10 cents difference for color copies.

Additional Information: 79.9% of all students surveyed, 87.2% of all parents surveyed, and 81.5% of all teachers surveyed agreed with the statement, “My/My Child’s teacher/The school has all the adequate resources needed for learning/teaching.”

Note: This does not include Multiple Handicapped Centers (Bright Horizons, The Quest, and Wingate Oaks Center) as media print materials are based on students' needs. Therefore, these centers are not required to comply with the District's standard Age of Collection.

Learning Resources will generate monthly reports for schools out of compliance. Learning Resources and Area Directors will follow up.

CONDITION 7:

The SCHOOL BOARD agrees to develop a plan to collect data on current disciplinary practices including suspension rates and additional support provided by the Standards of Student Services (SOSS). The SCHOOL BOARD shall analyze this data, and implement a plan to address the conclusions of said analysis and to assure equity in the administration of student discipline countywide.

7.1 The school provides accurate information that permits valid calculations of external suspension, multiple external, and internal suspensions rates, and alternatives to external suspension placements.

Status: Met

Findings/Actions: Area Directors monitor suspension rates quarterly and discuss school data with principals. Area Directors notify their respective Area Superintendent regarding high suspension rates at individual school sites.

7.2 The District will summarize on a school-by-school basis the proportion of disciplinary actions that comply with the Discipline Matrix prescription, as well as, external, multiple external, and internal suspension rates, and the proportion of alternative placements.

Finding: 80.3% Total Matrix Compliance for first incident actions. See Appendix J for school by school data. The data addressing 7.2 reveals the following:

- A meaningful monitoring system has been developed to identify compliance to the district discipline matrix.
- The Discipline Management System is driving compliance to a degree that we were not reaching prior to its' creation and implementation.
- The discipline matrix needs an effective review to ensure that it meets the needs of current school requirements as well as school culture realities (which will continue to diminish reporting disconnects).
- Required degrees of flexibility may account for some existing irregularities in alignment (such as schools that do not offer Saturday School as a consequence for a code of conduct violation – as it may be called for in the district discipline matrix).

Accounting for the vagaries suggested above, we are better positioned than ever before to identify, analyze, evaluate and address these existing irregularities. Once we have institutionalized the recording and reporting processes, that Area Offices should be provided with the data in order to address their schools within their sphere of responsibility.

7.3 The school uses the Discipline Matrix to determine internal and external suspension.

Finding: 80.3% total matrix compliance for first incident actions. The Discipline Management System is driving compliance to a degree that we were not reaching prior to its creation and implementation. We are better positioned than ever before to identify, analyze, evaluate and address the existing irregularities between expected compliance and actual compliance. Once we have institutionalized the recording and reporting processes, Area Offices should be provided with the data in order to address their schools within their sphere of responsibility.

7.4 The school uses alternatives to external suspension as viable disciplinary option.

Status: Met

Finding: 100% of all schools meet the indicator of at least one disciplinary option as an alternative to external suspension. Categories include: detention, Saturday School, internal suspension, and other such as Alternatives to External Suspension (AES). Also, during the 2008-09 school year there were not any schools that did not offer internal suspension, that registered a high number of external. See Appendix K for school by school data.

Currently, Area Offices conduct comprehensive analyses of internal, external, and alternative to external suspensions in order to monitor the future effectiveness of the Districtwide Discipline Management System with regard to equity of disciplinary actions.

7.5 The school has implemented a process to communicate and reinforce behavioral expectations.

Status: Met

Finding: All schools have implemented a process to reinforce behavioral expectations. For example, the Disciplinary Centers have a level, behavioral management system to monitor and assess improved or replacement behaviors.

In the 2008-09 school year, a new component of Virtual Counselor was added to identify students with specific 'Risk Factors.' School psychologists, social workers, and guidance counselors are now able to design a set of actions and/or interventions to address specific students' needs.

7.6 The school communicates with parents as a disciplinary intervention to resolve student behavioral problems.

Finding: 72.4% of all students surveyed, 79.2% of all parents surveyed, and 88.0% of all teachers surveyed agreed with the statement, “My/My child's/This school contacts parents when behavior problems occur.”

7.7 The school provides access to alternative resources that promote positive student behavioral changes (e.g., Project B.L.A.S.T. Family Counseling Program).

Status: Met

Finding:

- All schools have access to AES programs with 24 different programs serving the entire District.
- The District provides transportation for all students who accept assignment to an AES program.
- Among other programs and services, schools can offer peer-counseling, family counseling, Project Building Lasting Attitudes and Strategies for Tomorrow (B.L.A.S.T.), Broward Alliance for Student Success (BASS), conflict mediation, and Why Try. In addition, all high schools offer BRACE program to all juniors and seniors. The Junior Experience and the College Fair is available to all high schools.
- Each school has an annual guidance plan that details individual programs that are designed for positive changes behaviorally and academically. Anti-bullying programs are offered in all elementary schools but commercial programs may be different from school-to-school. The Guidance Leadership Team conducted skill-building groups with all first-time retained third, eight, and tenth graders.

8.4 School meets minimum standards for school facilities as specified in the CCC Agreement. Standard One: All space standards are based on the Board-approved facility list standards in the current State Plan Survey. Standard Two: All new construction, expansion and remodeling will be based on the District's generic educational specification available on line at: www.browardschools.com Departments, Facilities and Construction. Standard Three: All permanent construction will meet the Florida Building Code.

Finding: The three standards are met.

8.5 The Five-Year Capital Plan contains a listing of ADA facilities compliance projects. The District ensures that facilities meet the requirements of the Americans with Disabilities Act (ADA).

Status: Met

Findings/Actions: The Deputy Superintendent, Facilities & Construction Management, provided a 140-page status update to the Diversity Committee in June 2008. That report detailed the District's status concerning the Five-Year Capital Plan, including ADA compliance projects. According to federal ADA regulations, facilities constructed for initial occupancy after January 26, 1993 must abide by all ADA Accessibility Guidelines. All facilities constructed by the District since enactment of ADA Accessibility Guidelines are compliant. For buildings constructed prior to 1993, the District completes remedial work to ensure students have access to all facilities. In prior years, the percent of District facilities that fully comply with ADA guidelines, including facilities constructed before January 1993, was the metric for reporting compliance with this indicator. Since the release of the Deputy Superintendent's status report, the reported metric for this indicator was revised to align with the status report and the spirit of the law. As such, all schools are in compliance with ADA regulations

District Wide Facilities ADA Survey – In July 2008, the Facilities and Construction Management Department (FCM) initiated the new district wide Facilities ADA Survey, but due to budget constraints only 60 of the 227 schools in the District have been surveyed. The data collected is currently being analyzed to produce a report that will be completed for the August 2009 Diversity Committee Meeting. The FCM has requested 2.8 million dollars to Capital Budget, for the next fiscal year (2009-10), to complete the survey of the remaining 167 facilities. As it was reported in last year's CCC Settlement Agreement Status Report, this survey will allow the District to determine accurately which facilities, including "existing and new", are fully compliant.

- Capital (New & Existing) ADA Projects – The Facilities and Construction Management Department requested \$6.37 million to cover the budget shortfall, due to increases in construction costs, of the ADA projects listed in the Adopted District Educational Facility Program (ADEFP) that will be ready for construction in fiscal year 2009-10. An additional \$3.73 million was requested to fund the construction of

new ADA accommodation projects that are currently being designed and the \$2.8 million to complete the district-wide ADA Facilities Survey. These funding requests, \$12.9 million total, along with the money already allocated in the ADEFP for ADA projects, are being evaluated by the Board before the final adoption of the Five Year Plan. Nineteen Percent (19%) of the ADA projects reported last year as being expedited through the Safe and Healthy Schools Program have been completed; twelve (12%) percent are under construction and twenty five (25%) are ready to start construction. Thirty Five (35%) percent of the remaining projects are being designed and their construction documents are at various stages of completion; five (5%) percent are in planning and two (2%) percent have been cancelled; due to the remodeling and/or demolition of the buildings where the project was scheduled to be constructed. Additionally, two (2%) percent of the projects are on hold waiting for the result of master planning and/or a Castaldi Analysis to determine if the projects are still valid.

- This fiscal year, a total of 40 ADA projects listed in the Adopted District Educational Facilities Plan were completed. See Appendix L.
- ADA Accommodations (Emergency Projects) – In addition to the on-going construction program and the annual capital budget appropriations for the removal of architectural barriers to achieve program accessibility, the District provides a myriad of ADA accommodations to qualified individuals with disabilities. Both structural (installing ramps, widening a doorways, retrofitting toilet rooms, etc.) and nonstructural methods (reassignment of programs and activities to accessible locations, purchase, redesign or relocation of equipment, and assignment of aides) are constantly being implemented to offer people with disabilities, programs or activities in the most integrated setting appropriate. The Exceptional Students Education (ESE), Equal Educational Opportunities (EEO), Facilities & Construction Management and Physical & Plan Operations (PPO) Departments, work as a team, to provide these accommodations.
- This year a total of ninety-one (91) ADA accommodation requests are being processed by the Facilities and Construction Management Department. Eight percent (8%) of the projects have been completed, twenty percent (20%) are under construction and an additional twenty percent (20%) are being scheduled for construction. Twenty-one percent (21%) of the remaining projects are being designed, fourteen percent (14%) are being validated, thirteen percent (13%) are being initiated and four percent (4%) were cancelled because the projects were determined not to be valid ADA projects.

The SCHOOL BOARD shall utilize for student assignment purposes, the Diversity Committee's recommended and Board-approved definition of diversity that included multiple criteria and a narrowly tailored policy that uses a combination of said criteria and never uses any one factor alone. 5.1 The athletic facilities at the high school meet the District standards (access to baseball field, softball field, track, gymnasium, tennis courts) and are in satisfactory condition.

Capital Plan Athletic Projects

Blanche Ely - \$8,000,000 – New regional stadium to include expansion of polyurethane track to eight lanes, new drainage system, renovation of press box, two concession stands and bathroom facilities, 5,000 seat capacity bleachers and new baseball stadium, project is out to bid and on-going.

Boyd Anderson - \$100,448 – Renovate entire football field, install new Bermuda turf – 2010-2011

Coconut Creek - \$4,252,000 – Under construction new regional stadium seating 4,000, includes expansion of track to eight-lane polyurethane surface, new drainage system, renovation of press box, and one concession stand/bathroom facility.

Cooper City - \$5,000,000 – Funding for new pool complex. Prototype is under construction at Nova High School. Next swimming pool project to follow is Northeast and then Cooper City.

Deerfield Beach - \$4,252,000 – Under construction new regional stadium seating 4,000, includes expansion of track to eight-lane polyurethane surface, new drainage system, renovation of press box, and one concession stand/bathroom facility.

Everglades - \$1,500,000 – Re-grade the football field and provide adequate drainage system. Field turns to muck on the north side of field after extensive rain – 2012-13.
- \$350,000 School Board's contribution to partnership with City of Miramar to install lighting and facility improvements for baseball and softball field. City of Miramar's Commission appropriated matching funds of \$350,000 at May 20, 2009, Commission meeting, 2008-2009.

Fort Lauderdale - \$8,000,000 – New pool, tennis courts and parking garage-pool complex will be located across street from campus. Prototype swimming pool complexes at Nova High and Northeast High.

Hollywood Hills – Component of phased replacement of school includes 4,000-seat regional athletic stadium with baseball and softball fields and tennis courts.

Miramar - \$2,000,000 – Renovate track and press box. On hold.

Monarch - \$401,000 – Construct concrete dugouts at baseball and softball fields. Replacement of field to Bermuda turf and construct storage facility, 2011-2012.

Northeast - \$5,000,000 – Construction of new pool complex facility will begin in 2009-10 school year. Prototype is Nova High School. Northeast High pool has been closed; contractor selected and work to begin shortly.

Nova - \$1,500,000 – On hold to upgrade stadium with concession and bathroom facility, previously budgeted. \$5,000,000 – new swimming pool complex presently under construction, replacing existing pool.

Pompano Beach - \$4,600,448 – New regional athletic stadium including new drainage system, polyurethane eight lane track, concession stand/bathroom facility. Stadium renovations will not commence until completion of Blanche Ely Stadium. Blanche Ely will play games at Pompano Beach during period Tiger Stadium is under construction.

South Broward - \$10,328,006 – Project is in design, 100% design submittals due in last May. Regional athletic facility to include replacement of swimming pool complex, expansion of existing track to eight lanes polyurethane track, renovation of existing baseball/softball fields including dugouts and bleachers. Addition of lights to illuminate softball field. Construct/renovate existing concession stand including restrooms, storage and press box. Construct additional drainage throughout athletic field where required.

Stranahan – Replacement of school includes regional athletic facility.

JP Taravella - \$320,721 – Start up funds for regional stadium committee.

General - \$3,666,000 – Concession and bathroom facilities for three high schools that lack such facilities, Flanagan High, Hallandale High and Everglades High. Schools currently use portable bathrooms at their stadium complexes, (2009-2012).
